

...Commends Ganduje, Oloyede For Being His Mentors



Prof. Mukhtar Atiku Kurawa, Rector, Kano State Polytechnic.

rof. Mukhtar Atiku Kurawa is a fine gentleman, an academic par excellence and a renowned Professor of Inorganic Chemistry from the prestigious University of Bristol, United Kingdom.

The soft-spoken academic was elevated to the rank of a professor in 2015 and was appointed Rector, Kano State Polytechnic, in 2016. Before his appointment, he was Dean, Faculty of Sciences, Bayero University, Kano.

Prof. Mukhtar Atiku Kurawa has conducted various research projects and published

widely in both national and international journals.. He is also a member of various professional bodies (both at home and abroad).

Furthermore, he has served in several committees and Boards at both state and national levels.

He is a member of the 10th Governing Board of the Joint Admissions and Matriculation Board (JAMB). He is also on the Board of the National Board for Technical Education (NBTE) and was briefly on the Board of Raw Materials and Research Development Council (RMRDC).

TESTS"...Test-blind (as opposed to test-optional) admissions is on the rise. By Scott Jaschik September 14, 2020 Culled from "Inside Higher Ed"

he cliche "Change is the only permanent thing in the world" has come into its own as Testblind is fast becoming the new norm of admitting candidates to tertiary institutions globally rather than the traditional test scores currently being employed by almost all testing agencies including the Joint Admissions and Matriculation Board.

An article titled "Admissions Without Tests" culled from INSIDE HIGHER **ED** features all you need to know

regarding this new initiative. When Loyola University New Orleans announced in May that it was going test blind in admissions, only two other colleges had that status: Hampshire College went test blind in 2014, and Northern Illinois University changed its policy earlier this

Today, there are 59 colleges that are test blind -- meaning that they do not look at SAT and ACT scores even if students submit them. Obviously there are far more colleges that are test optional.

Most colleges are in fact test optional, although many only have adopted that policy for one or two years.

Loyola's announcement was noteworthy because the university has attracted students with good (but not exceptional) test scores. The most recent class profile of the university lists an SAT average of 1367 and an ACT average of 30.

When Loyola announced its policy -early in the pandemic -- a statement by Nathan Ament, chief enrollment officer, cited the difficulty some students faced

in taking the SAT or ACT: "The spring and summer after a student's junior year are typically when students prepare for and complete standardized testing. Currently, the SAT and the ACT test dates offered in the late spring and throughout the summer have been cancelled. By removing the testing requirement, we hope to reduce some of the stress that might be caused by the college application process."

The colleges that have followed Loyola include some of the most competitive in admissions: the California Institute of Technology and the University of California, Berkeley. In fact while the University of California's Berkeley, Irvine and Santa Cruz campuses went test blind, a state judge barred all of the others from considering SAT and ACT scores because of concerns over whether students with disabilities would be able to get the accommodations they need.

Liberal arts colleges have also joined the movement. Reed College will go test blind for two years and Dickinson College for one year.

The SAT/ACT situation has arguably gotten worse -- not better -- since May. Both tests are now being given, but registering for the test is difficult for many. And students have complained of last-minute cancellations at some test centers

Kevin Myers, a spokesman for Reed, which used to require the tests, said going test blind seemed to be "the most equitable decision. If we really wanted to level the playing field, it seemed like the way to go." (Reed continues to "strongly encourage" either the Test of English as a Foreign Language -- TOEFL -or the International English Language Testing Service assessment -- IELTS -- for students who went to school speaking a language other than English.)

Berkeley's policy states, "Berkeley has always used, and will continue to use. holistic review, which means there is no one sole factor on the application that will determine a student's admission status. SAT/ACT test scores were not the only academic indicators available on the application to assess students. Other academic indicators will continue to be assessed in the review process, including grades, the rigor of a student's courses, other non-required tests (SAT subject test, AP tests, IB test, etc.), and a student's individual academic context." Dickinson was the last college to go test blind. Margee M. Ensign, the president, sent a note to students, faculty and alumni this month explaining the decision. "We have heard from countless students, parents and college counselors in the past several months about the anxiety students are feeling because the COVID-19 virus has disrupted access to standardized tests, such as SATs and ACTs. Testing availability has decreased dramatically both nationally and internationally, disproportionately impacting already marginalized students. In addition, there are potential health risks with taking the tests. For all of these health, equity and fairness reasons, we have made this decision. By declaring that we are test blind, the admissions committee will not factor testing scores into a decision about enrollment, even if scores are submitted."

Catherine McDonald Davenport, the vice president for enrollment management and dean of admissions, said Dickinson has been test optional since 1994, so admissions representatives know how to evaluate applicants who don't submit scores.

She said moving to test blind for a year "made logical sense" given the pandemic. She said the proposal was developed in enrollment management and was approved by the college's senior leadership and faculty committees in a week.

"The most important factor was student health," she said. Everything at the college has been focused on student health, she said. While 80 percent of students typically submit test scores in a normal year, she wondered if remaining test optional would really be fair during the pandemic.

"When students and families hear 'optional,' a lot of them transfer the word to 'required,'" Davenport said.

She also said that "testing was out of control" even before the pandemic, with families feeling pressure to produce the best scores possible.

"The pandemic has caused us to pause, and I really hope higher ed will look at the craziness," she said.

Davenport said she's aware of the reasons some colleges are sticking to testing. Some fear an impact on rankings (but U.S. News & World Report confirms that test-blind colleges won't be punished next year). And there are questions about high schools and grading. Some are shifting to pass/fail with students at home; others are sticking with traditional grading.

But to Davenport, the reality is that "we are able to spend more time on each application file" and deal with any issues.

The data from Dickinson show, as data at other colleges have shown, that minority and international students are more likely to apply without test scores. Last year, 76 percent of applicants who identified as white submitted SAT or ACT scores. Only 69 percent of nonwhite students did so.

Davenport said she didn't know what the college would decide in a year. She said that the college has regularly analyzed its test-optional policy and has found only positive impacts. She said the same approach would be taken with test blind.

... "My Desire Is To Make KSP Top-Ranking Polytechnic In The World"-Prof. Kurawa



The multiple-award winner in this interview with *JAMBulletin* bares his mind on his elevation to the Rectorship position, the passion of the Kano State Governor, Alh. Abdullahi Umar Ganduje, for education and KSP, his vision and the mentoring provided by the current JAMB Registrar, Prof. Ishaq Oloyede, among other sundry issues.

Prof. Kurawa told *JAMBulletin* that he was given the mandate to turn around the fortunes of the ailing polytechnic which was on the verge of collapse when he was appointed and he did that swiftly, hence the success stories that are being celebrated today.

The hard-working Rector said, "It is a fact that since my assumption as the Rector of Kano State Polytechnic, the institution has recorded tremendous achievements ranging from the peaceful co-existence between management, staff and students; digitisation of all the operational processes in the institution; accreditation of 57 programmes by NBTE and NCCE; mounting of 15 new programmes; stabilisation of the institution's academic calendar; timely payment of staff allowances; prompt release of students' results; conduct of several colourful convocation ceremonies; NBTE ranking as the 5th State Polytechnic in the country to the establishment of a Microfinance Bank to mention but a few. The magic employed to achieve all these is quite simple - honesty, dedication, team work, unhindered access to the Visitor of the institution, i.e. His Excellency, Dr. Abdullahi Umar Ganduje (OFR), the Executive Governor of Kano State, coupled with impactful guidance from my mentor, Prof. Is-haq O. Oloyede. These, according to him, are among the strategies he employed to record these achievements within record time.

Continuing, he said: "The inclusive leadership style I adopted has also greatly contributed to the success achieved. In addition, at KSP, we make it a tradition to work as a team in conjunction with the Governing Council, the Management team and the Polytechnic Academic Board. Moreover. I work harmoniously with the academic and nonacademic staff unions of the institution as well as the host community. We try to, as much as possible, keep all stakeholders abreast of what we do, most importantly the State Government.

"I have to put on record that the support I got from my Management team and the staff was an integral part of the success story, to sum it all, Allah the Almighty, has been our guide and facilitator of the successes recorded coupled with our unwavering commitment to keeping the rules of the job."

Commenting on the resuscitation of programmes that had atrophied before coming on board as the Rector, Prof. Kurawa said, "The quest to breathe life back to the academic programmes that had lost accreditation, the need to train the youth to be self-reliant and guaranteeing the credibility of the institution's certificate are the motivating factors behind my ceaseless appeals to the stakeholders to garner support for the prompt accreditation of all the 66 programmes run by

the Kano State Polytechnic.

"I had sought audience with the Visitor and reported the ugly situation to him. The State Governor instructed a 100% release of funds that were budgeted for the exercise for us to tackle the situation head-on. All categories of staff of the institution (including the unions) were invited to join hands with the Management team to address this Herculean task once and for all and this resulted in getting all the programmes fully accredited by the NBTE for ND and HND programmes) and NCCE for NCE Technical programmes. The State Governor has been very supportive of us. I keep saying it wherever I go that I have never gone to the Governor with a request that pertains to the Polytechnic and he says no."

Prof. Kurawa was passionate about taking the institution to her zenith and he affirmed once again that his dream for Kano State Polytechnic is simple. He said, "I wish for the institution to be among the top-ranking Polytechnics in the country where youths and artisans will be adequately trained to become job creators rather than job seekers. I wish the institution to be internationally recognised in terms of the number and quality of the programmes it offers.My vision is to offer an excellent leadership that would make the Polytechnic lead in the areas of teaching, learning, research, technological and scientific innovations in Nigeria, geared towards training skilled manpower that could compete with her peers globally."

Commenting on the experience garnered as a member of three Governing Boards, JAMB, NBTE and RMRDC, the don said, "The experience has been extremely educative and very rewarding. Although, I served concurrently on three Boards at one time but at present, I am a member of the Governing Boards of JAMB and NBTE only. Serving on these Boards, which all

DAILY POST.NG MONDAY, SEPTEMBER 14, 2020 — Teachers Registration Council Goes After Unqualified Staff in Nigerian Schools: The Teachers Registration Council of Nigeria (TRCN) is going after unqualified teachers in public and private schools nationwide. The Registrar, Prof. Josiah Ajiboye, who made this announcement said the Council would swing into action once schools fully reopen. He said despite the grace period given to unqualified teachers, there were still records of many unqualified teachers.

The Registrar said of the four million in various institutions in Nigeria, just over two million were registered with the council. Ajiboye warned affected teachers to register with TRCN or risk being laid off. He stated that the council has the power to remove and prosecute those unqualified.

DAILY TRUST TUESDAY, SEPTEMBER 15, 2020 - COVID-19: 3 Kano Schools Win Cash Support for NABTEB Students: The development Research and Projects Centre (RPC), with support from Open Society Foundation, has begun the disbursement of funds to schools that have successfully qualified to access cash support under the centre's direct school support for activities/ project aimed at improving National Business and Technical Examination Board (NABTEB) outcomes. Speaking during the presentation of the first instalment of N100,000 to each awarded school, head of the RPC team, Alhaji Abdulhamid Inuwa, revealed that the award was aimed at supporting after school hours coaching; purchase of past question papers and/or textbooks; purchase of COVID-19 protection materials such as hand sanitisers; tables and chairs for effective observation of COVID-19 protocol, as well as improve students' transition to the world of skill-work in order to mitigate the negative impact of the global pandemic.

GUARDIAN TUESDAY, SEPTEMBER 15, 2020 —Engineers Seek Policy to Boost Women Participation in STEM Education: Engineers have called for a deliberate policy that will boost the participation of women and girl-child in Science, Technology, Engineering, and Mathematics (STEM). Leading the call, the Managing Director/Chief Executive, Nigerian Printing and Minting Company, Mr Abbas Umar Masanawa, said such policy would halt gender stereotyping that

discourages girls to study STEM subjects. For him, the state, local governments and women in STEM could engage the school boards and ministries of education so as to incorporate education policies that actively encourage girls to study STEM subjects. This could be achieved by launching state and local government campaigns that showcase strong female role models, leadership and expertise, especially within STEM professions.

THISDAY WEDNESDAY, SEPTEMBER 16, 2020 —Digital Technology: Equip Adult Literacy Centres, Govt Told: Dr Blessing Anyikwa, a senior lecturer in the Department of Adult Literacy Education, University of Lagos (UNILAG), has called on the government to invest more in, and equip adult and youth literacy centres with the infrastructure and technologies needed to adapt to a digital environment. She said efforts must also be made towards providing facilitators and learners with the skills to function well

towards providing facilitators and learners with the skills to function well. She pointed out that the COVID-19 crisis has been a wake-up call for stakeholders of adult and youth literacy education and has shown what can be done with technology. It is her belief that the government should do all that is required to ensure that the gains already made in adult literacy in Lagos State are sustained during the subsisting COVID-19 crisis.

THISDAY WEDNESDAY, SEPTEMBER 16, 2020 -Soludo Endows Funds in UNIZIK, Ojukwu Varsity for Best Economics Graduates: Former Governor of the Central Bank of Nigeria (CBN), Prof. Chukwuma Soludo has endowed funds for the best graduating students in the Departments of Economics, Nnamdi Azikiwe University, Awka and Chukwuemeka Odumegwu Ojukwu University, Igbariam, Anambra State. The Leader of the group, Mr Jude Emecheta, who presented a cheque of N1 million to the Vice-Chancellors of the two universities, said the best graduating students from the two universities will get N100,000 for the next five years.

THISDAY WEDNESDAY, SEPTEMBER 16, 2020 — Nigerian Law School Calls 1,785 Graduates to Bar: A total of 1,785 successful graduates of the Nigerian Law School have been called to the Nigerian Bar. They emerged successful at the January Bar Examination, just as a total of

736 were said to have failed the examinations. Giving a breakdown of the result at the Call to Bar ceremony held at the Eagle Square, Abuja, the Director-General, Nigerian Law School, Prof. Isa Hayatu (SAN), stated that the candidates successfully completed the vocational training at the Nigerian Law School as prescribed by the Legal Education Act and had also taken the prescribed examinations and the dining terms and met all other required conditions set by the Council of Legal Education.

DELISTING OF 22 FRAUDULENT CENTRES: ACTU COMMENDS JAMB

he Anti-corruption and Transparency Unit (ACTU), JAMB Chapter, has expressed dismay at the report of some CBT centres, twentytwo of them to be precise, that had engaged in dubious practices to defraud hapless candidates.

ACTU commends the Board for its diligent investigation which led to the discovery of the antics of these fraudulent CBT centres which had extorted 11,823 candidates to the tune of N59 million because they were charging them amounts ranging from erring centres pending the final approval N3,000 to N6,000 as opposed to the N200 stipulated by the Board.

It would be recalled that JAMB, in response to the raging COVID-19 Pandemic and the attendant restrictions. had entrusted these centres with the task of processing candidates' data employing certain protocols aimed at controlling crowds at service points nationwide.

By way of punishment, the Board had taken the wise step of suspending these

of the Governing Board of their eventual delisting and prosecution. To avoid future occurrence, ACTU advises candidates to always go through legitimate channels (JAMB Offices nationwide) to avail themselves of whatever services they would like to access. This advice is not only necessary but also timely as it would also preclude them from becoming accomplices to unwholesome deeds.
