The Joint Admissions and Matriculation Board(JAMB) would take legal action against any group of people, organisation or individual caught using its logo without authorisation.

The Board's logo, which is a combination of text and visual imagery, serves two purposes. First, it informs people about

Therefore, all candidates, who desire to undertake Part-time, Sandwich, National Open University of Nigeria (NOUN) students, and other related programmes as required by law to be registered by the Board must do so by first typing "NIN" then the NIN itself, for instance, (NIN xxxxxxxxxxx) and send to 55019 or

HOW TO CHECK 2024 UTME RESULT

The Board, once again, wishes to state clearly that the only way to check the 2024 UTME result is to send UTMERESULT to 55019 or 66019 using the same phone used by the candidate in registering for the UTME exercise.

This is different from what obtained last year, hence, the results, at the moment, are not and cannot be found on the Board's website.

Candidates are urged to follow the method specified above to obtain their results. They need not visit any cybercafe

or patronise any third-party entity to check their result.

The public is also advised to be wary of any candidate parading printed result slip as currently, the result is not on any paper format as being circulated on social media by some individuals.

A reasonable number of candidates have checked their results as seen on our monitoring dashboard but for the few still struggling, please follow the right channel.

PROF. OLOYEDE NOT A TITLED HOLDER

he Registrar of the Joint Admissions and Matriculation

Board (JAMB), Prof. Is-haq Oloyede, is not a title holder of any Emirate Council in Nigeria.

Recently, the media, particularly the social media has been awash with reports of Prof. Oloyede being conferred with the chieftaincy title of Danburam Sokoto with many people sending him congratulatory messages. This is fake news as Prof. Oloyede only attended a public function, where he merely represented His Eminence the Sultan of Sokoto, Alh. CHANNELS FOR ACCEPTANCE OF JAMB INTRODUCES A DIMISSIO



ollowing the series of abuses associated with the process of accepting admission by candidates through which unscrupulous elements exploit hapless candidates, the Joint Admissions and Matriculation Board (JAMB) has introduced a new channel for accessing this service.

Board observed with dismay that some institutions have formed the habit of accepting or rejecting admission offers on behalf of candidates so as to create vacancies for less-qualified but favoured candidates while cybercafes and some centres engage in the practice to blackmail or extort money from the candidates.

The Board views this odious practice as criminal and a aross misconduct and has, therefore, put measures in place to forestall this unethical behaviour.

Consequently, the new method for accessing results is for a candidate to either send "ACCEPT" or "REJECT" on his dedicated phone line to 55019 or 66019.

A candidate can also access his admission through the use of fingerprint at any accredited CBT centre or JAMB office nationwide. The newly-crafted method is to protect candidates' personal information as well as uphold the sanctity of the admission process.

It would be recalled that the Board had hitherto accepted login to the candidate's profile by accredited CBT centres on the Central Admissions Processing System(CAPS).

In announcing this change of policy, the

PUNCH, MONDAY, APRIL 29, 2024: 2024 UTME: Why We Won't Announce Names of 2024 Top Scorers- JAMB: -The Reaistrar of the Joint Admissions and Matriculation Board (JAMB), Prof. Is-hag Oloyede has disclosed why the examination body would not announce the names of the highestscoring candidates in the justconcluded 2024 Unified Tertiary Matriculation Examination (UTME). According to the Registrar, the decision is based on several reasons, including the avoidance of a repeat of the "Mmesoma saga" and the consideration of UTME as only a ranking examination.

Speaking at a press briefing in Bwari, Abuja, Prof. Oloyede explained that the Board has consistently maintained that its UTME is solely a ranking examination and that other parameters are considered in determining the minimum admissible score for candidates seeking admission to tertiary institutions. He added that the various variables adopted by institutions make it challenging to arrive at a single set of parameters for generating a list of candidates with the highest admissible score.

Prof. Oloyede emphasized that gaining admission is the ultimate goal, and it might be unrealistic to declare a particular candidate the highest scorer, as he or she may not even be admitted in the end. However, in response to public demand and to prevent a repeat of the Mmesoma saga, the Board is urging those who wish to award prizes to high-performing candidates to verify claims before offering such awards.

VANGUARD, MONDAY, APRIL 29, 2024: <u>WASSCE to Start April 30, 2024:</u> - The West African Examinations Council (WAEC) has announced that the 2024 West African Senior School Certificate Examination (WASSCE) for school candidates will commence on Tuesday, April 30, and conclude on Monday, June 24. The examination will be conducted in four WAEC member countries: Nigeria, Gambia, Sierra Leone, and Liberia.

According to Dr Amos Dangut, Head of the Nigeria Office, "I am delighted to inform you that WASSCE for school candidates, 2024 will take place between Tuesday, April 30, and Monday, June 24, 2024, in Nigeria, spanning seven weeks and six days."

A total of 1,814,344 candidates from 22,229 schools have registered for the examination, which will feature 76 subjects made up of 197 papers. Additionally, about 30,000 practising senior secondary school teachers, nominated by various Ministries of Education, will supervise the examination. Also in Punch, Tuesday, April 30, 2024.

CHANNELS TV, MONDAY, APRIL 29, 2024: <u>JAMB Releases 2024 UTME</u> <u>Results, 8, 401 Score 300 and Above:</u> -The Joint Admissions and Matriculation Board (JAMB) has officially released the 2024 Unified Tertiary Matriculation Examination (UTME) results. This announcement was made by JAMB's Registrar, Prof. Is-haq Oloyede, during a press conference held at the Board's Headquarters in Bwari, Abuja.

According to Prof. Oloyede, over 1.94 million candidates registered and sat

for the examination, which took place in 118 towns and over 700 centres across the country from April 19 to 29. Out of the 1,989,668 registered candidates, 80,810 were absent, while 1,904,189 sat the UTME within six days of the examination.

The results show that 0.4% of candidates scored above 300, while 24% scored 50% (200/400) and above. Meanwhile, 1,140,249 candidates, representing 76% of the total, scored below 200.

In line with its previous stance, JAMB has reiterated its decision not to publish the name of the highestscoring candidate. As stated by Prof. Oloyede, "The Board considers its UTME as only a ranking examination, and other parameters will constitute the minimum admissible score for candidates seeking admission to tertiary institutions."

Unified Tertiary Matriculation Examination (UTME).

Prof. Okebukola praised Oloyede's technical and administrative expertise in seamlessly conducting the UTME for 1.9 million candidates, releasing the results promptly, and bringing respectability, transparency, and credibility to the examination process.

In a statement, Prof. Okebukola noted, "The successful administration of the UTME to 1.9 million candidates, with results released shortly after the examination, demonstrates JAMB's capacity under Oloyede's leadership to conduct public examinations with excellence." He added, "This feat is remarkable, considering that the number of candidates exceeds the entire population of some African countries, including Guinea-Bisau, Equatorial Guinea, Mauritius, Eswatini, and Djibouti."

Prof. Okebukola's commendation highlights the transparency and credibility of the UTME under Oloyede's leadership, and it is hoped that JAMB will continue to maintain this level of excellence in conducting public examinations in Nigeria.

DAILY POST, WEDNESDAY, MAY 1, 2024: <u>NCC, JAMB in Talk Over Special</u> <u>SIM Card for Students:</u> - The Nigerian Communications Commission (NCC) and the Joint Admissions and Matriculation Board (JAMB) are in discussions to provide specialized SIM cards for students with limited services. According to JAMB Registrar, Professor Is-haq Oloyede, these SIM cards have become essential for executing sensitive operations, particularly in the admission process.

Speaking to the media in Lagos on Monday, Professor Oloyede announced a new procedure for admission acceptance, which includes Sending "ACCEPT" or "REJECT" via a dedicated telephone line to (55019/66019) or personally endorsing or declining admission offers (including programme changes) using a fingerprint at an authorized CBT centre or JAMB office These new methods aim to protect candidates' information and maintain the integrity of the admission process. With the introduction of this system, the importance of registered telephone numbers (SIM cards) has increased, as they are now crucial for conducting sensitive operations. JAMB is currently negotiating with the NCC to establish dedicated SIM cards for students with restricted functionalities.

This development comes as JAMB released the 2024 UTME results, which showed that 77% of the 1,842,464 candidates scored below 200.

PUNCH, WEDNESDAY, MAY 1, 2024: Mass UTME Failure Should Provoke Govt. Action: The recently concluded 2024 UTME results have raised alarm bells, highlighting the urgent need for action to address the crisis in the education industry. FEEDNEWS.COM, WEDNESDAY, MAY 1, 2024: JAMB Results: There is No Pass and There is No Fail- Prof. Oloyede on Examination Terminology: - In a recent interview on Arise Television, Prof. Ishaq Oloyede, the Registrar of JAMB, clarified that the terms "pass" and "fail" are not applicable in examination terminology. This comes after the release of the UTME results, which showed that only 0.4% of candidates scored above 300, while 24% scored 50% (200/400) and above. Contrary to popular belief, Prof. Oloyede emphasized that scoring below 200 does not necessarily mean a candidate has "failed".

"When you talk about pass or fail, we don't have such terminologies in ranking examinations. There is no pass, and there is no fail," he stated.

Prof. Oloyede also rated this year's examination as the best in the last ten years, saying, "Indeed, the result this year is the best, at least in the last three years, but I will say the best in the last ten years."

Regarding educational assessment, he highlighted the importance of understanding the purpose of the examination, stating, "Assessment is a serious business. When we are talking about educational assessment, the purpose of the examination determines the format of the results."

He also addressed concerns about the results, saying, "People are talking about the results this year being bad; if anything is bad, not today, this may have been bad before."

PUNCH, WEDNESDAY, MAY 1, 2024: <u>UTME Results Not Available in Paper</u> <u>Format-JAMB:</u> The Joint Admissions and Matriculation Board (JAMB) has issued a warning to Nigerians to be cautious of individuals parading printed result slips, as the 2024 UTME results are currently not available in paper format. Additionally, the results are not accessible on the Board's website, unlike last year.

According to a statement released by JAMB's spokesperson, Dr Fabian Benjamin, some individuals have been circulating printed result slips on social media, prompting the need for clarification. The statement emphasized that the only legitimate way to check the 2024 UTME result is by sending "UTMERESULT" to 55019 or 66019 using the same phone number used during registration.

To obtain their results, candidates are advised to follow this specified method and avoid visiting cybercafes or patronizing third-party entities. The public is also warned to be wary of any candidate presenting printed result slips, as they are not authentic.

BUSINESS DAY, THURSDAY, MAY 2, 2024: <u>UTME: Dismal Result Reflection</u> <u>of Nigeria's Education System-</u> <u>Stakeholders:</u> -Stakeholders in the education sector have expressed concern over the poor performance of candidates in the 2024 Unified Tertiary Matriculation Examination (UTME), attributing it to the systemic issues plaguing Nigeria's education system. According to the Joint Admission and Matriculation Board (JAMB) Registrar, Prof. Is-haq Oloyede, a staggering 76% of the 1.8 million candidates who sat for the examination scored less than 200, with 1.4 million candidates falling short of the mark.

Education stakeholders have described this outcome as a stark reflection of the crisis in the country's education system, emphasizing the need for urgent and decisive national intervention. Legal practitioner Bamidele Okuwoga noted that the results were unsurprising, given the state of the education system. However, he highlighted the irony that even those who passed the JAMB threshold would struggle to secure admission into Nigeria's limited tertiary institutions.

Public affairs analyst Yinka Bolarinwa commended JAMB's efforts to modernize the UTME but criticized the subpar education quality provided to candidates before the examination. He emphasized the need for curriculum alignment, educational quality enhancement, and technology integration to improve examination outcomes and ensure fairness and inclusivity in the assessment process. Bolarinwa advocated for a collaborative approach among policymakers, educators, parents, and students to address the systemic challenges and create a conducive learning environment for academic success.

TRIBUNE, THURSDAY, MAY 2, 2024: <u>Why Universities are Dropping</u> <u>Agitation for Post-UTME- JAMB</u>: -The Joint Admissions and Matriculation Board (JAMB) has revealed that most Nigerian universities are no longer insisting on conducting post-Unified Tertiary Matriculation Examination (post-UTME) tests, owing to the significant improvements and enhanced credibility in the processes of test administration and candidate selection.

According to Dr. Fabian Benjamin, JAMB's Public Communication Advisor, technology has played a crucial role in this development. He credited the JAMB Registrar, Professor Is-haq Oloyede, with harnessing technology to transform the entire process, thereby curbing infractions. The introduction of the Central Admission Processing System (CAPS) in 2017 is a notable example of this, as it has streamlined the admission process and eliminated manual irregularities.

Dr. Benjamin emphasized that the registration process for UTME candidates is a critical foundation for the entire process, and JAMB has invested heavily in technology to prevent infractions from the outset. He also highlighted the Registrar's commitment to transparency, prudent financial management, and stakeholder engagement, which has opened up the processes to scrutiny and participation.

speech commended the Registrar for introducing the Central Admissions Processing System (CAPS) into the Board's admission process. CAPS is a platform that had enabled a seamless admission exercise. She disclosed that the collaboration between the institution and the Board's National Headquarters Annex, Ilorin, has gone along way towards enlightening the institution on the Board's admission guidelines.

Mr. Ganiyu Yahaya, Assistant Director, NHA, Ilorin, who represented the Registrar, emphasized the significance of the Central Admission Processing System (CAPS) during his speech. He stated that CAPS, as a candidateoriented policy in the admissions process for tertiary institutions in

Nigeria, is designed to focus on the needs, preferences, and strengths of candidates, while providing personalised support and individualised assessment. This approach aims to ensure fairness, transparency, and support for the candidates' aspirations and potential.

...All Process/Applications in JAMB Now to be Through Profiles Linked to the NIN of Candidate

66019 as done by the regular candidates, who register for the UTME. This is because the waiver given to these categories of candidates aspiring through such programmes has been withdrawn.

This measure is aimed at addressing all loopholes being used by fraudsters to compromise candidates' records using the unsecured registration channels allowed for these set of candidates. It is to be recalled that before now, Part-time, Sandwich, NOUN students and other candidates under such categories, had registered with the Board without going through the process of sending their NIN to 55019 or 66019 using their unique phone number to create a profile.

However, with the recent discovery by the Board through the confessions of arrested fraudsters as well as the review of the Board's processes, it became necessary to bring all transactions and updates under the same secured procedure. It is also necessary to disclose, at this juncture, that each process that the Board had exempted or liberalised for the comfort of candidates had ended up being abused.

Consequently, going forward, all candidates, even those ones, who had engaged our platform previously but had not integrated their NIN, Phone (SIM) as well as new entrants, would have to create a profile using their NIN and phone number to access any of the services of the Board and this would be tied to their personal records for life.

It is worthy of note that since 2021, the Board had integrated its platform with NIMC and had required all candidates aspiring to register for the UTME to send their NIN to either of its sort codes to be registered. The system then pulls their details (name,

Date of Birth, etc.) from the NIMC database with their phone number tied to this profile, thus, making their details unique to them. Also, all other candidates before 2021, who had approached the Board for certain services, were in the past, simply requested to create a profile but their NIN was not integrated using their phone numbers. Now, such candidates, if they require any further service from the Board, would have to follow the same procedure of sending their NIN to 55019 or 66019 using their phone number to be on the same data platform as those from 2021 upwards.

The Board will continue to devise new ways of strengthening its existing security features to ensure that it renders uncompromised services to candidates while protecting national data.

TARABA STATE OFFICE SENDS OFF RETIRING STAFF



(VERIFICATION OF A-LEVEL QUALIFICATIONS BY AWARDING INSTITUTIONS)

This advisory is issued to guide all A-level certificate awarding institutions on the procedures of verifying the certificates claimed by candidates during the 2024 DE registration exercise.

This is a follow-up to the earlier issued advisory referenced No. 2024ff01, dated 31st March, 2024 (copy attached) on the above subject. This edition is issued to reiterate the previously raised matters as well as to guide all A-level awarding institutions on the procedures to be followed to verify the certificates claimed by candidates during the 2024 DE registration exercise.

All concerned institutions should therefore take note and adhere strictly to the provisions herein:

- 1. As part of the requisite requirements for Direct Entry application, all applicants' qualifications must be uploaded at the registration point (JAMB Professional Registration Centre (PRC), while the Head of the awarding institutions gets notified immediately through email to verify the candidates' claims.
- 2. The Institutions are expected to log in to the JAMB website via this linkhttps://efacility.jamb.gov.ng/InstitutionSignin. Please, note that the link is also included in the mail sent to the Heads of Institutions once candidates' certificates are uploaded during registration. Institutions without efacility account should contact JAMB through the CAPS mail for details.
- 3. On Login, by the left pane menu list, click on Certificate Verification (DE Registration) menu to view the list of all untreated candidates' applications.
- 4. To treat each candidate's application, click on the **"Process Button"** beside the name of the candidate to pull the candidate's full information, including the uploaded certificate.
- 5. To confirm that a candidate's certificate is genuine, select the "**first radio button**" and click the blue "**Authenticate Certificate**" button. This verifies the certificate as genuine and also sends an email and SMS to the candidate (and reflects on the JAMB's profile of the candidate) confirming the authenticity of his/her certificate.
- 6. To confirm that the certificate is fake or rather not issued by the institution, select the "second radio button", while you specify the reason for disapproving the certificate and click on the "Disown Certificate" button. This disowns the certificate and also sends an email and SMS to the candidate (and reflects on the JAMB's profile of the candidate) informing him/her why his/her certificate was disowned by the institution.
- 7. As soon as either of steps (5) or (6) above is completed, the response will be automatically sent back to the database for update.
- 8. The procedure is a continuous process and all candidates must be treated individually.

Note: a. For further guidance, a manual is provided

b. The Board will NOT consider for admission any candidate whose qualification is not verified by the awarding institution.

This advisory is issued to guide stakeholders on the alignment of data for the 2024 DE registration and verification of candidates' data

1.0 PREAMBLE

The Board has been receiving series of complaints from institutions on candidates with forged or fake A-level certificates. Each institution has the policy of verifying the credentials of admitted candidates to ascertain their authenticity. One of such exercises was carried out by Bayero University, Kano, where the results of 148 admitted students were verified and 142 of them were found to be forged or faked. The Independent Corrupt Practices and other related Offences Commission (ICPC) in conjunction with the Federal Ministry of Education and JAMB subsequently carried out a sting operation at the A-level examination venues across the country. The result of which was extremely embarrassing to the Education sector. The then Chairman of ICPC said that much.


As a result of this, the Board had to, with the approval of the Federal Ministry of Education, act appropriately and establish the Nigeria Integrated Post-Secondary Education Data System (NIPEDS) which has the mandate to verify all A-level certificates used in the DE application before admission is considered.

2024 DE CANDIDATES VERIFICATION FLOW

Find below the flow of candidates' verification by NIPEDS: Every candidate presents his/her credentials for DE registration at any of the JAMB PRCs/State Offices.

a. Upon receiving the document, it is classified as follows:

. For IJMB, JUPEB, NABTEB or Cambridge (post-2018) certificate or awaiting result candidates of IJMB, JUPEB or NABTEB, the candidate data is compared to the databank on NIPEDS for such qualifications. The system checks with the candidate's number as supplied by the respective examination body. The system verifies alignment of name, qualification, subject and grades (where applicable). Once the alignment is confirmed, the candidate continues and completes his/her registration.

- For other qualifications other than "i" above, the credentials of the candidates ii. are transmitted to the respective institution to authenticate/verify the claim.
- If the institution is compliant (credibility of prompt response to verification iii. request in 2023), the candidate is allowed to complete his/her DE registration without waiting for verification of the result from the awarding institution. For the avoidance of doubt, the following 15 institutions are regarded as noncompliant for the on-going 2024 DE registration:

2.0 **EXPERIENCE/LESSONS FROM 2023 VERIFICATION EXERCISE**

The Board had on 23rd February 2023 issued an advisory to guide the registration of candidates seeking admission through Direct Entry (DE) in the 2023/2024 academic session. That was to address the issue of candidates who intended to use forged or fake A-level certificates/qualifications to secure admission.

For effective monitoring, DE registration from 2022/2023 academic session, has been restricted to JAMB-PRCs (offices).

For 2023 registration, of the 44,866 candidates who applied for the DE (or converted from UTME) 1,957 have so far been disclaimed by institutions/examination bodies.

The verification exercise by the Nigeria Post-Secondary Education Data System (NIPEDS) also revealed some discrepancies which could unduly disadvantage students/candidates or provide avenue for their impersonation. The discrepancies are:

The Board noted that by infusing its logo into their unsavoury claims, a toga of originality and genuiness is conferred on their unholy ventures, thereby deceiving unsuspecting members of the public.

The Board, therefore, warned that as ignorance is not an excuse in the eye of the law, perpetrators should be well-advised to desist from this ignoble act or face the unpalatable consequences of their actions.

Already, the Board has set up a monitoring team to identify these culpable individuals or schools towards handling them over to security agencies for prosecution.

1.0 PRE-DE REGISTRATION ALIGNMENT

Going by the experiences of the 2023 DE registration exercise, the Board has introduced, where necessary, the preregistration checks and data alignment for applicants with only **IJMB, JUPEB, and NABTEB qualifications**his provision enables the system to authenticate the details supplied by a prospective candidate at the point of registration with what has been preloaded by the examination bodies. A platform **THIRD-PARTY ALEVEL DATA ALIGNMENT PLATFORM (TALDAR)** "been provided to cater to this.

When a candidate's data (spelling of name, result/grade, subjects) do not align or are not included with the records supplied by the examination bodies, an alignment must be done on the TALDAP, before proceeding with the DE registration with JAMB.

It is worth noting that there are ONLY two (2) types of pregistration data alignment available on the TALDAP system:

- a. **Missing candidate's data alignment (data omissiαn)** his type of alignment can only be carried out when at the point of registration, the exam/matric/registration number supplied by the candidate and on the presented credential of the candidate for a particular qualification (IJMB/JUPEB/NABTEB) does neturn any candidate's data.

2.0 PROCESS OF APPLYING ALIGNMENTS FOR DATA OMISSION OR DATA DISCREPANCY

The processes are described below:

- i. Visit NIPEDS A/level Home PageOpen the web browser and go to nipeds.jamb.gov.ng
- **ii. Click on Alignment of Data Application** avigate to the alignment of data section on the homepage and click the "Visit Portal" button.

iii. Click on Apply for Alignment of Data button to begin the application process on the new page

- iv. Select the Type of Data AlignmentOn the page,
 - a. candidates should choose the appropriate alignment type (missing candidate data alignment or data discrepancy alignment). If data discrepancy alignment is selected, the candidate can then select "alignment of name spelling", "alignment of subjects" or "alignment of grades"
 - **b.** candidates should provide the examination number and year as shown on the claimed certificate/document;
 - **c.** candidates should provide a valid email address (preferably the one to be used or used for JAMB registration).
- v. **Provide the SupposedlyOmitted/Correct Data:** In the subsequent step on the page, the candidate should input the name, subject, and grade, exactly as shown on his/her certificate/document and upload the proof/credential.
- vi. **Make Payment:**The final step involves making a payment.
- vii. Application Completion Candidates will receive an email for payment made which serves as a confirmation of the "submitted application". An email notification will also be sent to the examination body informing them about the new application which they are to either recommend to AMB or Reject. Any of the actions will have justifications **A submitted application does not** *automatically mean approval.*

3.0 JAMB APPROVAL/REJECTION

Once the application is approved or rejected, the candidate gets an email confirming the approval/rejection of his/her application and the same is reflected on the profile of the candidate.

4.0 PAYMENTS FOR SERVICES

There would be a payment for the services to be rendered. Payment should be made using ATM cards or othemethods displayed at the time of payment, including USSD payment and bank transfer.

VERIFY UTME RESULT CLAIMS BEFORE AWARDING SCHOLARSHIPS - JAMB

he Joint Admissions and Matriculation Board (JAMB)has urged Nigerians to verify claims of excellent performance by candidates in the 2024 Unified Tertiary Matriculation Examination(UTME) before awarding scholarships.

The Registrar, Prof. Is-haq Oloyede, gave this advice over the weekend while interacting with media executives.

According to him, seeking clarifications from the Board would prevent fraudulent claims of excellence. He made particular reference to the case of Ms. Mmesoma Ejikeme and other candidates, who had tampered with their scores to curry undue favours from the public. While fielding questions on the Board's unwillingness to publish the names of its best-performing candidates, the Registrar stated that the UTME is a ranking examination for candidates, who had five O'level credit passes in English Language and Mathematics and were thus qualified for tertiary institution admission.

He explained further that there are other parameters that would come into play to constitute what would later be considered the minimum admissible score for candidates seeking admission to tertiary institutions.

The Registrar also stated that because of the various variables adopted by respective institutions, it might be downright impossible to arrive at a single score or an allencompassing set of parameters for generating a list of candidates with the highest admissible score as gaining admission by candidates remains the ultimate goal of the Board.

"Owing to public demand and to avoid a repeat of the Mmesoma saga, we will not hesitate to provide guidance for those who may want to award prizes to these set of highperforming candidates, therefore, the Board appeals to all concerned to always verify claims by candidates before offering such awards," he said.

This step-by-step procedure outlines how an examination body camecommend/reject an alignment of data application processed by a candidate:

- i. Visit NIPEDS Home Page:
 - a. Open the web browser and go tmipeds.jamb.gov.ng
 - **b.** Navigate to the examination bodies portal section on the homepage and click on the "Visit Portal" button.
 - c. On the new page, enter your login details and click on the "Submit" button
- **ii. View applications** Navigate to the Data Bank menu on the homepage and click on the "Data Alignment Applications" submenu.
- **iii. Recommend/Reject application** Click on the desired application. On the page shown, view the details of the application.
 - a. **To reject anapplication:** Click on the "Reject Application" button. On the confirmation modal shown, provide the reason for rejection. Confirm your rejection by clicking on the "Confirm Rejection" button.
 - b. **To Recommend an application**Click on the "Recommend Application" button. On the confirmation modal shown,
 - Enter the reason for recommending the application
 - If the application is a data discrepancy alignment application, select the type of data discrepancy that is applicable (alignment of name spelling, alignment of subject, alignment of grade)
 - Upload the candidate data.
 - Click on "Confirm Recommendation" to submit the entered details. Once it is submitted, it awaits approval by JAMB before the uploaded data can be added to the bank

3.0 JAMB APPROVAL/REJECTION

It is important to note the following actions that take place once the approval/rejection process is completed by JAMB:

- Once the recommendation has been approved/rejected by JAMB, the system automatically sends an email to the xamination body.
- the candidate also gets an email confirming the approval/rejection of his/her application.

EXAMINATION MALPRACTICE AS AN ATOMIC BOMB

s the Joint Admissions and Matriculation Board (JAMB) continues its ongoing Unified **Tertiary Matriculation Examinations** (UTME) that started last Friday (April 19, 2024), and for which some 1.985.642 candidates had reaistered. it is auspicious to underscore the significance of eschewing examination malpractice in Nigeria. This is because examination malpractice is the incubator of corruption and combating corruption must begin from fighting examination malpractice to a standstill. In fact, it takes examination malpractice to destroy a nation, not atomic bombs, as will be reiterated here.

Fortunately, the imperative of stamping examination malpractice out of the polity is not lost on the Registrar of JAMB, Prof. Is-haq O. Oloyede, a man of impregnable integrity, who has set a new standard in public service with his avowed commitment to ensuring that right things are done and things are done right. This commitment is manifesting in the ongoing examinations which took off successfully. As a former Minister of Education, Prof. Chinwe Obaji, noted last Friday while on an inspection mission, "There are neither technical hitches nor biometric issues that bedeviled past exams. Thanks to the JAMB Registrar, Prof. Is-haq Oloyede, and his reforms...."

To guard against compromising the integrity of the examinations, JAMB had warned parents, some of whom are fond of aiding and abetting examination malpractice by roaming around the examination centres. With a threat of arrest and prosecution dangling on the heads of those who may want to cheat or facilitate it, the signal is clear that the violators of law and regulation will face the music of their indiscretion.

Basically, examination malpractice must be construed as it is - a

arievous crime. As far back as 1984, the Federal Military Government had promulgated Decree 20 which was meant to destroy the cankerworm of examination malpractice. The decree states that anyone "who fraudulently or with intent to cheat or secure unfair advantage to himself or any other person on in abuse of his office, produces, sells or buys or otherwise deals with any question paper intended for the examination of persons at any examination or commits any of the offences specified in Section 3 (2,7) (c) of this Decree, shall be auilty of an offence and on conviction be sentenced to 21 vears imprisonment."

The Examination Malpractice Act 33 of 1999 revisits the issue and stipulates a minimum punishment of fifty thousand naira (50,000.00) and a maximum of five years imprisonment, without an option of fine, for violators of the acts described in the Act. The offences identified in the Act are cheating at examinations, stealing of question p a p ers, impersonation, disturbances at examination, obstruction of supervision, forgery of result slip, breach of duty, conspiracy and aiding, etc.

Rather than obey the law, do the right thing and shun examination malpractice, candidates and students over time have become innovative in perpetrating the act, which can easily erode confidence in the Nigerian education system. It is a national tragedy that some schools also engage in this vice through impersonating candidates, colluding with other candidates to penetrate fraud and encouraging mass cheating.

Without mincing words, the best way on the part of students to guard against examination malpractice is proper preparation. When candidates prepare adequately, they are confident of sitting examinations and succeeding. Poor preparation induces lack of confidence followed by desperation. It is also important that school proprietors prioritise decency, honesty and integrity rather than compromise the future of their students and sabotage the nation just to feather their own nest through unmerited recognitions and undeserved patronage.

The general degeneration and pervasive corruption in the Nigerian society can both be traced in a way to examination malpractice because it has a multiplier effect on the society. Urgent and sustained efforts against examination malpractice are of utmost importance. This is because it has been reported that a university gate in South Africa has the following message which is worthy of contemplation and action:

"Destroying any nation does not require the use of atomic bombs or the use of long range missiles. It only requires lowering the quality of education and allowing cheating in the examination by students. Patients die in the hands of such doctors. Buildings collapse at the hands of such engineers. Money is lost at the hands of such economists and accountants. Humanity dies at the hands of such religious scholars. Justice is lost at the hands of such judges. The collapse of education is the collapse of the nation."

To prevent Nigeria from utter collapse, it is expedient that we put all hands on deck to prevent and severely punish examination malpractice. This is a worthy fight that only the worthy can fight. Are you worthy?

UNVERIFIED CANDIDATES IN 2024 UTME WORRISOME - JAMB

The Joint Admissions and Matriculation Board (JAMB)has described as worrisome the multiple cases of unverified candidates in the 2024 Unified Tertiary Matriculation Examination (UTME) in spite of measures put in place to checkmate the phenomenon.

Consequently, the Board has put in place adequate machinery in motion to carry out thorough investigation with a view to unravelling the circumstances preventing candidates, who were captured successfully during registration but failed during the verification exercise.

The Registrar, Prof. Is-haq Oloyede,

in a statement underscored the importance of biometric verification stating that it remains the only costeffective check against impersonation.

The Registrar pointed out that the Board had invested heavily in the purchase of state-of-the-art verification equipment to ensure reduction in the incidence of cases of biometric failures. He also noted that at the completion of registration, candidates are expected to authenticate their verification status by using their fingerprints to print their registration slip.

The Registrar recalled that only 373 candidates were clearly certified to be unverifiable and were consequently exempted from biometric verification during the examination.

"The Board finds it strange to still have cases of unverified candidates. The first thing that comes to mind when a candidate fails biometric screening after recording success during registration and was able to print his notification slip afterwards is that this might likely be a case of impersonation.

"Unfortunately, we have candidates, who fall within that category despite being successfully captured ab initio."

The Registrar, therefore, reiterated the determination of the Board to unravel the mystery surrounding the issue.

CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS

- All applications of admissions to First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc., must be processed ONLY through the Joint Admissions and Matriculation Board (JAMB).
- No Institution should advertise or sell "application forms" for admissions into the programmes. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
