JAMB TO HOST 2024 POLICY MEETING ON ADMISSIONS SOON



he Joint Admissions and Matriculation Board (JAMB) has concluded arrangements to host the 2024 Policy Meeting on Admissions into tertiary institutions in Nigeria anytime from now.

The meeting, which is to be chaired by the Hon. Minister of Education, Prof. Mamman Tahir, would have other critical stakeholders in the education sector in attendance.

These critical stakeholders include Heads of regulatory agencies such as the National University Commission (NUC), National Board for Technical Education (NBTE), National Council for Colleges of Education (NCCE), Heads of tertiary institutions in the country, and the National Youth Service Corps (NYSC), among others.

The policy meeting on admissions sets the tone for any particular year's admission exercise, formulation of admission guidelines. It also presents application statistics, candidates' performance evaluation, as well as setting the acceptable minimum admissions standards for all tertiary institutions across Nigeria for the given year.

During the exercise, the Registrar will

NIPOST SEEKS CLOSER TIES

he Akwa Ibom State Office of the Joint Admissions and Matriculation Board (JAMB), on Tuesday, 11th June, 2024, played host to the NIPOST State Postal Manager (SPM), Dr. Chris Uzoma Ashiedu, who paid a courtesy call to the State Office as part of his efforts to seek closer ties with the Board.

Dr. Ashiedu discussed areas of mutual interest to both agencies and how the opportunities inherent therein could be harnessed for their mutual benefits.

Speaking further, Dr. Ashiedu highlighted the various services and products of NIPOST that could help the Board to further enhance its service delivery. These, he said, include: Courier Services, Logistics Services, Sales of Postage Stamps, EMS/Speedpost Courier, Parcel Services (both local and international), Haulage and Cargo Services, Agency services, Financial Services (Postcash) Online Electronic

Money Transfer, Bulk Post Services, Special Delivery Services for Corporate Agencies, Rental and Provision of Private Mail Bag (PMB) and Private and Commercial Post Office Boxes, Billboard Advertisement and Advertisement through PMBs, Registration of Courier Companies, Address Verification, Philatelic Services, Space Rentals of NIPOST Premises for Commercial use by agencies and corporate organisations, Stamp Authentication for transactions above 1000 Naira, E-Commerce, Pick up Services, and Post Shops, among others.

He also stressed the need for the creation of a NIPOST Desk Office at the JAMB Office, Uyo, towards enhancing accessibility to NIPOST services by JAMB candidates, staff, and other stakeholders in the State.

In her reactions, the State Coordinator, Mrs. Grace Olima-William, welcomed Dr. Ashiedu and his team to the State Office. She acknowledged the symbiotic partnership between the two agencies and emphasised the Board's commitment to exploring opportunities that promote effective service delivery.

In the company of the SPM, NIPOST, was the NIPOST State Manager, Corporate Communication, Mrs. Marthalkpong.

In a related development, the Nigerian Postal Service (NIPOST) has also reaffirmed its commitment to supporting the Joint Admissions and Matriculation Board (JAMB) in providing a seamless registration exercise for candidates aspiring to sit its Unified Tertiary Matriculation Examination (UTME).

VANGUARD, MONDAY, JUNE 10, 2024: UNILORIN Introduces Self-Defence, Combat Training for Students: - The University of Ilorin's Department of Criminology and Security Studies has introduced self-defence and combat training as a vocation to equip students with essential skills. Dr Adedeji Oyenuga, a Visiting Scholar and Associate Professor at Lagos State University, announced this at the training's maiden edition held at the university's sports complex. Although the training cannot be immediately integrated into the curriculum due to the proposal's late submission, the university has recognized its importance and is offering it as a vocational activity, with plans to incorporate it into the curriculum later. Dr Oyenuga emphasized the significance of self-defence in security studies, stating that this innovative approach aligns with the evolving landscape of Criminology and Security Studies, which demands practical self-defence techniques.

VANGUARD, MONDAY, JUNE 10, 2024: UNILORIN Research Group Gets N1.7b Grant to Develop Antibiotic Alternative: -The Innovative Veterinary Solutions For AntiMicrobial Resistance (INNOVET-AMR) 2 Research Group at the University of Ilorin (UNILORIN) has secured a grant worth 1.6 million Canadian Dollars (approximately N1.712 billion) to develop innovative solutions for Antimicrobial Resistance (AMR) in food-producing animals. The grant was awarded by the International Development Research Centre (IDRC) of Canada. Led by Dr. Ismail Ayoade Odetokun,

the research team will collaborate with researchers from Spain's Institute of Agrifood Research and Technology (IRTA) and the Royal Holloway University of London, UK. Their project, "Bacteriocin-rich **Extract from Engineered Lactic Acid** Bacteria as an Antibiotic Alternative for Therapeutic and Prophylactic Use in Ruminants and Aquaculture (BAC4RumA)," aims to develop a bacteriocin-rich extract (BRE) as a potential antibiotic alternative. The project will explore the effectiveness and economic benefits of BRE as a treatment and preventive measure against bacterial infections in livestock and aquaculture.

PUNCH, TUESDAY, JUNE 11, 2024: FG Approves N25bn for Tertiary Institutions Labs, Workshops Upgrade: - The Federal Government has approved N25 billion to upgrade laboratories and workshops in public universities, polytechnics, and colleges of education (Technical). The Executive Secretary of Tertiary Education Trust Fund (TETFund), Arc. Sonny Echono announced this during the inauguration of a 55member committee for TETFund National Research Fund (NRF) and Screening, and a 48-member committee for the Technical Advisory Group (TAG) in Abuja.

The NRF Screening and Monitoring Committee, established by the Fund's Board of Trustees, will implement and administer the intervention. Additionally, N5 billion was approved for skills-related equipment in polytechnics. Echono encouraged polytechnics to identify three to five skills areas and utilize the opportunity to train Nigerians.

Minister of Education, Tahir

Mamman, urged academia to contribute to national development through cutting-edge research during the committee inauguration. He highlighted the government's shift towards emphasizing research, innovation, and teaching in tertiary institutions. The administration is committed to reskilling the education sector, from primary to tertiary institutions, to equip youths with essential skills.

VANGUARD, TUESDAY, JUNE 11, 2024: **LASU Secures NUC Accreditation for** 44 Courses: - Lagos State University (LASU) has achieved a remarkable feat by securing National Universities Commission (NUC) accreditation for 44 courses. This accomplishment follows a rigorous exercise conducted by the NUC in October and November 2023. Prof. Ibiyemi Olatunji-Bello, the Vice-Chancellor of LASU, announced this achievement in a statement, highlighting that 43 courses received full accreditation, while 'Computer Science Education' received interim accreditation. This outcome represents an impressive 99% pass mark, setting a new record in the university's recent history. Prof. Olatunji-Bello emphasized that this achievement marks a significant milestone in the university's strategic goals, with course accreditation being a top priority.

served as the Acting Vice-Chancellor for 19 months following the death of Professor Mohammed Mustapha-Akanbi in November 2022. The appointment follows a screening exercise by the university's governing council, in which Prof. Shaykh-Lukman emerged as the top candidate. According to Rafiu Ajakaye, the Chief Press Secretary to the governor, Prof. Shaykh-Lukman brings decades of experience as an administrator and university scholar to the role.

PUNCH, THURSDAY, JUNE 13, 2024: Police Arrest Operators of Fake JAMB Websites: -The Nigeria Police Force has arrested three suspects responsible for creating fake JAMB registration websites and falsifying admission letters. According to a statement by Force Public Relations Officer Olumuyiwa Adejobi on June 13, 2024, the suspects were apprehended through a joint effort by the Police National Cyber Crime Centre and JAMB to combat phishing websites and scammers.

The suspects, Effa Leonard Mpama, Ibang Ernest Jerome, and Eshiet Odotukana Benson, aged 34, 38, and 38, respectively, are part of a syndicate that illegally accessed JAMB's Central Admission Processing System (CAPS) and e-facility. They altered and deleted genuine admission letters, replacing them with fake ones, compromising the entire JAMB admission process.

The Inspector General of Police, Olukayode Egbetokun, has reaffirmed the NPF's commitment to ensuring the safety and security of citizens both physically and in cyberspace. The suspects will be charged to court upon completion of investigations. Four fake domain names and websites were also recovered. <u>UBEC Warns Officers Against Infractions: -</u>The Universal Basic Education Commission (UBEC) has launched a revised Accounting Manual and a new sanction regime to enhance financial management and accountability in the basic education sector. Dr. Hamid Bobboyi, UBEC's Executive Secretary, announced this in Abuja, emphasizing the need for judicious use of government investments in basic education.

Speaking at a six-day training for UBEC and State Universal Basic Education Boards (SUBEBs) accountants and auditors, Bobboyi warned against financial infractions and stressed the importance of understanding the new accounting manual and sanction regime. The training aims to familiarize participants with the revised manual and ensure successful service delivery in basic education.

According to Adamu Misau, UBEC's Director of Finance and Accounts, the new sanction regime was developed in 2022 to safeguard the FGN-UBE Intervention Fund and was approved by the Commission Governing Board. The training programme is a precursor to the regime's implementation, ensuring that financial managers are equipped to handle funds judiciously, adhering to financial regulations and quidelines.

TRIBUNE, THURSDAY, JUNE 13, 2024: US CADFD Partners FUOYE on Curriculum Co-development for Women and Gender Studies: - The United States of America's Scholar Fellowship Programme for educational projects (CADFP) has selected Federal University Oye Ekiti (FUOYE) to host a collaborative project on Curriculum Co-Development for Gender Studies. This distinction comes four years after CADFP partnered with Benue State University for a similar project. Out of over 170 universities in Nigeria, FUOYE was chosen for its academic excellence, earning it the reputation as Nigeria's fastest-growing

university under the leadership of Vice Chancellor Prof Abayomi Sunday Fasina.

Professor Sylvia Uzochukwu of FUOYE's Food Science and Biotechnology department will lead the project alongside Professor Chinyere Okafor from Wichita State University in Kansas, USA. This project is one of 60 initiatives that will pair African Diaspora scholars with African higher education institutions for collaborative work on curriculum development, research, graduate training, and mentoring. Also in Nation, Thursday, June 13, 2024.

TRIBUNE, THURSDAY, JUNE 13, 2024: BSc./HND Dichotomy: Discriminating Against HND Holders in Workplace Wrong- FG: - The Federal Government has condemned the prevalent discrimination against Higher National Diploma (HND) holders in the workplace, favouring Bachelor of Science (BSc) degree holders. Minister of State for Education, Dr. Yusuf Sununu, addressed this issue at a one-day dialogue on the future of HND in Nigeria's educational landscape. He emphasized that discriminating against individuals with the right skills to perform optimally is wrong.

Dr. Sununu acknowledged the challenges faced by HND holders, stemming from societal perception that values paper qualifications over competence. However, he expressed confidence in the government's education reform initiatives, which aim to address these issues and promote a sense of belonaina. The integration of the National Skills Qualification framework (NSQ) into the Federal Schemes of Service and the new Performance Management System (PMS) are steps towards competency-based assessment in the workplace. Additionally, the National Board for Technical Education is promoting skills acquisition programmes for HND holders to enhance their relevance in the society.

This move aligns with global trends, emphasizing skill acquisition in polytechnic education. According to NBTE's Head of Media, Hajiya Fatimah Abubakar, diploma holders

will now receive a National Skills Qualification (NSQ) or its equivalent, in addition to their diploma certification. MSQ is now a compulsory requirement for all diploma programmes, ensuring graduates possess practical skills for career advancement. This dual certification enhances job prospects, provides a competitive edge, and equips individuals with the skills and knowledge needed to excel in their fields.

NEW TELEGRAPH, FRIDAY, JUNE 14, 2024: NELFUND to Publish Completed Data Submissions from Institutions for Student Verification:-The Nigerian Education Loan Fund (NELFUND) has announced that it would publish a comprehensive list of institutions that have submitted complete student data for the Student Verification System (SVS) portal on June 24. According to a statement signed by NELFUND's spokesperson, Nasir Ayitogo, the list will include both federal and state institutions to ensure transparency and encourage participation in the scheme. While many federal institutions have already completed the exercise, state-owned institutions are currently uploading their data to the NELFUND SVS portal. NELFUND emphasized the importance of accurate information, including JAMB numbers,

matriculation numbers, admission numbers, full names, and dates of birth, to facilitate a seamless evaluation process. Applicants are urged to enter their details accurately during the application process. present reports on the justconcluded Unified Tertiary Matriculation Examination (UTME) and the ongoing Direct Entry (DE) applications while also analysing key performance indicators that could shape the policy directions of the government in the area of admission.

Also, the meeting would apprise stakeholders of the salient issues that cropped up in the course of the previous year's admission exercise. In addition, the policy meeting would look at the performance of candidates in the current year's UTME in order to determine the year's minimum admissible score.

It would be recalled that stakeholders had in the previous year agreed on the minimum admission requirement for admission into universities, polytechnics and colleges of education.

Furthermore, the meeting would determine the year's admission requirements while kick-starting the admission process for the current year; discuss unresolved issues emanating from the previous academic year; and, at the same time, appraise the compliance of stakeholders with extant advisories and suggesting further amendments where necessary.



RE: ADVISORY ON 2024 DIRECT ENTRY (DE) REGISTRATION, VERIFICATION AND ALIGNMENT OF DATA (VERIFICATION OF A-LEVEL QUALIFICATIONS BY AWARDING INSTITUTIONS)

This advisory is issued to guide all A-level certificate awarding institutions on the procedures of verifying the certificates claimed by candidates during the 2024 DE registration exercise.

This is a follow-up to the earlier issued advisory referenced No. 2024ff01, dated 31st March, 2024 (copy attached) on the above subject. This edition is issued to reiterate the previously raised matters as well as to guide all A-level awarding institutions on the procedures to be followed to verify the certificates claimed by candidates during the 2024 DE registration exercise.

All concerned institutions should therefore take note and adhere strictly to the provisions herein:

- 1. As part of the requisite requirements for Direct Entry application, all applicants' qualifications must be uploaded at the registration point (JAMB Professional Registration Centre (PRC), while the Head of the awarding institutions gets notified immediately through email to verify the candidates' claims.
- 2. The Institutions are expected to log in to the JAMB website via this linkhttps://efacility.jamb.gov.ng/InstitutionSignin. Please, note that the link is also included in the mail sent to the Heads of Institutions once candidates' certificates are uploaded during registration. Institutions without efacility account should contact JAMB through the CAPS mail for details.
- 3. On Login, by the left pane menu list, click on Certificate Verification (DE Registration) menu to view the list of all untreated candidates' applications.
- 4. To treat each candidate's application, click on the "Process Button" beside the name of the candidate to pull the candidate's full information, including the uploaded certificate.
- 5. To confirm that a candidate's certificate is genuine, select the "first radio button" and click the blue "Authenticate Certificate" button. This verifies the certificate as genuine and also sends an email and SMS to the candidate (and reflects on the JAMB's profile of the candidate) confirming the authenticity of his/her certificate.
- 6. To confirm that the certificate is fake or rather not issued by the institution, select the "second radio button", while you specify the reason for disapproving the certificate and click on the "Disown Certificate" button. This disowns the certificate and also sends an email and SMS to the candidate (and reflects on the JAMB's profile of the candidate) informing him/her why his/her certificate was disowned by the institution.
- 7. As soon as either of steps (5) or (6) above is completed, the response will be automatically sent back to the database for update.
- 8. The procedure is a continuous process and all candidates must be treated individually.

Note: a. For further guidance, a manual is provided

b. The Board will NOT consider for admission any candidate whose qualification is not verified by the awarding institution.

RE: ADVISORY ON 2024 DIRECT ENTRY (DE) REGISTRATION, VERIFICATION AND ALIGNMENT OF DATA

This advisory is issued to guide stakeholders on the alignment of data for the 2024 DE registration and verification of candidates' data

1.0 PREAMBLE

The Board has been receiving series of complaints from institutions on candidates with forged or fake A-level certificates. Each institution has the policy of verifying the credentials of admitted candidates to ascertain their authenticity. One of such exercises was carried out by Bayero University, Kano, where the results of 148 admitted students were verified and 142 of them were found to be forged or faked. The Independent Corrupt Practices and other related Offences Commission (ICPC) in conjunction with the Federal Ministry of Education and JAMB subsequently carried out a sting operation at the A-level examination venues across the country. The result of which was extremely embarrassing to the Education sector. The then Chairman of ICPC said that much.

As a result of this, the Board had to, with the approval of the Federal Ministry of Education, act appropriately and establish the Nigeria Integrated Post-Secondary Education Data System (NIPEDS) which has the mandate to verify all A-level certificates used in the DE application before admission is considered.

2024 DE CANDIDATES VERIFICATION FLOW

Find below the flow of candidates' verification by NIPEDS:

Every candidate presents his/her credentials for DE registration at any of the JAMB PRCs/State Offices.

- a. Upon receiving the document, it is classified as follows:
 - i. For IJMB, JUPEB, NABTEB or Cambridge (post-2018) certificate or awaiting result candidates of IJMB, JUPEB or NABTEB, the candidate data is compared to the databank on NIPEDS for such qualifications. The system checks with the candidate's number as supplied by the respective examination body. The system verifies alignment of name, qualification, subject and grades (where applicable). Once the alignment is confirmed, the candidate continues and completes his/her registration.



- ii. For other qualifications other than "i" above, the credentials of the candidates are transmitted to the respective institution to authenticate/verify the claim.
- iii. If the institution is compliant (credibility of prompt response to verification request in 2023), the candidate is allowed to complete his/her DE registration without waiting for verification of the result from the awarding institution. For the avoidance of doubt, the following 15 institutions are regarded as non-compliant for the on-going 2024 DE registration:
 - A. Four (4) Universities:
 - i. Ahmadu Bello University, Zaria (565 candidates);
 - ii. University of Nigeria, Nsukka (125);
 - iii. Ekiti State University, Ado-Ekiti (61); and
 - iv. Federal University of Technology, Owerri (12).
 - B. Five (5) Polytechnics/Monotechnics:
 - i. Nuhu Bamalli Polytechnic, Zaria (61);
 - ii. Akanu Ibiam Federal Polytechnic, Unwana, Afikpo, Ebonyi State (58);
 - iii. College of Health Technology, Calabar (25);
 - iv. Best Solution Polytechnic, Akure, Ondo State (24) and;
 - v. Federal College of Animal Health and Production Technology, V om, Plateau State (24);
 - C. Six (6) Colleges of Education:
 - i. Cross River State State College of Education, Akamkpa (91);
 - ii. Kashim Ibrahim College of Education, Maiduguri, Borno State (72);
 - iii. College of Education, Katsina-Ala, Benue State (47);
 - iv. Osun State College of Education, Ila-Orangun, Osun State (27);
 - v. Shehu Shagari College of Education, Sokoto (25); and
 - vi. College of Education, Waka-Biu, Borno State (20).

2.0 EXPERIENCE/LESSONS FROM 2023 VERIFICATION EXERCISE

The Board had on 23rd February 2023 issued an advisory to guide the registration of candidates seeking admission through Direct Entry (DE) in the 2023/2024 academic session. That was to address the issue of candidates who intended to use forged or fake A-level certificates/qualifications to secure admission.

For effective monitoring, DE registration from 2022/2023 academic session, has been restricted to JAMB-PRCs (offices).

For 2023 registration, of the 44,866 candidates who applied for the DE (or converted from UTME) 1,957 have so far been disclaimed by institutions/examination bodies.

The verification exercise by the Nigeria Post-Secondary Education Data System (NIPEDS) also revealed some discrepancies which could unduly disadvantage students/candidates or provide avenue for their impersonation. The discrepancies are:

Consequently, the Board introduced new measures, through the **THIRD-PARTY A-LEVEL DATA ALIGNMENT PLATFORM (TALDAP)**, to align the data supplied by the candidate with the data supplied by the examination bodies before DE registration.

1.0 PREDE REGISTRATION ALIGNMENT

Going by the experiences of the 2023 DE registration exercise, the Board has introduced, where necessary, the preregistration checks and data alignment for applicants with only IJMB, JUPEB, and NABTEB qualificationshis provision enables the system to authenticate the details supplied by a prospective candidate at the point of registration with what has been preloaded by the examination bodies. A platformTHIRD-PARTY ALEVEL DATA ALIGNMENT PLATFORM (TALDAR) been provided to cater to this.

When a candidate's data (spelling of name, result/grade, subjects) do not align or are not included with the records supplied by the examination bodies, an alignment must be done on the TALDAP, before proceeding with the DE registration with JAMB.

It is worth noting that there are ONLY two (2) types of pregistration data alignment available on the TALDAP system:

- a. **Missing candidate's data alignment (data omissiαn)** his type of alignment can only be carried out when at the point of registration, the exam/matric/registration number supplied by the candidate and on the presented credential of the candidate for a particular qualification (IJMB/JUPEB/NABTEB) does neturn any candidate's data.
- b. **Data discrepancy alignment** This type of alignment can only be carried out when at the point of registration, the exam/matric/registration number supplied by the candidate and on the presented credential of the candidate, for a particular qualification, returns a candidate's data hat contains name spelling mistakes/omission, different grades, and/or subject combinations, other than what was presented in the candidate's credential.

2.0 PROCESS OF APPLYING ALIGNMENTS FOR DATA OMISSION OR DATA DISCREPANCY

The processes are described below:

- i. Visit NIPEDS A/level Home PageOpen the web browser and go to nipeds.jamb.gov.ng
- ii. Click on Alignment of Data ApplicationNavigate to the alignment of data section on the homepage and click the "Visit Portal" button.
- iii. Click on Apply for Alignment of Data button to begin the application process on the new page
- iv. Select the Type of Data AlignmentOn the page,
 - a. candidates should choose the appropriate alignment type (missing candidate data alignment or data discrepancy alignment). If data discrepancy alignment is selected, the candidate can then select "alignment of name spelling", "alignment of subjects" or "alignment of grades"
 - **b.** candidates should provide the examination number and year as shown on the claimed certificate/document;
 - **c.** candidates should provide a valid email address (preferably the one to be used or used for JAMB registration).
- v. Provide the SupposedlyOmitted/Correct Data: In the subsequent step on the page, the candidate should input the name, subject, and grade, exactly as shown on his/her certificate/document and upload the proof/credential.
- vi. **Make Payment:**The final step involves making a payment.
- vii. Application Completion Candidates will receive an email for payment made which serves as a confirmation of the "submitted application". An email notification will also be sent to the examination body informing them about the new application which they are to either recommend to AMB or Reject. Any of the actions will have justifications A submitted application does not automatically mean approval.

3.0 JAMB APPROVAL/REJECTION

Once the application is approved or rejected, the candidate gets an email confirming the approval/rejection of his/her application and the same is reflected on the profile of the candidate.

4.0 PAYMENTS FOR SERVICES

There would be a payment for the services to be rendered. Payment should be made using ATM cards or othermethods displayed at the time of payment, including USSD payment and bank transfer.

1.0 PREDE REGISTRATION ALIGNMENT

Going by the experiences of the 2023 DE registration exercise, the Board has introduced, where necessary, the preregistration checks and data alignment for applicants with JMB, JUPEB, and NABTEB qualification is provision enables the system to authenticate the details supplied by a prospective candidate at the point of registration with what has been preloaded by the examination bodies. A platform "THIRD-PARTY A-LEVEL DATA ALIGNMENT PLATFORM (TALDAP)" has been provided to cater to this.

When a candidate's data (spelling of name, result/grade, subjects) do not alignith or are not included in the records supplied by the examination bodies, an alignment must be done on the TALDAP, before proceeding with the DE registration with JAMB.

It is worth noting that there are ONLY two (2) types of pregistration data alignment available on the TALDAP system:

- i. Missing candidate's data alignment (data omissiαn) his type of alignment can only be carried out when at the point of registration, the exam/matric/registration number supplied by the candidate and on the presented credential of the candidate for IJMB/JUPEB/NABTEB does not return any candidate's data.
- ii. Data discrepancy alignment This type of alignment can be carried out, when at the point of registration, the exam/matric/registration number supplied by the candidate and on the presented credential of the candidate, for a particular qualification, returns a candidate's data that contain name spelling mistakes/omission, different grades, and/or subject combinations, other than what was presented in the candidate's credential.

2.0 PROCESS OF DATA ALIGNMENTS FOR IJMB, JUPEB, AND NABTEB QUALIFICATIONS

This step-by-step procedure outlines how an examination body camecommend/reject an alignment of data application processed by a candidate:

- i. Visit NIPEDS Home Page:
 - a. Open the web browser and go topiceds.jamb.gov.ng
 - **b.** Navigate to the examination bodies portal section on the homepage and click on the "Visit Portal" button.
 - **c.** On the new page, enter your login details and click on the "Submit" button
- **ii. View applications** Navigate to the Data Bank menu on the homepage and click on the "Data Alignment Applications" submenu.
- **iii.** Recommend/Reject application Click on the desired application. On the page shown, view the details of the application.
 - a. **To reject anapplication:** Click on the "Reject Application" button. On the confirmation modal shown, provide the reason for rejection. Confirm your rejection by clicking on the "Confirm Rejection" button.
 - b. **To Recommend an application**Click on the "Recommend Application" button. On the confirmation modal shown
 - Enter the reason for recommending the application
 - If the application is a data discrepancy alignment application, select the type of data discrepancy that is applicable (alignment of name spelling, alignment of subject, alignment of grade)
 - Upload the candidate data.
 - Click on "Confirm Recommendation" to submit the entered details. Once it is submitted, it awaits approval by JAMB before the uploaded data can be added to the bank

3.0 JAMB APPROVAL/REJECTION

It is important to note the following actions that take place once the approval/rejection process is completed by JAMB:

- Once the recommendation has been approved/rejected by JAMB, the system automatically sends an email to theexamination body.
- the candidate also gets an email confirming the approval/rejection of his/her application.
