## UNILORIN GOLDEN JUBILEE: JAMB COMMISSIONS NATAP-M AWARD INTERNATIONAL HOSTEL



The Joint Admissions and Matriculation Board (JAMB) has commissioned the National Tertiary Admissions Performance-Merit (NATAP-M) Awards International Hostel. The facility, named the "JAMB Merit Awards International Hostel," was constructed by the University of Ilorin using the proceeds of the ₦500 million prize it won in the 2022/2023 edition of the NATAP-M award.

place in the scheme of things.

"It is our duty to remind ourselves that Africa will only be great when the continent of Africa and its intellectuals are given their rightful place. Many times when I look at the continent of Africa, and I look at other continents, I look at the promises that we make to ourselves, and many of the promises that we have made to ourselves in the continent of Africa have been made here in Nigeria," he said.

The legal icon, whose lecture dwelled extensively on the role of universities as catalysts for development, posited that its time now for

"African universities to be given the respect that they deserve while African scholars must also be given the respect that they deserve.

"We are the only continent in the world where academics do not get the remuneration that they deserve, but politicians are multi-millionaires.

If Africa is to compete with the rest of the world, it must change. And Africa will only change when academics are given opportunities and compensated in the manner that they should be."

According to Prof Lumumba, the continent is highly-endowed with human and material resources to change the narratives and jump-start the continent to greatness even as he expressed optimism that all hope is not lost.

"I'm looking forward to the day when the engineers prove that the University of Ilorin will solve the problems of the continent of Africa. I look forward to the University of Ilorin producing a different set of graduates of agriculture, so that when we talk about aquaculture in Nigeria, when we talk about poultry farming in Nigeria, when we talk about sugarcane farming in Nigeria, when we talk about all these things, Africa will be ready and able to feed

itself. Today, African cannot feed itself.

"It gladdens my heart that at this University of Ilorin, you are beginning to teach the next generation that Ilorin can produce university graduates of the same quality as anywhere else in the world. When the Vice-Chancellor was reading his speech, he did not say that he wanted to be the Oxford of Nigeria or the Harvard of Nigeria. He wanted to be the Ilorin of Nigeria.

"He had said, 'the time has come for us to refer to ourselves without trying to mimic others. And in doing so, we must also have a cultural orientation that is informed by the realities of our circumstances.' And that is why it gladdens my heart."

Prof Lumumba, therefore, commended the founding fathers for the conception and the nurturing of the university to greatness.

"Honourable Vice-Chancellor, let me

TRIBUNE, MONDAY, NOVEMBER 24, 2025: WAEC Gives Update On Five Compulsory Subjects Ahead of May/June 2026: The West African Examinations Council (WAEC) has provided an update on the compulsory subjects that candidates sitting the May/June 2026 West African Senior School Certificate Examination (WASSCE) and subsequent editions must register for... The Head of the National Office of WAEC Nigeria, Dr. Amos Dangut, explained this shortly after the conclusion of this year's Annual Meeting (63rd edition) of the Nigeria National Committee (NNC) of WAEC, held over the weekend in Umuahia, Abia State...

According to Dr. Dangut, "We want to assure all students that no candidate will be restricted from registering for subjects from other subject groups or distinct elective fields. Specifically, science students are not barred from taking Economics as an elective subject. They can choose the subject to complete their selection..."

He stated, "The subjects to be offered by candidates have now been categorized into five distinct fields, namely: core subjects, science subjects, humanities subjects, business subjects, and trade subjects..."

PUNCH, TUESDAY, NOVEMBER 25, 2025: FG Begins Final Steps On YABATECH Varsity Upgrade: The Federal Government has begun considering the recommendations of the committee set up to work out the modalities for the upgrade of Yaba College of Technology to the University of Technology and Vocational Studies. President Bola Tinubu, represented by the Minister of

State for Education, Prof Suwaiba Ahmad, disclosed this during the 37th Convocation Ceremony of Yabatech on Thursday. He had, in February, approved the conversion of YABATECH to a university.

Speaking at the convocation, President Tinubu said the upgrade of Yabatech, established originally as Yaba Technical Institute in 1947, was aimed at integrating hands-on technical training with advanced research, thereby fostering innovation, economic growth and national development.

He said, "As you are aware, the Federal Government has approved the upgrading of YabaTech to Yaba Technical and Vocational University. The committee constituted to work on the modalities to bring about seamless transition has already submitted its report. The recommendations are being considered." He said.

PUNCH, TUESDAY, NOVEMBER 25, 2025: New Development Levy Will Cut Out-Of-School Figures— TETFund: The Executive Secretary of the Tertiary Education Trust Fund, Sonny Echono, has said that the newly introduced Development Levy will play a crucial role in reducing Nigeria's out-of-school population and improving the quality of tertiary education nationwide. Nigeria has an estimated 18.3 million children out of school, according to the United Nations Children's Fund.

Arc. Echono stated this at the 2025 TETFund Board of Trustees Town Hall Meeting in Lagos, where he confirmed that the Fund will receive 50 per cent of the levy from next year. The Development Levy, introduced under the Nigeria Tax Bill 2024, consolidates

four existing statutory levies: the Tertiary Education Tax, Information Technology Levy, NASENI levy and the Police Trust Fund levy...

THISDAY, WEDNESDAY, NOVEMBER 26, 2025: UI Lecturer Wins 2025 Rahamon Bello Best Thesis Award: A lecturer at the Department of Geography, University of Ibadan, Dr. Oluseyi Obateru, has been declared winner of the 2025 Rahamon Bello Award for best Ph.D thesis in African Studies. The Director, Institute of African and Diaspora Studies (IADS), University of Lagos, Prof. Ayo Yusuf, made this announcement in a recent interview in Lagos.

He stated that the winner's thesis is titled: 'Dynamics of Urban Landscape Structure and its Impact on Ecosystem Services in the Rainforest and Guinea Savanna Ecoregions of Nigeria'. According to him, Dr. Obateru's thesis was an important contribution to the growing sub-field of urban environmental studies, with a focus on Guinea Savanna ecoregions of Nigeria.

He added that "The thesis not only contributes to the knowledge of the ecosystems of the focus region, but also contributes importantly to the methodology of the field. It is a well written and accessible work. It also appropriately employs the technical register of the field. The additional technical integration and finesse recommend it to the top of the pack in this competition," he stated.

SAHARA REPORTERS, WEDNESDAY, NOVEMBER 26, 2025: Education Rights Group Warns WAEC Against Forcing Students To Take Strange Subjects In 2026 Exam: The Education Rights Campaign (ERC) has cautioned the West African Examination Council (WAEC) against going ahead with plans to use the new curriculum for the 2026 West African Senior School Certificate Examination (WASSCE), insisting that the move would unfairly disadvantage current SS3 students. In a statement issued by its National Mobilisation Officer, Mr. Adaramoye Michael Lenin, the group said WAEC's insistence, communicated in a November 21, 2025 letter to school principals, would compel most candidates to register for at least two subjects they have not studied since SS1 just to meet the minimum eight-subject requirement.

"It takes at least three years of SSS 1-3 to prepare students for WASSCE. How does WAEC expect students to be prepared for the exam in just two terms?" the ERC queried. While acknowledging that curriculum reviews are a normal part of educational development, the organisation faulted what it described as WAEC's "fire-brigade approach" to the rollout...

PUNCH, WEDNESDAY, NOVEMBER 26, 2025: Stop Building Boarding Schools In Unsafe Areas, Tinubu Urges States: President Bola Tinubu has urged state governments to rethink the establishment of boarding schools in remote or under-protected areas, citing the growing risks to students. This followed a wave of mass school kidnappings of schoolchildren and teachers in Niger, Kebbi and other parts of the country in the past week. In a statement he signed, the President warned that poorly located boarding institutions are increasingly vulnerable to attacks by armed groups. "States should rethink establishing boarding schools in remote areas without adequate security," the president said. He also urged mosques and churches to constantly seek police and other security protection when they gather for prayers, especially in vulnerable areas. Speaking further, the President

assured Nigerians that his administration would continue to maintain efforts in securing the remaining students of Catholic School in Niger State and other Nigerians still being held, hostage.

UDST is a leading institution for applied education and research, contributing to Qatar's sustainable development and the global community.

Minister of Education, Dr. Olatunji Alausa, announced the collaboration when he paid an official visit to the university and was warmly received by the President of UDST, Dr Salem Al-Naemi, alongside other members of the university's senior leadership. During the visit, Dr Alausa toured the university's renowned Certificate School, a specialised institution that is focused on competency-based TVET education and internationally accredited technical programmes...

**BLUEPRINT, THURSDAY, NOVEMBER 27, 2025: TETFund Spends N30bn To Strengthen Security In Nation's Tertiary Institutions:** The Tertiary Education Trust Fund (TETFund) has said it invested more than N30 billion to strengthen security in tertiary institutions across Nigeria between January till date. The Chairperson, Board of Trustees (BoT), TETFund, Mal. Aminu Masari, made the disclosure in a statement in Katsina, Katsina state. Mal. Masari, who was once the governor of Katsina state, said the investment had significantly improved safety for students, lecturers, and other campus residents. He stated further that the security intervention aligns with President Bola Tinubu's commitment to creating a safe and conducive learning environment in the country's higher institutions. "Just as we created a budget line for electricity, we also deemed it fit to establish a dedicated line for security. Students and academic staffers need safe environments to carry out their activities," he said.

**GUARDIAN, FRIDAY, NOVEMBER 28, 2025: Mother Tongue Ban Could Collapse Nigerian Education – NAE:**

The Nigerian Academy of Education (NAE) has criticised the Federal Government's recent cancellation of the National Language Policy, calling on the Minister of Education, Maruf Alausa, to reinstate the use of mother tongue as the language of instruction at the foundational levels of schooling.

In a position paper submitted to the minister on November 25, the NAE argued that evidence supports early education in indigenous languages, stating that it enhances learning outcomes, strengthens cultural identity, and promotes inclusive national development. The statement was signed by NAE President, Emeritus Professor Olugbemiro Jegede, and Secretary-General, Professor Chris Chukwurah.

The Academy described the policy reversal as a "grave disservice" to Nigeria's educational progress, warning that discontinuing mother tongue instruction without rigorous evaluation amounted to "permanent recolonisation and the burial of Nigeria's future and pride."

**LEADERSHIP, FRIDAY, NOVEMBER 28, 2025: KASU Wins N1bn TETFund Grant For Commercial Agriculture:** The Vice Chancellor of Kaduna State University (KASU), Professor Abdullahi Ibrahim Musa, has announced that the university has won a ₦1 billion competitive grant for commercial agriculture, awarded by the Tertiary Education Trust Fund (TETFund). Prof. Musa also emphasised that KASU has evolved into one of the most progressive centres of higher learning in academic delivery, research and

expanded infrastructure. He emphasised that the university has expanded opportunities for Kaduna State's youth to achieve academic excellence.

Prof. Musa, who made this known in a statement, said that three KASU scholars have been ranked among the World's top 2 per cent scientists, "a historic achievement for not just Kaduna State but Nigeria at large." He listed Prof. Ibrahim Inuwa of the Department of Chemistry, Dr Daniel Yahaya Shagaiya of the Mathematics Department, and Dr Abdullahi Yusuf Zuntu of the Department of Physics as KASU scholars who are making the nation proud.

**PUNCH, FRIDAY, NOVEMBER 28, 2025: 2026 CBT Rollout On Track, Says WAEC:** The West African Examinations Council has maintained that its plan to conduct the 2026 West African Senior School Certificate Examination for school candidates through a fully computer-based system remains firmly on track. WAEC also assured that no candidate would be required to travel more than two kilometres from their location to take the examination.

This was contained in a statement delivered by the Head of the Nigeria National Office of WAEC, Dr Amos Dangut, during a press conference in Umuahia, Abia State, on Friday.

**THISDAY, SUNDAY, NOVEMBER 23, 2025: NUC Uncovers 32 Fake Honorary Degree Varsities, Seeks New Law:** The National Universities Commission (NUC) has uncovered 32 institutions involved in the illegal and unethical award of honorary doctorate degrees, vowing tough sanctions to protect the integrity of Nigeria's higher education system. The 32 violators include 10 foreign universities, four unlicensed local universities, 15 professional bodies without degree-awarding powers, and three other institutions not authorised to confer academic titles. Executive Secretary of the Commission, Prof. Abdullahi Ribadu, disclosed this during a press briefing in Abuja while lamenting the growing abuse of honorary degrees by both awarding institutions and recipients.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.

## BURIAL EXPENSES IN THE PUBLIC SERVICE

*"In moments of loss, dignity and support speak louder than words." — Anonymous*

The Public Service Rules (PSR) outline the obligations of Government when an officer dies either in service or while on an official assignment abroad. Understanding these provisions helps staff appreciate the welfare protections available to them and their families during difficult times.

This edition provides a simplified guide to burial expense provisions under PSR 130401 and 130402.

### 1. Repatriation of Corpses from Abroad

Where a Nigerian Officer dies abroad while on any of the following:

- Official duty tour
- Course of instruction/training
- Or where the spouse duly authorized to accompany the Officer dies

...the Government will repatriate the corpse at the request of the family.

Government's responsibility is strictly limited to the following:

#### i. Preparation of the Body

- Embalming and other necessary preparations

#### ii. Provision of a Standard Casket

- A reasonably priced coffin or casket
- Includes inner zinc and wooden coffin as required by airline regulations

#### iii. Transportation to Home Town

- Conveyance of the corpse to the officer's home town at reasonable cost

#### iv. Obituary Publication Support

- Cost of obituary publication not exceeding **one full-page advertisement** in **one national newspaper**, paid to the family at prevailing rates. (PSR 130401)

## ...Human Resource Management in Focus

Where a pensionable officer dies while in active service, government's financial responsibility is clearly defined:

### ✓ **Payment of 100% of Total Annual Emolument**

The Government shall pay to the deceased officer's family a sum equal to one full year's total annual emolument as burial expenses.

This payment serves to:

- Support the family in managing funeral arrangements
- Provide immediate financial relief during a difficult period
- Uphold the welfare commitment of government to its workforce (*PSR 130402*)

### **Why These Rules Matter**

The burial expenses provision:

- Ensures dignity and respect in handling the remains of the deceased officers
- Provides structured financial support to families
- Prevents confusion, delays, or disputes during emotionally challenging periods
- Reinforces government's commitment to staff welfare, even beyond active service.

Understanding these benefits helps officers and their families know what support is available when needed.

### **In Conclusion**

Loss is never easy, but clear administrative provisions ensure that officers and their families are not left unsupported. Every staff member is encouraged to familiarize themselves with these rules and keep their personal records—especially Next of Kin information—accurate and up to date.

start by congratulating the University of Ilorin, Kwara, on the occasion of its 50th anniversary. This is my first time at this university, and I can assure you that I have visited several universities on the continent of Africa and around the world. And you are better by far.

And you know, even if you do not have to say it yourself, a great Nigerian once said that the lizard that jumped from the high Iroko tree praised itself if there was nobody to do so. But on this occasion, I praise you."

Continuing, he said, "If this can be replicated in Nigeria and be replicated on the continent of Africa, then we will not be a continent that is famous, or is it infamous, for going around the world with a beggar's

bowl, asking from other civilisations. I am suggesting that we have a duty to do so. I am also hoping that this university, as it is celebrating its 50th anniversary, will be a university that restores our self-esteem.

"For too long, we, in the continent of Africa, have laboured under some complex. For too long, we, in the continent of Africa, have believed that what is ours is not good enough. For too long, on the continent of Africa, we labour under the misguided belief that we have to be acknowledged by others."

Prof Lumumba also stated, "When this university was established, perhaps very few knew that it would acquire the status that it now has. But yet, a great Nigerian once said that when you look at the mouth of a king, you would not know that he too suckled at his mother's breast. And that is also true of the mouth of a queen.

"Today, when we look at the University of Ilorin, nobody would imagine that only 50 years ago it was a toddler beginning to learn not only to crawl but even to sit. But 50 years later, we are now witnessing that it has grown into the giant that it is. It is a giant that is acknowledged not only in the community in which it sits. It is a giant that is acknowledged not only in Nigeria. It is a giant that is acknowledged in the continent of Africa and in the world."

In conclusion, Prof. Lumumba remarked that, "It is incumbent upon us, therefore, to praise those who thought about the establishment of the University of Ilorin. But as we look to the future and as we celebrate 50 years, it is incumbent upon us that we must not rest on our laurels. It is incumbent upon us to remember that Africa is still punching at the lower levels."

### **ADVISORY ON PROCEDURE FOR PROCESSING OF (DEGREE) ADMISSION FOR AFFILIATED INSTITUTIONS**

In 2022, the Board proposed that universities should take full responsibility for admissions into all degree programmes offered through institutions affiliated with them. However, this directive was not fully implemented, as universities were initially given the liberty to decide on the matter, pending a final resolution. To date, only the University of Ibadan has assumed this role of overseeing and coordinating the admissions of its affiliate institutions.

2. Following the meeting held on Monday, 18th August 2025, with various institutions regarding violations of matriculation guidelines, concerns were raised about the existing admission processing structure. Notably, institutions complained that they could not be held accountable for the misdemeanors of their affiliates under the existing processing format. As a result of this, the matter was revisited.

3. Consequently, it was resolved that the previously proposed process, where Mother-Institutions take responsibility for admissions into their affiliated institutions, should now be adopted and implemented by all universities with affiliates.

4. In light of the above, the Board has developed an updated procedure for the processing of admissions by both Mother-Institutions and their affiliates, as follows:

- a. Head of the affiliated-institution logs into JAMB (CAPS) portal and downloads candidates for a particular programme;
- b. The Head of the Affiliated-Institution (wherever it is based) logs into JAMB (CAPS) portal and sets admissions criteria for every programme, such as minimum scores for UTME, post UTME, aggregate, catchment and ELDS;
- c. The Head of the affiliated institution proposes the qualified candidates for each programme on CAPS and it goes to the Head of the mother-institution;
- d. The Head of the Mother-Institution (wherever it is based) logs into the JAMB (CAPS) portal and recommends the candidate to the Registrar of JAMB (or representative) for approval or declines the proposal with a reason for the rejection;
- e. The Registrar of JAMB (or representative) approves the recommendation(s) from the Head of the Mother-Institution or declines the recommendation with a reason for the rejection;

- f. If the recommendation is approved, the candidate is notified through his/her email and SMS to either accept or reject the offer of admission. The two institutions can log in and view the status of the recommended candidates;
- g. If the candidate accepts the offer of admission, he/she can thereafter print his/her admission letter and access other services online from his/her profile.

**NOTE:** The Head of an Affiliated-Institution has access to **"VIEW ONLY"** all recommendations by the Head of a Mother-Institution.

5. All Universities serving as Mother-institutions, Polytechnics/Monotechnics, Colleges of Education and other institutes offering degrees in affiliation with universities are to be guided by this, please.
