

### **CANDIDATES REGISTERING FOR 2026 UTME** TO DISCLOSE THEIR ADMISSION STATUS

he Joint Admissions and Matriculation Board (JAMB) has directed its relevant departments to ensure that the registration template for the 2026 Unified Tertiary Matriculation Examination (UTME) includes a mandatory field requiring all candidates to declare their current admission status, that is, whether or not they are already

students of any tertiary institution in Nigeria or elsewhere.

This measure is part of the Board's renewed efforts to curb impersonation and other forms of examination malpractice observed during the 2025 UTME cycle.

### ...Candidates Registering for 2026 UTME to Disclose Their Admission Status

2025 UTME Infraction Report, over 90% of candidates involved in various forms of examination malpractice were already students of tertiary institutions who sought to manipulate the system for illegitimate gains.

Consequently, beginning with the 2026 UTME registration, every candidate will be required to make a clear declaration regarding their current studentship status.

Any candidate who fails to disclose

such information or is found to have provided false details will face appropriate sanctions, including the withdrawal of any earlier admission, cancellation of current registration, and possible prosecution in line with existing laws and regulations.

This directive serves as an early notice to all prospective candidates and the general public that the Board will not tolerate any attempt to undermine the integrity of the admission process. The UTME is

designed primarily for fresh admission seekers, and candidates who are already admitted into tertiary institutions must not, under any guise, participate in the examination without proper disclosure.

The Board remains committed to ensuring that the admission process in Nigeria remains transparent, fair, and credible, while upholding the highest standards of integrity and accountability.

### LATE NSCDC COMMANDANT LAID TO REST

t was a day of mourning at the Edo State NSCDC Command, as officers bade farewell to their late Commandant, Agun Gbenga Joseph, whose demise was announced on 2nd October, 2025, during an official assignment.

The late Commandant, who hailed from Osogbo, was born on 24th, September, 1968. He assumed duty at the Edo State Command on 10th January, 2024, as the 18th

Commandant in the State.

### 2026 UTME REGISTRATION: LAGOS LGZO (HA) SENSITIZES SECONDARY SCHOOLS ON COSTLY MISTAKES

s part of the programmes heralding the 2026 Unified Tertiary Matriculation Examination (UTME) registration exercise, the Lagos Zonal Office (LGZO) Headquarters Annex, Joint Admissions and Matriculation Board (JAMB) has organised a sensitisation programme for students and teachers of selected secondary schools in the State.

The event, which was held on Thursday, 30th October, 2025, at Araromi Senior Secondary School, Sari-Iganmu, Lagos, provided a unique opportunity for the Director, JAMB LGZO (HA),Mr. Billiaminu Shittu, to sensitise prospective UTME candidates ahead of the upcoming registration exercise.

Furthermore, he leveraged the event to highlight certain avoidable mistakes that are capable of diminishing candidates' admission prospects adding that some mistakes could not be corrected after registration.

The initiative, according to the Director, was borne out of the need to address these avoidable pitfalls and equip the participants with the right information needed for a seamless registration. He also added that the outreach underscores the Board's commitment to inclusivity, awareness, and excellence in service delivery.

He highlighted some of these mistakes as: biodata mismatch, incorrect e-mail address, loss of registration SIM, wrong choice of institution/course, wrong UTME subjects combination, failure to send REQUERY command to pull updated information from the platform of the National Identification Management Commission (NIMC) after effecting changes to names, date of birth, State or Local Government of origin, etc., particularly by repeaters, among others.

"Some of these avoidable mistakes cannot be corrected after registration. That is why we have devoted time to ask you to be attentive during registration. As such, you are urged to ensure that all necessary corrections are effected on the NIMC platform before generating your profile code with your National Identification Number (NIN),"he said.

In her contributions, the Board's State Public Relations Officer (PRO), Mrs. Grace Ojekwe, urged the participants to always consult the Integrated Brochure and Syllabus System (IBASS) so as to be informed of programme requirements, approved institutions and programmes before commencing their UTME registration.

The students, in their various comments, expressed gratitude to JAMB for the outreach and described it as timely and impactful.

The Council did not issue any such directive(s) nor restrict the choice of students to offer any particular subject(s) for WASSCE (SC) 2026 as alleged," the statement read. A staff member from the Exams and Records unit, currently under disciplinary review, was found in possession of 30 forged Statements of Result, along with fake official stamps, stamp pads, and admission letters.

The Rector, Professor Salisu Usman Ogbo, revealed that "All individuals involved will be handed over to the Police for diligent prosecution," while emphasizing the institution's zero-tolerance policy on academic fraud. He assured the public and stakeholders that the Polytechnic's quality assurance and security measures remain uncompromised. to implement the policy decisions reached by stakeholders at the just-concluded 2025 UTME Policy Meeting on Admission in Abuja. He added that the training would equip them to uphold integrity, navigate CAPS effectively and ensure that every candidate is treated justly in order to safeguard the reputation of their chosen institutions and sustain the trust of the public in the admission process.

He commended the Prof. Is-haq Oloyede's led administration for investing in merit and institutional excellence by awarding a total of 710 million naira via the National Tertiary Admissions Performance Merit (NATAP-M) Awards to six topperforming institutions at the 2025 Policy Meeting.

The VC said the annual NATAP-M Awards for transparency and compliance with the policies on admissions, commitment to inclusive education through the JAMB Equal Opportunity Group (JEOG) for candidates with disabilities and special needs, has come to stay.

Speaking further, he said that Babcock University is proud to partner with JAMB to nurture a tertiary institution system that is transparent, merit-driven, inclusive and ready to empower the next generation.

Earlier in her welcome address, the Director, JAMB Ibadan Zonal Office, Mrs. Temitope Catherine Akintola, expressed appreciation to the Vice Chancellor and Management of Babcock University for hosting the meeting.

According to her, the meeting themed: "Bridging The Gap Between Policy and Practice in Admissions" was a timely one as it reminds stakeholders of the shared mandate to place suitably-qualified candidates into tertiary institutions in Nigeria. She emphasized that the Central Admissions Processing System (CAPS), which was introduced in 2017 has integrity and transparency as its hallmark and is aimed at putting an end to the

problems of excessive bureaucracy and under-the-table admissions. She, therefore, submitted that no admission must be processed outside CAPS.

The Head, Matriculation Monitoring Unit, Mrs. Kafayat Ibiwoye, gave the participants a comprehensive presentation on 'Bridging the Gap Between Policy and Practice in Admissions. According to her, policy and practice must work hand-in-hand to ensure proper implementation.

Continuing, Mrs. Ibiwoye highlighted some of the gaps between policy and practice as follows: Admitting candidates without ensuring proper change of institution and/course; Inconsistency in the interpretation of policies; Failure to attend Policy Meetings; Sourcing candidates locally; Non-consideration for carrying capacity during admission process; Admitting candidates for unaccredited courses; Improper treatment of Transfer (Local and Foreign) students; Admitting students with wrong subject combinations, among others. She explained that these gaps are capable of creating problems for the students in future.

Mrs. Ibiwoye also explained that the gaps could be bridged by adhering to all the policies guiding the conduct of admissions, attending trainings and retraining of staff working with them, as well as correctly communicating policies as well implementing them appropriately. She stressed that Admission Officers must not compromise on the requirements of the 2025 admission process in addition to conducting all admissions on CAPS.

In his remarks, the Ogun State Coordinator, Mr. Hakeem AbdulHameed, reiterated that the meeting became necessary to foreground the policies arrived at by stakeholders during the 2025 Policy Meeting on Admission held in Abuja while clarifying some of the issues raised by participants.

The Ogun State Coordinator recalled that the admissible age of candidates into tertiary institutions in Nigeria remains 16 years and eligible candidates must have attained this age as of 30th September, 2025, even if the admission process of the institution closes by the end of December as is the case with some Polytechnics. He, therefore, encouraged the participants to always seek clarifications when in doubt.

In their individual responses, the Admission Officer of Olabisi Onabanjo University, Ogun State, Mr. Olufunmilade Olujimi, took the participants through a practical and step-by-step admission process on CAPS using the 2024 platform.

Also, the Admission Officer of Moshood Abiola Polytechnic, Abeokuta, Mr. Dauda Somoye, commended the State Coordinator for his foresight to convene the meeting. He said he, personally had learnt a lot and was better informed by the meeting. He urged coparticipants to train their subordinates well as information concealed could be dangerous to te growth of the system.

In his part, the Admission Officer, Federal University of Agriculture, Abeokuta, Mrs. Olufunmilola Sorinmade, said the second edition was a very inpactful one and expressed appreciation to the State Coordinator and his team for putting the programme together.

While giving the vote of thanks, the Head, SERVICOM/PR Unit of the Ogun State Office, Ms. Abiola Adekunle, also thanked Prof. Tayo and the Management of Babcock University for hosting the meeting. She equally thanked all the Admission Officers for attending the meeting and urged them to always adhere to the policies of the Board by making sure they walk the talk.

The meeting witnessed an excellent turnout of participants as a total of forty-four Admission Officers were in attendance.

### MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular.** 

- 2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
- 3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
- 4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
- 5. No candidate can use the process to change any of the data already supplied to the Board.
- 6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
- 7. Please be guided for compliance.

### **ADVISORY ON PROCEDURE FOR** PROCESSING OF (DEGREE) ADMISSION FOR AFFILIATED **INSTITUTIONS**

In 2022, the Board proposed that universities should take full responsibility for admissions into all degree programmes offered through institutions affiliated with them. However, this directive was not fully implemented, as universities were initially given the liberty to decide on the matter, pending a final resolution. To date, only the University of Ibadan has assumed this role of overseeing and coordinating the admissions of its affiliate institutions.

- Following the meeting held on Monday, 18th August 2025, with various institutions regarding violations of matriculation guidelines, concerns were raised about the existing admission processing structure. Notably, institutions complained that they could not be held accountable for the misdemeanors of their affiliates under the existing processing format. As a result of this, the matter was revisited.
- 3. Consequently, it was resolved that the previously proposed process, where Mother-Institutions take responsibility for admissions into their affiliated institutions, should now be adopted and implemented by all universities with affiliates.
- In light of the above, the Board has developed an updated procedure for the processing of admissions by both Mother-Institutions and their affiliates, as follows:
  - a. Head of the affiliated-institution logs into JAMB (CAPS) portal and downloads candidates for a particular programme;
  - b. The Head of the Affiliated-Institution (wherever it is based) logs into JAMB (CAPS) portal and sets admissions criteria for every programme, such as minimum scores for UTME, post UTME, aggregate, catchment and ELDS;
  - c. The Head of the affiliated institution proposes the qualified candidates for each programme on CAPS and it goes to the Head of the mother-institution;
  - d. The Head of the Mother-Institution (wherever it is based) logs into the JAMB (CAPS) portal and recommends the candidate to the Registrar of JAMB (or representative) for approval or declines the proposal with a reason for the rejection:
  - e. The Registrar of JAMB (or representative) approves the recommendation(s) from the Head of the Mother-Institution or declines the recommendation with a reason for the rejection;

- f. If the recommendation is approved, the candidate is notified through his/her email and SMS to either accept or reject the offer of admission. The two institutions can log in and view the status of the recommended candidates;
- g. If the candidate accepts the offer of admission, he/she can thereafter print his/her admission letter and access other services online from his/her profile.

**NOTE:** The Head of an Affiliated-Institution has access to "VIEW ONLY" all recommendations by the Head of a Mother-Institution.

5. All Universities serving as Mother-institutions, Polytechnics/Monotechnics, Colleges of Education and other institutes offering degrees in affiliation with universities are to be guided by this, please.

As part of proactive measures to safeguard the integrity of future examinations, the Board has resolved that for the 2026 UTME registration exercise, candidates from schools found to have engaged in registration runs or group registration will not be allowed to sit for the examination.

Candidates are therefore strongly advised to ensure that they register individually and personally at any of the Board's accredited Computer-Based Test (CBT) centres nationwide. This is to guarantee the integrity of their data and to ensure that their personal information is accurately captured in the Board's database.

The Board remains unwavering in its commitment to maintaining the credibility, transparency, and integrity of its examination processes and will continue to take decisive action against any institution or individual found undermining these standards.
