LIKE THE KEFFI DECLARATION, ETHIOPIA MINISTRY OF EDUCATION READS RIOT ACT ON HONOURARY DEGREES

Ethiopia has recently implemented a new directive from the Ministry of Education which prohibits individuals who have received honorary doctorates from using the title "Doctor" outside of the conferring institution. This

NWRI SOLICITS JAMB SUPPORT ON ENROLMENT

The Director-General of the National Water Resources Institute, Dr. Abdul Jalal Dan Baba, has solicited the support of the Joint Admissions and Matriculation Board (JAMB) towards boosting candidates' enrolment at the Institute.

The DG made the appeal when he paid a courtesy visit to the Registrar, Prof. Is-haq Oloyede, at the Board's National

Headquarters, Abuja, on 29th September, 2025

He pointed out that NWRI is a unique institution pursuing both academic and research mandates to train and retrain water engineers, technologists and technicians in the water resources sector. He said the Institute is charged with the responsibilities of providing training for stakeholders in diverse sectors of the economy especially in terms of short courses and formulating policies for the management of water resources in the country.

According to the DG, the Institute coordinates the activities of the 12 River Basin Development Authorities in the country as well as playing critical roles in the management of the National Water

JAMB, A PIVOTAL INSTITUTION IN NIGERIA EDUCATIONAL SECTOR - PSIN

The Public Service Institute of Nigeria (PSIN) has underscored the role of the Joint Admissions and Matriculation Board (JAMB) in the nation's manpower development architecture saying the Board remains a pivotal institution in Nigeria's educational sector.

The Administrator of the Institute, Barrister Ime Patience Okon, gave this assessment when she led top management staff of the agency on a courtesy visit to the JAMB National Headquarters on 29th September, 2025.

In her address, Barr. Okon pointed out that JAMB, under the leadership of Prof. Is-haq Oloyede, has set a benchmark for credibility, integrity, openness, inclusivity and transparency in the education sector through reforms and innovation that have improved assessment practices, reduced examination malpractice and restore sanity to the sector.

She particularly commended the automation of the admission process through the Board's Central Admissions Processing System (CAPS) noting that

Council meetings. He also intimated the Registrar of plans to boost the status of the Institute by having a robust website, partnering with the National Board for Technical Education (NBTE) on renewable energy and development of micro hydro power stations as well as sought NBTE accreditation for its new programmes. He said the introduction of new programme and consequent accreditation of same

informed his visit, adding that his visit also aims at soliciting the support of the Board towards boosting enrolment.

He listed such programmes as Science Lab Technology, Mechanical Engineering, Distance Learning programmes as obtainable in the Institute, which it runs in collaboration with the Federal Ministry of Science and Technology, Water Resources, which is the

Institute's parent ministry.

He also disclosed that the Institute's collaboration with the United Nations Educational, Scientific and Cultural Organisation (UNESCO) is aimed at creating awareness on climate change, global warming and the need for proper management of borehole drilling in the country as well as provide a roadmap for waterways development to give adequate warnings in case of imminent flooding, among other threats.

Dr. Danbaba also informed the Registrar of the desire of the Institute to have a functional Computer-Based Test centre for the use of its students and UTME candidates alike. Earlier, the Registrar had congratulated the DG on his appointment and the advocacy visit. He said water resources is one of the critical areas need for the development of not only Nigeria but also for all the nations of the world. He, therefore, enjoined the DG to identify the problems and expressed the willingness of JAMB to assist the Institute within its powers.

MANDATORY USE OF MICROSOFT CAMERA ON JAMB APPLICATION IN UTME REGISTRATION NOT NEGOTIABLE

As part of the buildup to the 2026 UTME registration and examination, the Gombe State Coordinator, Mr. Johnson Adebisi, on Tuesday, 30th September, 2025, paid a working visit to El-Lawanti ICT Centre, Commercial Area, Near Doma Hospital, Gombe.

According to the Coordinator, the purpose of his visit was to ascertain the level of compliance of the accredited CBT centre with its rules of engagement particularly, with regard to the mandatory use of Microsoft Camera on JAMB application registration, which deadline for adoption was 1st October, 2025.

Adebisi explained that the policy decision became imperative following the review of the conduct

of the 2025 UTME, where some CBT centres were reported to be involved in image blending of candidates with the intent of committing examination infractions such as impersonation, among others.

The Coordinator urged the Proprietor to take advantage of the window of opportunities provided by the Board to all accredited CBT centres to handle those services that were hitherto limited to the Board's Professional Registration Centres (PRCs) and Professional Testing Centres (PTCs). He stated further that C T centres should also take advantage of the impending patronage from other sister organisations such as the West African Examination Council (WAEC), National Examinations Council (NECO), and other agencies, who

have adopted CBT as their mode of examination.

Adebisi affirmed that the Board's deadline on the mandatory use of Microsoft camera for UTME registration is non-negotiable adding that, going forward, all other cameras would be disallowed on the system. He, therefore, advised the centre proprietor, Mr. Barde Usman Lawanti, to do the needful stressing that the Board will not hesitate to delist any defaulting centre from participating in its registration activities.

Continuing, he said, as a trusted partner, the Board asks for the full cooperation of the centre in ensuring the integrity of its registration processes bearing in mind that it is a shared responsibility.

No further student applications will be accepted after this date. The portal will reopen in the second week of October 2025 for fresh applications into the 2025/2026 academic session. Submission For NYSC Mobilisation:

The Federal Government has made it mandatory for graduates to submit their theses or final year projects into the Nigeria Education Repository and Databank (NERD) before they can be mobilised for the National Youth Service Corps (NYSC).

The policy, which takes effect from October 6, stipulates that no graduate, whether trained in Nigeria or abroad, will be mobilised for or exempted from the NYSC without proof of compliance.

The directive was contained in a circular issued by the Secretary to the Government of the Federation (SGF), Senator George Akume, who conveyed President Bola Tinubu's approval on Saturday.

The circular stated that the "NYSC mobilisation criteria [have been adjusted] in accordance with the President's regulation requiring proof of NERD Policy compliance for all prospective corps members, regardless of where they were educated..."

Obasanjo, Sultan, Kukah Call For Investment In Education: Former President Olusegun Obasanjo, the Sultan of Sokoto, Alhaji Muhammad Sa'ad Abubakar III, and the Catholic Bishop of Sokoto Diocese, Most Rev. Matthew Hassan Kukah, have converged in Sokoto with a common message: Nigeria must urgently invest in education, skills, and unity to avert future instability. The key to this, they suggest, lies in significant investment in education.

They spoke at the commissioning of the Bakhita ICT Centre, a facility equipped with 250 laptops and 50 digital tablets to provide training in ICT and vocational skills for young people, including children. Such facilities represent a tangible investment in education and vocational training.

President Obasanjo warned that Nigeria's 24 million out-of-school children constitute "a ticking time bomb" that could worsen insecurity if not urgently addressed. Prioritising

investment in education is essential to mitigate these risks..."

Ogun Govt Suspends School Principals Over Illegal Fees: The Ogun State Government has suspended the principals of Ilugun High School, both Junior and Senior schools, Mrs. Olukoga Adeyemi and Mrs. Ladipo Temitope, over illegal fees, which led to students' protests. Students of the school were seen in a video destroying school property.

According to an address by the State Commissioner for Education, Science and Technology, Professor Abayomi Arigbabu, the Ministry is conducting a preliminary investigation over the death of a yet-to-be-identified person whose death might have sparked the protest...

"We have all become aware of the incident that took place at Ilugun High School (Junior), Elegu. I stand before you this afternoon to confirm that the incident did happen in the school.

"Our preliminary investigations have revealed that the Principal of Ilugun High School (Junior) had been involved in the collection of illegal fees. In light of these findings, government has decided to place both the Junior and Senior Principals of Ilugun High School on suspension while we conduct an investigation into the causes of this incident."

TRIBUNE, WEDNESDAY, OCTOBER 1, 2025:

Akwa Ibom Govt Shuts Illegal Schools, Proprietors Face Prosecution: The Akwa Ibom State Government has intensified its crackdown on illegal private schools, sealing several unlicensed institutions across the state and ordering the arrest of defaulting proprietors who attempted to defy the directive.

The Commissioner for Education, Prof. Ubong Essien, who led the enforcement taskforce, disclosed that while many operators complied with the state's directive to shut down, some proprietors illegally

unsealed their premises and resumed academic activities.

Angered by the development, Prof. Essien ordered the arrest and detention of the offenders, who are now awaiting prosecution.

"During the ministry's regular monitoring exercise, it was observed that while several operators of unauthorized private schools had obeyed the directive, a few chose to defy the order and continued with academic activities," he said.

The Governor gave this assurance recently while receiving members of the Governing Board of the university, on a courtesy call at Government House, Birnin Kebbi. He said that the partnership on agriculture has become necessary to achieve food security in the state and the country at large.

"We all know that Kebbi State is an agricultural state, and this partnership will help us in achieving our set goals and objectives of national food security," he emphasised.

CAPS streamlines the entire admission value chain, addresses the challenges associated with the manual approach, restores the autonomy of tertiary institutions, eliminates multiple admissions, and provides easily-retrievable data for decision making and research, among other benefits.

Furthermore, she disclosed that millions of Nigerians have been able to access higher education and build careers across public and private sectors through the critical role JAMB plays as a clearing house for admissions into tertiary institutions in Nigeria.

Okon pointed out that the visit was

to strengthen institutional harmony and foster strategic partnership that would be of mutual benefit to the two organisations. She informed the Registrar about the immense opportunities provided by the Institute's SMART-P programme through which staff of the Board could enhance their digital, communication and leadership skills, natural values, ethics, and integrity. Against this backdrop, she made a case for the assessment of the Institute's Computer-Based Test centre and invited the Board to conduct a physical audit of its facilities with a view to accrediting

MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.

ADVISORY ON PROCEDURE FOR PROCESSING OF (DEGREE) ADMISSION FOR AFFILIATED INSTITUTIONS

In 2022, the Board proposed that universities should take full responsibility for admissions into all degree programmes offered through institutions affiliated with them. However, this directive was not fully implemented, as universities were initially given the liberty to decide on the matter, pending a final resolution. To date, only the University of Ibadan has assumed this role of overseeing and coordinating the admissions of its affiliate institutions.

2. Following the meeting held on Monday, 18th August 2025, with various institutions regarding violations of matriculation guidelines, concerns were raised about the existing admission processing structure. Notably, institutions complained that they could not be held accountable for the misdemeanors of their affiliates under the existing processing format. As a result of this, the matter was revisited.

3. Consequently, it was resolved that the previously proposed process, where Mother-Institutions take responsibility for admissions into their affiliated institutions, should now be adopted and implemented by all universities with affiliates.

4. In light of the above, the Board has developed an updated procedure for the processing of admissions by both Mother-Institutions and their affiliates, as follows:

- a. Head of the affiliated-institution logs into JAMB (CAPS) portal and downloads candidates for a particular programme;
- b. The Head of the Affiliated-Institution (wherever it is based) logs into JAMB (CAPS) portal and sets admissions criteria for every programme, such as minimum scores for UTME, post UTME, aggregate, catchment and ELDS;
- c. The Head of the affiliated institution proposes the qualified candidates for each programme on CAPS and it goes to the Head of the mother-institution;
- d. The Head of the Mother-Institution (wherever it is based) logs into the JAMB (CAPS) portal and recommends the candidate to the Registrar of JAMB (or representative) for approval or declines the proposal with a reason for the rejection;
- e. The Registrar of JAMB (or representative) approves the recommendation(s) from the Head of the Mother-Institution or declines the recommendation with a reason for the rejection;

- f. If the recommendation is approved, the candidate is notified through his/her email and SMS to either accept or reject the offer of admission. The two institutions can log in and view the status of the recommended candidates;
- g. If the candidate accepts the offer of admission, he/she can thereafter print his/her admission letter and access other services online from his/her profile.

NOTE: The Head of an Affiliated-Institution has access to “VIEW ONLY” all recommendations by the Head of a Mother-Institution.

5. All Universities serving as Mother-institutions, Polytechnics/Monotechnics, Colleges of Education and other institutes offering degrees in affiliation with universities are to be guided by this, please.

GUIDELINES ON THE AWARD OF HONORARY DEGREES AND ACADEMIC TRADITION IN NIGERIAN UNIVERSITIES

1.0. INTRODUCTION

At the 27th Conference of the Association of Vice Chancellors of Nigerian Universities (AVCNU) held at Nasarawa State University, Keffi, and in the examination of the general erosion of academic culture/tradition with particular reference to the indiscriminate award of honorary degrees in our universities, AVCNU made a declaration (henceforth THE KEFFI DECLARATION) that the age-long, best practices of university culture be restored and maintained as herein set forth.

honorary degrees shall not be tied to wealth consideration or political alignment but rather, it should be based on leadership and service vis-a-vis the contribution of the intended recipients to socio-economic development of the society. Some of the other criteria that could be considered in choosing recipients for the award of any honorary degree shall include:

2.0 CONDITIONS AND PROCEDURE FOR AWARD OF HONORARY DEGREES

- a) AVCNU member-Universities hereby make it a policy not to honour with honorary degree anybody holding political office (elected or appointed) while such officers are still in service;
- b) The procedure for the selection of honorary degree recipients shall be in accordance with the law and statute of the respective Universities, and in line with best practices, and the selection process shall normally be through the appropriate Committee of Senate of the University;
- c) The Honorary Degree award shall normally be given to any professional who has made significant or ground breaking discoveries/accomplishments/invention/ innovation etc to societal development in any field of human endeavour, i.e. Humanities, Science or Technology. The award of

- i. Reputation as a leading and reputable scholar;
- ii. Associated with important discoveries/accomplishment /innovation etc;
- iii. Being an inventor, an artist, a musician or a social activist of great repute;
- iv. Being a successful entrepreneur, who has contributed immensely to development of the University;
- v. Being a leader of political organization that has impacted positively on the lives of people, subject to (2a) above;
- vi. One who has rendered outstanding life-long service to the University, the community or the nation at large, etc;
- vii. Men and women of integrity, undisputed role models, in the society.

- d) The maximum number of recipients of honorary degrees at any convocation ceremony shall not exceed THREE, and this may be in one out of several convocations;
- e) A University shall not award honorary degrees if it has not graduated any Ph.D or has no Post-graduate school or programme;
- f) Award of Honorary degree can be Posthumous, but no Honorary Degree shall be awarded in absentia to a surrogate;
- g) Award of Honorary degree to the Chancellor of one's University particularly before Convocation is not compulsory, but shall be without prejudice to her statutes and 2(a) above;
- h) Installation of a Chancellor can be done on a special day or a day preceding convocation. It depends on the decision of the Senate of the University concerned;
- i) The use of 'Dr' as a title for honorary degree graduands/awardees is unconventional and therefore, not allowed. This shall be strictly observed in all academic documents and publications.

3.0 CONDUCT OF CONVOCATION

Convocation is an annual formal assembly of the University for a Graduation Ceremony for its students. It is a cardinal statutory event which provides the University an opportunity to showcase its graduands and give account of how the institution has fared to its stakeholders. It is normally presided over by the Chancellor, with the Chairman and members of the

Governing Council or Board of Trustees/Regents present. The Visitor or proprietor of the institution usually attends in person or is represented. Convocation shall evoke decorum, solemnity and grandeur.

Therefore:

- a) As a matter of policy, Universities shall hold their Convocation ceremonies annually, preferably on their Foundation day and, as much as possible, within the same month each year;
- b) Convocation shall be a timely and solemn event (needs to start on time and strictly observe the timeline of programmes or activities)
- c) Certificates must be ready at convocation and issued to students after necessary clearance;
- d) Before the procession starts, there could be light music to be supplied by the University choir, the Police band or through stereo sound system.
- e) While guests are seated, officiating personnel (as authorized by the Vice Chancellor or Registrar) can use the period before the commencement of procession to recognize dignitaries and make announcements, but no more. After the procession, the Registrar takes over the order of proceedings and announcements, if any.
- f) The norm about procession requires that people should not robe or de-robe in public except when such a person is being dressed publicly for honours. Furthermore, guests are not allowed to cross or interrupt a procession.

- g) **Persons who are not robed should not normally be part of a convocation procession.**

- h) With respect to Order of Procession: the procession shall move to the Convocation Arena in the following order (while processional music is played) and the assembly shall stand as the Congregation's procession enters the Arena:

(All graduands must be seated before the academic procession commences and shall remain at their seats throughout the ceremony)

- i) As soon as the Visitor gets to the front of his seat at the Dais, the National Anthem will be sounded. Thereafter, the Visitor takes his seat followed by the Assembly.

- j) At the Convocation Ground:

The Faculty colours should be placed in front of the graduands for easy identification of the various faculties.

In the academic procession, the mace, which is the symbol of authority, is usually carried by a designated mace bearer. After the sounding of the National Anthem, it is then positioned on a platform in front of the Chancellor.

The sitting arrangement at the

Convocation ground should be such that gives prominence and prime recognition to members of Senate, Deans, members of Council, State dignitaries from the education sector including Visiting Vice-Chancellors, as well as parents, guardians and the press. The sanctity of designated seats shall be strictly maintained by ceremonial officials.

Pre-Convocation rehearsal is very necessary and Vice-Chancellors must ensure that it is done before the Convocation proper so that observed lapses could be addressed.

- k) In the Procession, the following should obtain:
 - Academic ceremonies must always begin and end with a procession.
 - Academic processions are always formed in ranks of two
 - Processions are divided into divisions according to affinity groups. Each division should be separated by a gap of about 20 feet, enough space to keep marchers from bunching up as people move into their seating rows. The gap is also to ensure a better view of the marchers' regalia
 - Only those people specified in the order should be in the procession, if robed.
 - Where for example, Council members want to be part of the procession, they could only wear the gown but without the hood unless they are also qualified to wear the hood by holding appropriate degrees.

4.0 MATRICULATION CEREMONY

This is a statutory ceremony where new students are inducted into the university. The ceremony comes early after

orientation programme, usually within two to four weeks of freshers' arrival on campus.

Consequently:

- a) Matriculation ceremony shall normally be held not later than the fourth week of students arrival on campus;
- b) There shall be no further admission and registration of students after matriculation;
- c) Matriculation shall be given the seriousness it deserves as all academic ceremonies with Principal Officers and members of Senate actively participating;

5.0 SENATE

Senate is the highest body on academic matters of a university. Many of the University Committees report to Senate, and through the Committee structure, Senate regulates the academic activities of the University.

Therefore:

- a) In terms of regularity, Senate meetings shall hold as scheduled in the university statutes, which means other relevant committees such as Faculty Boards shall meet ahead of Senate meetings to submit matters for Senate consideration;
- b) All statutory meetings of Senate shall also be held as scheduled;
- c) A university's basic governance system is the Committee System which is self regulatory. Consequently, the various committees shall be allowed to function effectively;
- d) In Senate, and indeed in the University, robust debate and effective participation shall be encouraged to ensure quality decisions;

6.0 COUNCIL MEETINGS

Council is the highest policy making body in the university governance structure and superintends over the Assets (estate, property and finances) of the university.

It is **RECOMMENDED** that:

- Statutory meetings of Council shall be held on a regular basis as specified in the university statute;
- Council shall adhere to its functions and not override Senate decisions on academic matters; and
- A clear distinction between policy matters and day-to-day management of the university shall be recognized and respected for good governance.

7.0 CONGREGATION

Congregation meetings provide opportunity for a large proportion of staff to be briefed on university matters and enable them to participate in the governance of the university.

Therefore:

- a) There shall be regular meetings of the Congregation, as specified in the statutes or at least once per semester;
- b) Congregation meetings shall be given adequate publicity and members encouraged to attend;
- c) Freedom of expression and robust debates and contributions shall be encouraged and constructive criticism permitted.

8.0 INAUGURAL, PUBLIC AND VALEDICTORY LECTURES

By the University tradition, it is the inaugural lecture that inaugurates a person's chair as Professor and this is usually held

within one or two years after the date of appointment, promotion and announcement. This cherished academic tradition has been neglected or is done on irregular basis in many universities, to the extent that some professors retire without giving their inaugurals. Also, public lectures in the university allow scholars and people from various walks of life who have distinguished themselves in their different callings to speak on contemporary issues. This culture is gradually being neglected to the extent that in many universities the tradition of public lectures has almost been forgotten.

Valedictory lecture is the academic tradition where a retiring Professor or Emeritus Professor delivers a farewell address or oration in a valedictory ceremony. In many universities, this is no longer done. The culture of Emeritus Professorship appointment has also been neglected or being improperly done.

Therefore:

Universities should restore and observe these cherished age-long academic traditions and practices.

8.1. Inaugural and Public Lectures

- i. The University authority shall programme inaugural and public lectures into the university calendar in such a way that within 2 or 3 years of being given a Chair/becoming a Professor, every Professor must deliver his/her inaugural lecture.
- ii. Efforts shall be made to clear the backlog and since the programme is basically academic, it should be undertaken regularly so as to

continuously enliven the academic community.

- iii. Senate shall regularly approve the schedule of inaugural and public lectures in accordance with the established Calendar, and relevant committees enabled to ensure compliance.

8.2 Valedictory Lectures and Emeritus Professorship

- i. Valedictory lecture can be delivered by Retiring and Emeritus Professors. However, such a person must still be seen to be professing even at that old age.
- ii. Nomination of candidates for the conferment of Emeritus Professorship usually starts from the Department. A senior professor may nominally initiate the process which gets through the Faculty to the Senate and then to Council for final approval.
- iii. In some cases, the University may on its own recognize the academic contributions of some senior professors who have retired from service for the conferment of Emeritus Professorship subject to laid down guidelines.
- iv. Emeritus Professors can be provided with official accommodation / house whenever on campus, and be remunerated on the basis of the work they do, including the mentoring of younger academics. Senate must establish proper guidelines for this.

9.00 GENERAL ISSUES OF ACADEMIC ETHICS AND DECORUM

- i. Universities shall all have code of conduct to be embedded in the condition of service for all members of teaching and non staff. Such a code shall address issues such as research, examination, dressing, sexual harassment, cultism and social vices, etc;
- ii. The code of conduct shall address all anti-social habits with appropriate sanctions.
- iii. The issue of extortion and 'sorting' of all kinds shall be addressed and appropriately sanctioned by university authorities.
- iv. Universities shall adhere strictly to their statutes and regulations on all matters, reward excellence and enforce discipline.

9.1 Examinations

- i. Universities shall adhere strictly to examination time-line
- ii. Continuous assessments shall be submitted before the commencement of examinations. Deans and Heads of departments shall ensure that all continuous assessment records are submitted and deposited with them before the commencement of examinations.
- iii. There shall be strict adherence to examination time table and examination regulations
- iv. An external examiner shall not only ensure a proper vetting of

- the examination questions in order to maintain standards, he/she shall write a report after reviewing the answer scripts.
- v. The departments shall not overload young lecturers with sensitive academic matters in order to prevent abuse
- vi. Universities shall determinedly address the problem of 'sorting' and examination leakages and culprits shall be appropriately sanctioned.
- vi. The mentor-mentee relationship between the old and the young academics shall be revived and strengthened. The younger academics shall sufficiently demonstrate their attitudinal and psychological preparedness to be mentored;
- vii. Universities shall encourage departments to establish research forum where young and old researchers can interact.

9.2 Research matters and Mentorship

- i. The issue of widespread plagiarism need be addressed by the university system.
- ii. All efforts shall be made to authenticate the originality of academic publications for the sake of credibility of the University;
- iii. Universities shall make funds available for research and research shall be made to attract more scores for promotion purposes;
- iv. Scholars with multi authorship shall indicate their specific contributions in the publications;
- v. People appointed to Professorial chairs are required to demonstrate competence through mentoring;

10.0 IMPLEMENTATION AND ENFORCEMENT

AVCNU and the National Universities Commission (NUC) shall act as 'whistleblowers' and shall take appropriate actions to ensure compliance with these guidelines.

Furthermore, all Vice Chancellors, as signatories to the Declaration, commit to strict adherence to the guidelines, and whenever occasions demand, to boycott convocation ceremonies of universities that flagrantly flout the guidelines on award of honorary degrees.

Endorsed by Vice Chancellors of Nigerian Universities, this 24th day of September 2012.
