

he 292nd inaugural lecture of the University of Ilorin has come and gone but what perhaps will remain indelible in the annals of the "better by far" institution is the legacy of the Registrar, Joint Admissions and Matriculation Board (JAMB), who was felicitated for his uncommon skill for discovering and mentoring promising students.

This was brought to the fore on Thursday,

6th November, 2025, during an

intellectually-charged discourse on environmental contamination by Professor Hussein Kehinde Okoro, a distinguished scholar and Head of Department of Industrial Chemistry, University of Ilorin, through his Inaugural Lecture titled: "Leveraging the Expertise of Chemists in Environmental Management: A Focus on Analytical,

embers of the JAMB Investment and Credit Cooperative Society (JICCS) have commended the President, Mr. Caleb Musa, for his visionary leadership and remarkable achievements in repositioning the Society as a profitmaking enterprise.

The commendation came from members across the Board's offices nationwide, who praised Mr. Musa for his prudent

management of resources and bold investment initiatives, despite the current economic challenges that have reduced membership and contributions.

Speaking to JAMBulletin on the sidelines of the commissioning of the Society's new sachet water factory, members described Mr. Musa's tenure as a turning point in JICCS's over two-decade history. They noted that, for the first time, the

Environmental, and Material Fields." The event, which was held at the Senate Building, University of Ilorin, drew an impressive audience comprising academics, students, traditional rulers, professionals, as well as friends and family members of the don.

Prof. Okoro, in his tributes to individuals, who have contributed to his career, acknowledged the role of Prof. Olovede in his academic odvssev as he recalled his constant refrain to him not to rest on his laurels but to strive for higher honours. He also commended the Registrar for his commitment to the development of the University when he was the Vice-Chancellor and as the Registrar, JAMB. He added that the University is proud to be associated with a scholar of Professor Olovede' repute on account of his landmark initiatives, which have continued to shape the field of large-scale assessment in Nigeria and beyond.

In his intellectual-stimulating lecture, Prof. Okoro explored the great role being played by Chemists in the fields of analytical, environmental and materials fields especially in terms of managing organic and inorganic contaminants in selected water bodies in Nigeria and South Africa through the evaluation of their levels of polycyclic aromatic hydrocarbons (PAHs) and the impact of these chemicals on human health. He also traced the release of other potentially toxic elements (PTEs) to the increased urban and industrial development in recent years. He submitted that these PTEs, which comprises Arsenic, Cromium, Cadmium, Nickel and Lead, amona others, have their sources in industrial effluents while highlighting the carcinogenic effects of these

In addition, Prof. Okoro noted that the discharge of domestic and industrial waste coupled with inflow of pesticide and fertiliser residues into water bodies had contributed to the high levels of phenols, thereby demonstrating the interconnection between environmental pollution and human health. He, therefore, advocated the construction of wastewater treatment plants to ensure the safety and and health of Nigerians, among others.

Earlier, in his opening remarks, the Vice-Chancellor, University of Ilorin, Prof Wahab Egbewole (SAN), had paid glowing tributes to Professor Okoro on account of his sterling contributions to academia, research, and mentorship.

The occasion served to underscore as well as showcase the contributions of Prof. Oloyede to both manpower and material development of the nation's education sector.

The Permanent Secretary of the Federal Ministry of Education, Mr. Abel Enitan, made the call at the 69th National Council on Education meeting held in Akure, the Ondo State capital, on Monday. The event was themed "Quality Education Data and Professionalisation of Teaching: A Tool for Enhanced National Development."

Mr. Enitan emphasized that teaching is not just a vocation but a noble profession that shaped the destiny of nations, deserving collective responsibility to improve it.

He said, "Our collective responsibility is to ensure that teachers are well-prepared, well-supported, and well-rewarded..."

PUNCH, MONDAY, NOVEMBER 3, 2025: Nigeria-Korea Institute Gets NBTE Accreditation, Records 500% Rise In Enrolment: The Nigeria-Korea Friendship Institute of Vocational and Advanced Technology in Lokoja, Kogi State has secured full accreditation for all its programmes from the National Board for Technical Education. The Rector of the Institute, Prof. Charles Williams,

made this known recently in Lokoja.

He said the accredited courses include Automotive Mechatronics, Welding and Fabrication, Electrical/Electronic Technology, and Computer Software Engineering. The institute, he said, has also recorded an impressive 500 per cent increase in student enrolment within three years.

"The NKFI recorded a 500 per cent increase in students' enrolment, from 40 students in September 2022 when I assumed office to over 900 in September 2025..."

BLUEPRINT, MONDAY, NOVEMBER 3, 2025: <u>UTME 2025</u>: <u>JAMB Extends Admissions Timeline For Public Universities</u>: The Joint Admissions and Matriculation Board (JAMB) has extended the deadline given to Nigerian federal universities to conclude the admissions process for the 2025/2026 academic year.

In a statement by its spokesperson, Dr. Fabian Benjamin, JAMB said the extension followed appeals by the Association of Vice Chancellors of Nigerian Universities (AVCNU) and the introduction of 229 new academic programmes by the National Universities Commission (NUC) on 29 October. "Admissions into those programmes are just being scheduled," JAMB said.

Earlier this year, stakeholders at the JAMB policy meeting, which featured the heads of all tertiary

institutions in the country, had agreed to certain timelines for institutions to conclude admission processes. At the meeting held on 18 July, federal universities were asked to conclude admissions deadlines by 31 October and 30 November for private universities... 2025: JAMB Warns Admission Seekers Against Institutional Backdoor' Change of Programmes: The Joint Admissions and Matriculation Board (JAMB) has issued a stern warning to admission seekers across Nigeria against falling for institutional schemes promoting unauthorized change of programmes, describing the act as a manipulative and unethical practice aimed at undermining transparency in the nation's admission process.

In a statement released on Tuesday by JAMB's Spokesman, Dr. Fabian Benjamin, the examination body cautioned that some institutions have resorted to influencing candidates to alter their academic programmes outside the official Central Admissions Processing System (CAPS), the only platform legally recognized for processing tertiary admissions in Nigeria.

According to JAMB, "The unethical practice is designed to create room for the institutions' preferred candidates to move up in the admission ranking order," the statement read..."

OKAYNEWS, TUESDAY, NOVEMBER 4, 2025: Tertiary Institutions to Access TETFUND ICT Intervention after Data Submission – FG: The Federal Government of Nigeria has launched the Tertiary Institution Governance and Transparency Platform (FTIGTP) to enhance accountability, efficiency, and transparency across the country's higher education system.

Minister of Education, Dr. Tunji Alausa, unveiled the platform on Tuesday in Abuja, describing it as a central database that will provide real-time information on the financial and operational activities of all tertiary institutions.

He said the FTIGTP will serve as a single, nationwide source of accurate data on student enrolment, government funding (capital, recurrent, and personnel), local and international research

The minister said, "We will now work to set up a technical working group to begin to draft the MoU with you, and we will feed these students in our technical school to the pathway. We will do it in such a way that you will also come in for the assessment of these students while they are in school and even the ones we have trained."

"The ones that your chamber deems fit to travel, we will follow through the processes that we will put in place up to getting training visa from the German embassy," he said.

Furthermore, the Academy took note of the various responsibilities that had been entrusted to the Registrar ranging from his being a former Vice Chancellor, University of Ilorin; former President, Association of African Universities (AAU); and former Chairman, Committee of Vice Chancellors/Association of Vice Chancellors of Nigerian Universities (CVC/AVCNU). "He is also Secretary-General of the Nigerian Supreme Council of Islamic Affairs (NSCIA)."

Earlier, the Academy had called for the declaration of a state of emergency in Nigeria's education sector, warning that continued neglect of the system would stall national progress.

According to the President of the Academy, Professor Kabiru Isyaku: "NAE believes that Nigeria can achieve significant development if the right attention and funding could be given to the education sector."

The President also commended the students loan scheme, and advocated major reforms such as the National Teacher Education Policy (NTEP) and the professionalisation of teaching, proliferation of tertiary institutions, among others.



### MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular.** 

- 2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
- 3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
- 4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
- 5. No candidate can use the process to change any of the data already supplied to the Board.
- 6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
- 7. Please be guided for compliance.

### **NEXT OF KIN: WHAT IT MEANS AND WHY IT MATTERS**

"It is not the length of life, but the depth (of responsibility) that defines our legacy."-**Ralph Waldo Emerson** 

In the Nigerian Civil Service, the term, 'Next of Kin' (NOK) appears on almost every official form - ranging from records of employment to pension documents. Hence, many officers often misconstrue it for inheritance rights, thinking it automatically confers legal authority on the person whose name has been appended as the Next of Kin by the officer.

It is pertinent to stress that Next of Kin is not synonymous in any guise to beneficiary. Therefore, in today's edition, clarification, administrative and legal implications of the term shall be observed, while every officer is enjoined to take cognizance of and treat it with utmost seriousness.

Also, it is utmost important that members of staff of the Board regularly update their NOK details, especially, after passing through major life events like marriage, divorce, relocation, or bereavement. **Understanding the Concept of Next of Kin** 

A *Next of Kin* is the person (usually a relative-spouse, child or parent) designated to be contacted or act on the behalf of another person in emergency situations, particularly, during serious illness or death.

Simply put, Next of Kin is an officer's official contact person, not necessarily an heir or beneficiary.

Within the civil service, this information enables the organization to promptly reach family members and facilitate appropriate administrative actions on an officer in critical situations.

### The Legal Reality: Next of Kin Is Not Automatically a Beneficiary

One common misconception is that the *Next of Kin* automatically inherits the property, entitlements, or benefits of a deceased officer.

In truth, under Nigerian law- whether statutory, customary, or Islamic, inheritance is determined by specific legal and religious frameworks, not by NOK designation.

A *Next of Kin* serves as a bridge between the organization and the officer's family, not as the rightful claimant of benefits (in case of death). Recognizing this distinction prevents avoidable conflicts and delays in the release of death benefits, pension, or gratuity of a severed officer.

### Why NOK Matters in the Civil Service

### Choosing the Right Next of Kin

Selecting a Next of Kin should be a thoughtful process. The selected individual should be:

- a. Trustworthy someone who can act in the best interest of the officer;
- b. Available and reachable especially in emergencies;
- c. **Responsible** capable of communicating effectively with the organization or relevant authorities.

### Going Beyond the Form: The Importance of a Will

While the Next of Kin serves as an administrative contact, only a Will can clearly define how your assets, benefits, and entitlements are to be shared.

Preparing a Will eliminates confusion, minimizes family disputes, and ensures that your wishes are respected after your demise. Every officer is encouraged to consider this act of foresight and responsibility.

The Next of Kin field in your file is not just a bureaucratic requirement, it represents a critical link between you, your family, and the organization.

Understanding its true purpose ensures smoother administrative processes, protects loved ones, and upholds your legacy of responsibility and orderliness.

Take a moment today to review your records and ask: Is my Next of Kin still the right person? Because in matters of life, service, and legacy, it truly matters.

### ADVISORY ON PROCEDURE FOR PROCESSING OF (DEGREE) ADMISSION FOR AFFILIATED INSTITUTIONS

In 2022, the Board proposed that universities should take full responsibility for admissions into all degree programmes offered through institutions affiliated with them. However, this directive was not fully implemented, as universities were initially given the liberty to decide on the matter, pending a final resolution. To date, only the University of Ibadan has assumed this role of overseeing and coordinating the admissions of its affiliate institutions.

- 2. Following the meeting held on Monday, 18th August 2025, with various institutions regarding violations of matriculation guidelines, concerns were raised about the existing admission processing structure. Notably, institutions complained that they could not be held accountable for the misdemeanors of their affiliates under the existing processing format. As a result of this, the matter was revisited.
- 3. Consequently, it was resolved that the previously proposed process, where Mother-Institutions take responsibility for admissions into their affiliated institutions, should now be adopted and implemented by all universities with affiliates.
- 4. In light of the above, the Board has developed an updated procedure for the processing of admissions by both Mother-Institutions and their affiliates, as follows:
  - a. Head of the affiliated-institution logs into JAMB (CAPS) portal and downloads candidates for a particular programme;
  - b. The Head of the Affiliated-Institution (wherever it is based) logs into JAMB (CAPS) portal and sets admissions criteria for every programme, such as minimum scores for UTME, post UTME, aggregate, catchment and ELDS;
  - c. The Head of the affiliated institution proposes the qualified candidates for each programme on CAPS and it goes to the Head of the mother-institution;
  - d. The Head of the Mother-Institution (wherever it is based) logs into the JAMB (CAPS) portal and recommends the candidate to the Registrar of JAMB (or representative) for approval or declines the proposal with a reason for the rejection;
  - e. The Registrar of JAMB (or representative) approves the recommendation(s) from the Head of the Mother-Institution or declines the recommendation with a reason for the rejection;

- f. If the recommendation is approved, the candidate is notified through his/her email and SMS to either accept or reject the offer of admission. The two institutions can log in and view the status of the recommended candidates;
- g. If the candidate accepts the offer of admission, he/she can thereafter print his/her admission letter and access other services online from his/her profile.

**NOTE:** The Head of an Affiliated-Institution has access to "VIEW ONLY" all recommendations by the Head of a Mother-Institution.

5. All Universities serving as Mother-institutions, Polytechnics/Monotechnics, Colleges of Education and other institutes offering degrees in affiliation with universities are to be guided by this, please.

### ...JICCS Holds OGM

He added that the deduction is not only affecting JAMB alone but other MDAs nationwide and pleaded for their understanding while the issue is being resolved.

While speaking on the various loan requests, he said a lot of staff are on the queue and they keep asking why the long wait for the emergency, short and long-term loans they had requested. He said the long wait is as a result of the huge number of members applying for loan almost on a daily basis, which according to him is as a result of the biting economic situations in the country. He, therefore, urged staff applying for loans to make use of the loan portal on the JICCS App to apply because it is based on "first come, first served" basis while the Loan Committee will handle the rest.

Speaking further on deductions, he said some members are in the habit of asking him and the secretariat to stay actions on deductions immediately on their salaries for reasons best known to them. But the President argued that if the Society stays action on the deductions how would it meet the outstanding requests on the loan queue!

Mr. Maigari also talked on the issue of beneficiaries and their guarantors, he said the rate at which loan beneficiaries are defaulting is alarming. He said, some staff on different loan schemes such as the Ojerinde Estate and long-term loan still want to go for emergency loan at the same time! He lamented that the trend is putting a lot of guarantors at risk and urged them to be wary of guaranteeing members on more than two types of loans.

The President also raised alarm at the increasing numbers of loan beneficiaries disappearing (Japa) to another country as a great source of concern. He said he had sought the intervention of the management to bring the trend under control.

With respect to the issue of home appliances, Mr. Maigari said a lot of members had approached him demanding why he had refused to include Home Appliances in the Society's programme for the year. He said the issue bordered on finance adding that the only available option to accommodate home appliances was to step down issuance of all categories of loans for 3 to 4 months so as to gather enough money to get those appliances or a soft emergency loan may be initiated for members to collect and sort themselves out on home appliances, a process that still needs to go through the queueing process.

As there was no unanimous opinion on the matter, the issue was stepped down for the year.

Mr. Maigari, thereafter, called for the inauguration of the Electoral Committee (ELCO) as the tenure of the present JICCS executives is gradually coming to an end. He read out the names of the eleven nominated members as follows:

Abbah M. Abubakar, Abah Christopher, Munirat Adamu, Barr. Chidinma, Abu Mohammed, David Kuduru Shagi, Yinka Kayode, Samson Omaye, Ebenezer Ayelabola, Justina Bature and Hassan Mohammed.

Afterwards, the 11 nominees were presented to members for approval and they, in turn, selected Mr. Abbah Abubakar as their Chairman.

In conclusion, the President disclosed that going forward, members would start enjoying fat dividend as the Society had commissioned its sachet water venture, which had since opened its doors for business. He, therefore, solicited patronage from members and friends of the Society. He also enjoined members not to forget the Society's Laundry Services, Bwari, as patronizing it will go a long way towards boosting the dividend paid to members.
