science, innovation, and promote best practices in education and research, among other noble objectives.

Presenting the excellence award at the 16th Quadrennial General Conference held at the University Mohammed VI Polytechnique in Rabat, Morocco, on 21st July, 2025, the organisation stated that Prof Oloyede was honoured because of the significant roles he played in driving higher education in Africa.

NELFUND Decries 900% Hike In School Fees: Nigerian Education Loan Fund (NELFUND) has raised concerns that 10 tertiary institutions have hiked their institutional fees by 900 per cent for the current academic session.

Particularly, the agency raised the alarm that the institutions increased tuition fees from N200,000 to N2 million. The Executive Director, Operations, at the Fund, Mr. Mustapha Iyal, stated this during the agency's media engagement in Abuja recently. Government-backed educational loans

In a statement in Abuja, recently, signed by the Director Press, Federal Ministry of Education, Mrs. Folasade Boriowo, she said the ministry had not received any official communication or report from WAEC, NECO, or any examination body regarding widespread malpractice in either of the examinations.

She urged students, parents, school administrators and the general public to disregard the fake press release currently in circulation, directing them to official websites for verification, including: www.waecnigeria.org and www.neco.gov.ng.

Mrs. Boriowo said, "The public is advised to seek information only from verified and credible sources, including the official website of the Federal Ministry of Education: www.education.gov.ng." N250b SUBEB Fund Unutilised By 36 States, FCT – UBEC:-

The Executive Secretary of the Universal Basic Education Commission, Dr. Aisha Garba, has revealed that the sum of N250 billion in the coffers of the State Universal Basic Education Boards of the 36 states and the Federal Capital Territory (FCT) has not been utilised.

Dr. Garba revealed this during the inauguration of a three-day financial management training for fund managers from the State Universal Basic Education Boards across all 36 states and the Federal Capital Territory on Monday.

She expressed concern over some state government not effectively utilising SUBEB funds to enhance infrastructure and improve the conditions for teaching and learning in schools nationwide.

"...slow access of UBE Matching Grant, slow utilisation of the fund, non-compliance with the fund utilisation guidelines, diversion of fund, non-deduction and remittance of taxes, non-compliance with the due process in the award of contracts for the execution of basic education projects as well as non-adherence to the approved Action Plan, to mention a few are the identified lapses

LEADERSHIP, TUESDAY, JULY 23, 2025: Federal Gov't To Deploy CBT Centres For School-based SSCE: Federal Government of Nigeria has revealed that privately-owned Computer-based Test (CBT) centres and others belonging to public institutions will be deployed next year for the school-based Senior School Certificate Examination (SSCE).

The Minister of Education Dr. Maruf Tunji Alausa stated this after monitoring a pilot CBSSCE conducted by the National Examinations Council (NECO) at Sascon International School, Maitama, in Abuja yesterday.

Dr. Alausa, who hailed NECO for the seamless conduct of the pilot phase of the CBSSCE, said future school-based SSCEs would be moved to designated CBT centres rather than held within schools.

He said: "WAEC and NECO exams are school-based exams being conducted at their schools. No, we will move away from that. It will be like (the way) JAMB examinations are being conducted at CBT centres. We have thousands of CBT centres across the nation..."

NATION, TUESDAY, JULY 22, 2025: 1.3m Students Sit NECO's SSCE- About 1,367,210 candidates are presently sitting the 2025 Senior School Certificate Examination conducted by the National Examinations Council (NECO) across the country using dual mode of Computer-Based Testing (CBT) and Paper Pencil Testing (PPT). Of the 1,367,210 candidates, 685,551 are male while over 681,300 are female.

NECO Registrar, Prof. Ibrahim Wushishi, disclosed this during the monitoring of the conduct of the examination at a pilot CBT centre, SASCON International School,

Maitama, Abuja in the company of the Minister of Education, Dr. Tunji Alausa.

The examination marks the first time NECO is exploring the use of CBT to conduct the O-level examination in select centres in Nigeria. Asked to explain how feasible it would be to deploy CBT to conduct the examination at the post-basic level, Prof. Wushishi said, "NECO is ready as a professional body to conduct examinations using any medium..."

NATION, TUESDAY, JULY 22, 2025: Reps Committee Pledges Support For NECO, WAEC, Others To Boost Education Standards: The House of Representatives Committee on Basic Education Examination Bodies has pledged to collaborate closely with the National Examination Council (NECO), West African Examination Council (WAEC), National Business and Technical Examinations Board (NABTEB), and other examination bodies to enhance the quality of education in Nigeria.

Chairman of the Committee, Hon. Oboku Oforji (PDP, Bayelsa), made this known while leading other members of the committee on an oversight visit to monitor the ongoing NECO examinations in the Federal Capital Territory (FCT).

Hon. Oforji emphasised the importance of supporting indigenous examination bodies, saying the National Assembly will provide all necessary legislative backing to strengthen their operations.

"What we have seen today, if this tempo is sustained, we are very confident that tomorrow will be better off. So it is a good one. We want them to show more resilience. For us in the parliament, we believe that the reforms that are ongoing are going to add more value to the educational sector, not just NECO but all the other examination bodies..."

PUNCH, THURSDAY, JULY 24, 2025: FG Committed to Reducing Number of Out-Of-School Children – UBEC-: The Universal Basic Education Commission has reaffirmed its commitment to reducing the number of out-of-school children across the country.

The Executive Secretary of the

Commission, Dr. Aisha Garba, gave the assurance recently while speaking at a retreat for senior staff of the commission held at the Tahir Guest Palace Hotel in Kano.

"We want to ensure we achieve the mandate of universal basic education, which is 100% access to education, reduce the number of out-of-school children – which has been a national challenge – and improve the quality of education," she said.

PUNCH, FRIDAY, JULY 25, 2025: FG sets 12-year New Minimum Age For JSS1 Admission-: A new policy document on Non-State Schools launched by the Federal Ministry of Education last week has pegged the entry age for pupils seeking admission into Junior Secondary Schools after completing six years of primary education at 12.

Non-State Schools, also referred to as independent or private schools or non-government schools, are educational institutions not managed by the government. They are typically financed by tuition payments as well as donations from individuals, businesses, communities, faith-based organisations and foundations.

Speaking on the age of enrolment, the Federal Ministry of Education said, "Children shall be admitted into Nursery One when they attain the age of three years, Nursery Two on attaining the age of four, and one year of compulsory pre-primary education (Kindergarten) on attaining the age of five years, in accordance with the specification of Section 2(17) of the NPE, 2013 Edition." On the age of enrolment for junior secondary schools, the policy clearly stated that, "Basic education shall be of nine years' duration. There shall be a six-year primary and a three-year Junior Secondary School (JSS). Children shall be admitted into

Primary One when they attain the age of six years..."

BLUEPRINT, THURSDAY, JULY 24, 2025: 52 Candidates Caught In Malpractices As NECO Releases Results Of Unity Colleges' Examination- The National Examination Council (NECO) has formally released results of 2025 National Common Entrance Examination (NCEE) for admission into 80 Federal Unity Colleges (FUCS) and Federal Government Academy (FGA).

The examination was conducted across designated centres in Nigeria, Benin Republic and Togo on Saturday, June 14, 2025.

Minister of State for Education, Prof. Suwaiba Said Ahmad, said, after receiving the results from the Registrar of NECO, Professor Dantani Ibrahim Wushishi, according to the results, 64,578 candidates registered for 2025 NCEE, 61,290 candidates sat the examination, while 3,288 were absent.

However, she lamented that, this year, an unprecedented number of 52 candidates (2 candidates from Lagos state and 50 candidates from Rivers state) were involved in examination malpractice.

She said: "The National Common Entrance Examination is for admission into Junior Secondary School one (JSS 1) of Federal Unity Colleges. It is a highly competitive examination which is administered every year to Nigerian children both at home and abroad who desire to gain admission into 80 Federal Unity Colleges (FUCs) spread across all parts of the country." MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
