Earlier, the Head of SERVICOM/Public Relations Officer, Ekiti State Office, Mr. Abdulrasaq Bhadmus, had updated the students' union leadership on the modalities for seamless processing of CUIA for affected students.

Furthermore, Mr. Bhadmus charged the students to always adhere to all relevant guidelines pertaining to their careers to guide against all forms of encumbrances. He, therefore, urged them to face their studies squarely and shun cultism or any other unwholesome acts that could derail their future dreams.

In his closing remarks, the State Coordinator expressed appreciation

to the students' union leaders for their visit stating that the Board exists principally to serve their interests.

"JAMB exists to serve the interest of Nigerian students, so, if we fail to do what we were established to do promptly, then, there's no need for our existence. Hence, we shall continue to discharge our duties in line with our mandate," he said.

## DOUBLE REGISTRATION IS PROHIBITED – OGUN STATE COORDINATOR

**A** call has gone to Part-Time candidates to avoid double registration.

This was contained in the address of the Ogun State Coordinator, Mr. Hakeem AbdulHameed, during the monthly prayer and general meeting held on Monday, 5th, September, 2023, at the State Office.

According to him, double registration is prohibited by the Board stating that the Registrar, Prof. Is-haq Oloyede, had reiterated same during the 2023 Policy Meeting held in Abuja.

Mr. AbdulHameed explained that a candidate, who registered for Part-Time between 2017 and 2020 and the institution, had not uploaded his/her details for Condonement of Undisclosed Illegal Institutional Admissions (CUIA), should not re-register for same as the Admission Officer is expected to process each Part-Time registration only once on CAPS. He added that Part-Time, Sandwich, NOUN and Distance Learning programmes are valid

programmes approved by JAMB with their admission letters processed on CAPS as well.

Furthermore, the State Coordinator stated that staff, on their part, should ensure that institutions adhere to all admission guidelines of the Board adding that no staff must register any Part-Time candidate, who falls between 2017 and 2020 for CUIA or those Part-Time candidates, with or without registration number, whose programmes were for 2016 and below for CUIA.

In another development, a case of impersonation and extortion by a dismissed staff of the NSCDC, Mr. Ayodeji Soetan, was brought to the notice of staff at the meeting.

In his explanation to staff, Mr. AbdulHakeem said a candidate, who had come to the office to apply for correction of data on Thursday, 31st, August, 2023, was accosted by Mr. Soetan, and was asked to pay the sum of five thousand naira, which she did.

However, the candidate on her return to the SERVICOM helpdesk was told she would need an ATM card to make any payment and she stated that she had already paid someone she thought was a staff and was taken round the office to identify the said staff to no avail.

Meanwhile, Mr. Soetan returned to the office on Friday, 1st September, 2023, under the guise of making inquiries on behalf of his sister, who wanted to apply for correction of data. Further investigation, according to the State Coordinator, revealed that he was the one that extorted the candidate and was subsequently handed over to the NSCDC Commandant in Ogun State. It was there that the culprit was exposed as a dismissed officer of the Command.

Mr. AbdulHameed, therefore enjoined staff to shun unwholesome acts or be exposed as was done in the case of Mr. Soetan.

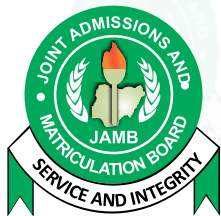

In his response, the rector of the Federal Polytechnic, Ado Ekiti, Ekiti State, host of the in-house interactive session, Dr. John Alake, commended the state office for domesticating the board's initiative, which, he said, would ultimately help institutions in the state to curb admission infractions.

**- Kano Varsity Becomes First To Offer Degree In Aviation Studies:** A private university, Azman University, in Kano will start offering a degree program in aviation studies, and this makes it the first university to offer such programmes in Nigeria and even West Africa.

During a press conference at the university in Kano, on Tuesday the Vice-Chancellor of the university, Prof. Fatima B. Mukhtar, disclosed

that the university got NUC approval for two programmes on aviation studies which include Aviation Management and Aviation Security. She also stated that Azman University will take-up with three faculties which are: Faculty of Computing and Science, Faculty of Allied Health Science, and Faculty of Social and Management Science. "There will be 20 courses under these three faculties," she said.

"Besides the aviation courses, we will

also have Public Health, which only a few universities offer in Nigeria. We are now only waiting for the National University Commission, NUC, to come on the 17th of this month and inspect the university. We will henceforth commence admission of students because we already have standard laboratories, libraries, lecture halls, offices, among others," she said. **Also in BLUEPRINT FRIDAY, 8TH SEPTEMBER, 2023.**

challenges that might crop up in the performance of their duties, and, by so doing, remain viable players in the e-examination and admission value chains.

According to the State Coordinator, core strategies for the improvement and conduct of e-examination in the State, include, but not limited to, the availability of examination halls and holding rooms; computer systems, (250) plus 25 back-ups; adequate spacing per computer cubicle; a professional centre administrator; adequate lighting and cooling systems, among others.

Earlier, the State Technical Advisor and Lecturer in the Department of Computer Science, University of Uyo, Associate Professor, Uyinomen Ekong, delivered a lecture titled: "STRATEGIES FOR THE CONDUCT OF IMPROVED e- EXAMINATION IN AKWAIBOM STATE".

In her presentation, she asserted that the advent of the Covid-19 pandemic fostered the spread and adoption of e-learning in many parts of the world.

Additionally, Prof. Ekong highlighted some of the deficiencies noticed in the conduct of the 2023 UTME and admonished CBT centre owners on the need to strictly adhere to all JAMB requirements and updates to avoid the delisting of their centres. Some of the deficiencies she highlighted included networking (cable) issues, poor infrastructure, outdated systems, lack of backups, among others.

As a way out, Prof. Ekong suggested increased synergy among stakeholders to ensure improved service delivery. She also urged centre owners to put their facilities in order to meet up with requisite specifications.

In his contribution, the State General Monitor, Prof. Akaneren Essien, reiterated the need to improve upon whatever deficiencies were experienced in the last exercise, so that the State can boast of having state-of-the-art CBT centres.

In a similar vein, the State Peace Monitor, Prof. Comfort Ekpo,

emphasized total compliance with JAMB requirements adding that centres must ensure proper CCTV configuration as inability to view a centre, suggests cheating and other unwholesome practices are taking place.

The Team Leader of the Roving Group, South-South, Prof. Iniobong Nkang, in her presentation, advised that independent assessors should be involved in the accreditation exercise, to avoid collusion as some of the centres have compromised standards approved by JAMB.

DCC Essien Udim, HOD, Critical Infrastructure, NSCDC, assured the gathering that with effective communication and full cooperation of all stakeholders, whatever security lapses were experienced in the last exercise would be improved upon stressing that security is a collective responsibility.

The CBT centre owners, in their response, assured the Board of their readiness to adhere to the rules and regulations guiding their operations.

### **ADVISORY ON PROCEDURE FOR EMERGENCY TRANSFER OF RETURNEE NIGERIAN STUDENTS INTO NIGERIAN UNIVERSITY SYSTEM IN TIME OF CRISIS**

Please find below the procedure for processing transfer of Returnee Nigerian Students into Nigerian University system in time of crisis:

1. A prospective student travelling abroad for undergraduate studies normally registers (document his/her travel) with the Federal Ministry of Education (FME) and obtains a Document ID. It is called "Notification to Study Abroad". In case of crises such registration becomes helpful.
2. Anyone who did not but has now become a returnee who is desirous of transfer into a Nigerian University must do a retroactive registration with the Federal Ministry of Education as follows:
  - Go to FME website - [www.education.gov.ng](http://www.education.gov.ng)
  - Go to attestation of academic documents or <http://ess.education.gov.ng>
  - Tick the certificates you want to evaluate (Tick your highest qualification in Nigeria to enable you pick a date)
  - Pick a date
  - Make payment via remittal - RRR code
  - Print Appointment Slip
  - Go to FME Revenue Unit - 2nd floor
  - Go to 8<sup>th</sup> floor - Evaluation Accreditation Division with original copies of your credentials base on your Date of Appointment

  - b. Transcript/Student Semester Results;
  - c. Data page of International Passport; and
  - d. Sworn Affidavit (confirming the genuineness of information supplied and that insincere or false information shall lead to withdrawal from studies and/or of certificates (in the event of issuance). Prosecution may also follow.
7. Returnee Student clicks SUBMIT button, which now sends an email to intended University of Choice for Request for Application to Apply for Inter-University Transfer.



8. Notification page for successful request is loaded and presented on the screen by IBASS System.
9. Returnee Student gets a notification email and SMS for his/her application request sent to the intended University of Choice.
10. Student's University of Choice gets an IBASS mail of the Student's Request for Application to Apply for Inter-University Transfer
11. Intended University evaluates Student's credentials for possible consideration.
12. If the Intended University of Choice is satisfied/unsatisfied with the credentials presented by the Returnee Student, a notification is sent on JAMB-IBASS-mail for Qualified/Unqualified for consideration.
13. Qualified Returnee Student is directed via the email and SMS to approach any JAMB Office (in person) to complete the Inter-University Transfer Application.

**Note** that the process is tracked by JAMB, NUC and the candidate as follows:

- (a) Submitted
- (b) Being reviewed by the University
- (c) Successful/Unsuccessful

14. The intended University of Choice then follows the Advisory on Inter-University Transfer of Students earlier sent to the institutions in 2019 (see attached).

### ADVISORY ON PROCEDURE FOR APPLICATION FOR FOREIGN INTER-UNIVERSITY TRANSFER FOR STALITES (NOT FRESHERS)

Please find below the procedure for application for foreign inter-University transfer for Stalites:

1. The proposed institution sends a list of all candidates (not Freshers) for foreign Inter-University transfer to State JAMB Office with a letter of indemnity.
2. The proposed institution directs each candidate to State JAMB Office to create his/her profile on efacility platform (Candidate not on the list earlier sent by the proposed institution would be rejected by the State JAMB Office and cannot process any application on the system).
3. At State JAMB Office, the candidate fills the INTER-UNIVERSITY TRANSFER APPLICATION FORM FOR STALITES (NOT FRESHERS) FROM FOREIGN UNIVERSITIES online which would be available only at the State JAMB Office (Note that only the State JAMB Office that the institution is located can attend to the candidates).
4. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her Current and Proposed Institutions for the signature of the Heads of the Institutions to indemnify JAMB on the accuracy of the information provided by the candidate. The form is to be endorsed first by the current institution.
5. The Proposed Institution sends the endorsed and indemnified form to the Coordinator of the State JAMB Office.
6. The form is uploaded from the State JAMB Office to the Headquarters and made available to the efacility platform for processing.
1. If the application is approved, the candidate is notified through his/her email.
2. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online ([www.jamb.gov.ng](http://www.jamb.gov.ng)) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

## CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS

-  All applications of admissions to **First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc.**, must be processed **ONLY** through the Joint Admissions and Matriculation Board (JAMB).
-  No Institution should advertise or sell “application forms” for admissions into the programmes. Institutions should advertise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
-  Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
-  The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

### ADVERTORIALS

-  Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
-  It should be reiterated that no Institution should advertise or sell “application forms” for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
