





TEAM BUILDING, A PANACEA FOR ORGANIZATIONAL GROWTH - SERVICOM

n continuation of its programmes of activities lined up to mark the Board's maiden SERVICOM Customer Week, sensitisation talks on the importance and the need for effective Team Building in the workplace as a solution for organisational development were delivered by seasoned professionals during the event.

Kicking off the set sensitisation lectures was the National Head of Operations, SERVICOM Office, Mrs Ngozi Akinbodewa, who, in her lecture titled: "Team Building for Enhanced Service Delivery" described Team Building as the ability to identify and motivate individual employees to form a team that stays together, works together and achieves together.

According to Mrs Akinbodewa, Team Building can be for either problemsolving purposes or cross functional purposes. She stated the four conditions necessary to function as an effective team to include: the group must have a reason for working together; the members of the group must be interdependent and rely on each other's experiences, abilities, and commitment to arrive at mutual goals; group members must be committed to the idea that working together as a team leads to better decisions and outcomes than working independently; and team members must be accountable as a functioning unit within a larger organisational context.

Continuing, she said, as part of measures in building a phenomenal team that stands out, one will require extraordinary approach such as, not settling for mediocrity; picking a thoughtful leader, selecting leaders you can trust and maintaining systemic processes.

Furthermore, Mrs Akinbodewa said the driving force behind building a formidable team in an organisation as JAMB is a diligent effort, which must go through development stages. These stages are: Forming Stage, Norming, Performing and Adjourning stage, among others.

She added the following benefits to ensue that all team members contribute their quotas in team building: better communication, higher efficiency, enhanced commitment, better synergy and shared culture.

Finally, she concluded that a team is not an end itself but rather a means to an end, the purpose of a team is to a chieve result. Therefore, performance is the primary driver of teams. For a team to function effectively, the members must have one goal, commitment and ability to accommodate each other's differences and rely on the strength of other team members to succeed.

In another brilliant presentation on Emotional Intelligence, by the National SERVICOM Team Leader C, Mrs Kike Aina, highlighted how employees' emotional state can impact their working attitude whether at the group or individual level. According to her, whether in business or at the home front, people leverage on their emotions to attain improved productivity.

"Being able to identify and recognise emotions, consciously think about them and use them in a logical manner are the main components of emotional intelligence".

"Emotional Intelligence is the ability to sense, understand, and effectively apply the power and acumen of emotions as a source of human energy, information, connection and influence."

She further explained that, certain skills can highly develop people's emotional intelligence, these are: Independence from your own feelings and ability to adjust yourself to them, ability to recognise, name and direct your feelings, use them in positive way, and derive actions from it. Other sub-skills include, how we monitor our own, others feelings, how we discriminate, assess and how we use this knowledge to guide our thinking and actions which is germane to assertiveness, impulse control, adaptability, motivation and optimism.

Continuing, Mrs Aina said, we have two sides of Emotional Intelligence, they are, Personal Competence (how we manage ourselves) and Social Competence (how we handle our relationships with others).

She rolled out the signs of people with Low Emotional Intelligence; these are people, refusing to accept personal responsibility for errors, criticizing other people when they make mistakes, always playing the role of the victim, refusing to accept critical feedback, refusing to integrate with the team, not open to others' opinions.

She enjoined the participants to improve on their Emotional Intelligence via the following fundamental and basic steps: Develop your Emotional Self-Awareness, Take Responsibility for Your Actions and Feelings, Remember You Are Not Your Emotions, Put Yourself In The Other Person's Shoes, Get Some Distance From The Bad Stuff.

On a final note, Mrs Aina stated that being knowledgeable about emotions means that we can perceive and use emotions to create optimal relationships and produce desired outcomes for the betterment of all.



JAMB PROHIBITS STAFF FROM EATING IN THE OFFICE

s part of efforts aimed at checking the influx of rodents into its facilities, the Joint Admissions and Matriculation Board(JAMB) has warned staff to desist from eating in their various offices.

According to a statement issued by its management, the Board is dismayed that in spite of the series of advisories issued on this matter, staff have flagrantly refused to comply with the directives.

This latest warning may not be

unconnected with the protracted failure recorded in the use of pesticides while noting that the rodents had almost taken over the entire office space.

In a final warning signed by the Director of Huma Resources, Mr. Muhammed Shehu, which reads in parts: "management has observed with dismay that despite several warnings some staff at the National Headquarters, Zonal and State Offices have continued to eat in their offices thereby attracting rodents and causing serious

damage to equipment and other items."

The statement warned that stiffer penalties await staff, who disobeyed this directive while charging Directors and State Coordinator to ensure compliance with the directive.

...Gross Disregard for the Board's Mandate Unacceptable - Oloyede

This came after it was observed that some institutions matriculated students during the 2021 and 2022 academic years before sending their matriculation notification to the Board as against the stipulated two-week prior written notification to the Board before the ceremony.

Article18.6.1 of the 2023 Guidelines on Admission states that, "The Joint Admissions and Matriculation Board (JAMB), National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE), must all be informed and invited not later than two weeks before matriculation ceremony, through the CAPS mail (as applicable to the institution)."

According to the Registrar, despite being aware of the above provision of the law, some institutions still proceeded to matriculate students without properly informing the Board, which was charged with the responsibility of analyzing the matriculation list and offering appropriate advice on whether the ceremony should be postponed or continued as planned.

"Gross disregard for the Board's mandate is unacceptable, and henceforth, any erring institution will be sanctioned accordingly and violators will be published in the Board's weekly Bulletin in line with the 2023 Guidelines on Admissions."

"JAMB would continue to forward the analysis of matriculation lists to the institutions, for them to properly appraise the level of compliance or violations as late invitation to the matriculation ceremony would not be entertained," he said.

Earlier, the Registrar expressed

appreciation to the Desk Officers for upholding the Board's image and integrity. He cited a scenario on the floor of the Senate during plenary on 8th November, 2023, where the Board was accused of complicity in admission racketeering with the University of Nigeria, Nsukka, by the Senator representing Ebonyi North, Sen. Nwebonyi Onyeka Peter, prompting the Senate President,

ADVISORY ON PROCEDURE FOR EMERGENCY TRANSFER OF RETURNEE NIGERIAN STUDENTS INTO NIGERIAN UNIVERSITY SYSTEM IN TIME OF CRISIS

Please find below the procedure for processing transfer of Returnee Nigerian Students into Nigerian University system in time of crisis:

- A prospective student travelling abroad for undergraduate studies normally registers (document his/her travel) with the Federal Ministry of Education (FME) and obtains a Document ID. It is called "Notification to Study Abroad". In case of crises such registration becomes helpful.
- 2. Anyone who did not but has now become a returnee who is desirous of transfer into a Nigerian University must do a retroactive registration with the Federal Ministry of Education as follows:
 - Go to FME website www.education.gov.ng
 - Go to attestation of academic documents or http://.ess.education.gov.ng
 - Tick the certificates you want to evaluate (Tick your highest qualification in Nigeria to enable you pick a date)
 - Pick a date
 - Make payment via remittal RRR code
 - Print Appointment Slip
 - Go to FME Revenue Unit 2nd floor
 - Go to 8th floor Evaluation Accreditation Division with original copies of your credentials base on your Date of Appointment

- In the IBASS page, the Returnee Student uploads the registration slip obtained from 4. the FME and then completes the Returnee Transfer Personal data:
 - a. Name
 - b. NIN
 - c. Telephone Number
 - d. Active e-mail address
 - e. Current University
 - f. Country and City of Study
 - g. Programme
 - h. Year of Entry
 - i. Current Level of Study
- 5. Returnee Student selects intended University of Choice and Programme.
- Returnee Student uploads scanned copy of the following documents: 6.
 - a. Current University Admission letter;
 - b. Transcript/Student Semester Results;
 - c. Data page of International Passport; and
 - d. Sworn Affidavit (confirming the genuineness of information supplied and that insincere or false information shall lead to withdrawal from studies and/or of certificates (in the event of issuance). Prosecution may also follow.
- 7. Returnee Student clicks SUBMIT button, which now sends an email to intended University of Choice for Request for Application to Apply for Inter-University Transfer.

- 8. Notification page for successful request is loaded and presented on the screen by IBASS System.
- 9. Returnee Student gets a notification email and SMS for his/her application request sent to the intended University of Choice.
- 10. Student's University of Choice gets an IBASS mail of the Student's Request for Application to Apply for Inter-University Transfer
- 11. Intended University evaluates Student's credentials for possible consideration.
- 12. If the Intended University of Choice is satisfied/unsatisfied with the credentials presented by the Returnee Student, a notification is sent on <u>JAMB-IBASS-mail for</u> Qualified/Unqualified for consideration.
- 13. Qualified Returnee Student is directed via the email and SMS to approach any JAMB Office (in person) to complete the Inter-University Transfer Application.

Note that the process is tracked by JAMB, NUC and the candidate as follows:

- (a) Submitted
- (b) Being reviewed by the University
- (c) Successful/Unsuccessful
- 14. The intended University of Choice then follows the Advisory on <u>Inter-University</u> <u>Transfer of Students earlier sent to the institutions in 2019</u> (see attached).

ADVISORY ON PROCEDURE FOR APPLICATION FOR FOREIGN INTER-UNIVERSITY TRANSFER FOR STALITES (NOT FRESHERS)

Please find below the procedure for application for foreign inter-University transfer for Stalites:

- 1. The proposed institution sends a list of all candidates (not Freshers) for foreign Inter-University transfer to State JAMB Office with a letter of indemnity.
- 2. The proposed institution directs each candidate to State JAMB Office to create his/her profile on efacility platform (Candidate not on the list earlier sent by the proposed institution would be rejected by the State JAMB Office and cannot process any application on the system).
- 3. At State JAMB Office, the candidate fills the INTER-UNIVERSITY TRANSFER APPLICATION FORM FOR STALITES (NOT FRESHERS) FROM FOREIGN UNIVERSITIES online which would be available only at the State JAMB Office (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- 4. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her Current and Proposed Institutions for the signature of the Heads of the Institutions to indemnify JAMB on the accuracy of the information provided by the candidate. The form is to be endorsed first by the current institution.
- 5. The Proposed Institution sends the endorsed and indemnified form to the Coordinator of the State JAMB Office.
- 6. The form is uploaded from the State JAMB Office to the Headquarters and made available to the efacility platform for processing.
- 1. If the application is approved, the candidate is notified through his/her email.
- 2. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

about what was perceived to be a connivance between JAMB and some institutions on the issue of admission racketeering. This was hardly flattering but sometimes, what appears to be negative, if thoroughly looked into, may turn out to have some positivity in it as the Senate President stood in defense of JAMB, saying, "JAMB must be heard, because JAMB has integrity." We must, therefore, thank the Senate President, in particular, and the Senate in general for taking that course of action. We thank them sincerely for giving us the opportunity to be heard. For that, I feel very proud of JAMB and those who are working in JAMB."

"However, JAMB will fully cooperate with the Senate to ensure that perpetrators, whosoever they are receive appropriate sanction, we will continue to do our best to ensure that the confidence reposed in us by the nation is not compromised in any way as we will continue to make the nation proud."

Findings from the Board's preliminary investigations showed clearly that no staff of the Board was in any way involved in the reported admission irregularities.

Furthermore, the Registrar had recalled that the Board, on discovering some of the abnormalities, had insisted that the right thing must be done by the institutions involved by ensuring that all high-scoring candidates topping their merit list must be admitted into their programmes of choice. He noted that it was during the process of oversight that the Board discovered that many of the candidates parading themselves as high scorers did not meet the requirements to be admitted on

merit. He stated that this was the main reason they had gone through illegal routes to secure their backdoor admissions. According to him, all students know that any admission letter that did not emanate from JAMB is not a letter of admission but a "Letter of Deception".

The Registrar expressed confidence that the Board's mediation between the institution and the candidate would be greatly appreciated at the end of the investigation as the candidates had complicated their matter by accepting admissions through illegal channels even as he added that he who comes to equity must come with clean hands.

He concluded by thanking all staff of the Board for their commitment, integrity and quality service delivery.

ADVISORY ON PROCEDURE FOR APPLICATION OF FRESH FOREIGN CANDIDATES (EXTRA ORDINARY)

Please find below the procedure for application for fresh foreign candidates (this **supersedes** the advisory issued in November, 2019):

- The University sends a list of all fresh foreign candidates (for current admission) to State JAMB Office with
 a letter of indemnity signed by Head of the Institution. The letter of indemnity will read in part "I confirm
 that the listed candidate as forwarded to JAMB all met the admission requirements into my institution and
 hereby indemnify JAMB against any inaccuracy of the claims".
- The same list and letter as in (1) above should be sent to the JAMB Director of Admissions through the CAPS mail.
- The institution directs candidates to State JAMB Office to create their profiles individually on efacility platform (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- 4. At State JAMB Office, the candidate fills FRESH FOREIGN Application form online which would be available only at the State JAMB Office (Candidate not on the list earlier sent by the institution would be rejected by the State JAMB Office and cannot process any application on the system).
- Immediately the registration is completed at the JAMB Office, a Registration Number would be generated and assigned to the candidate alongside his/her transaction ID.
- Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her institution for the signature of the Head of the Institution to again indemnify JAMB on the accuracy of the information provided by the candidate.
- The <u>Head of the Institution authorises the candidate's application online</u>. At this point the details
 of the candidate is now made available on CAPS to enable the institution Propose and Recommend the
 candidate to JAMB for approval.
- The Head of the Institution would now send the endorsed indemnified <u>physical</u> form to the Coordinator of the State JAMB Office for immediate upload to CAPS for approval.
- NO UPLOAD OF INDEMNIFIED PHYSICAL FORM, NO APPROVAL ON CAPS BY JAMB
- If the application is approved, the candidate is notified through his/her email. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

THE CRUSADE TO SANITISE THE EDUCATION SECTOR IS ON **ALL OF US - OGUN EDUCATION COMMISSIONER**

he Ogun State Commissioner of Education, Science and Technology, Prof. Abayomi Ariababu, has announced that the campaign to sanitise the education sector is the responsibility of every citizen and not just that of educators.

The Commissioner made this declaration during the courtesy visit of the SERVICOM/PR Unit to his office on Monday, 6th November, 2023, as part of activities to mark the maiden edition of the Board's Customers' Service Week.

In her remarks, the Head of the SERVICOM/PR Unit, Ms. Abiola Adekunle, said one of the activities of the Board during this week-long event was to conduct series of sensitisation outreach in various secondary schools nationwide with the aim of sensitizing students on the steps they need to take in order to properly register for the 2024 UTME.

According to her, the Board has discovered that most of the mistakes made by candidates during reaistration stems from the mismatch of their data pulled from the National Identity Management

Commission (NIMC). She explained that there is a need to supply accurate information at the point of their NIN enrolment. She identified some of the errors to include: wrong subject combination, use of henna, which makes it difficult to capture their fingers, and failure to upload O'level results, among others. She said another forum to sensitize stakeholders in the State on the steps to take before registering for the UTME with the help of the Commissioner would be appreciated.

In his remarks, the Commissioner expressed happiness with the Board's desire to sensitise the students of the State, whom he sees as prospective UTME candidates, adding that the outreach was a veritable means of enlightening students on the Board's processes from registration to admission into tertiary institutions.

Prof. Ariababu commended the Registrar, JAMB, Prof. Is-haq Olovede, for his laudable efforts at sanitizing and improving the education system, especially with regard to the UTME registration process as well as the admission

process. He disclosed that the system now ensures that even the child of a nobody gains admission on merit while ensuring that malpractices, in terms of name manipulation and impersonation are curbed. He also noted that the digitalization of IBASS has also improved access to brochures and syllabi such that candidates know what subjects they require to study their preferred course.

"It is my hope that this year's JAMB SERVICOM sensitization exercise would help reduce errors made by candidates out of ignorance."

"Oaun State has an identification system for its learners in the State known as the Learner Identification Number (LIN) so there is no duplication of learners, especially for people with popular names. All schools recognized by the State have their learners registered and students not registered are those who are not vet in primary school." he disclosed.

The week-long 2023 JAMB SERVICOM Customer Service Week, was celebrated in all the Board's offices nationwide.

> According to her, UTME candidates must first generate a profile code by sending NIN (leave a single space), followed by the eleven digits of their National Identification Numbers to either of the sort codes: 55019 or

66019. According to her, once the profile code is generated, the candidate's biodata would be retrieved from the National Identification Management Commission (NIMC) portal and the code becomes the immutable and unique identity of the candidate on the JAMB portal.

Furthermore, Mrs. Egbuna revealed that as soon as a profile code is successfully generated, the candidate would proceed to any JAMB approved Computer-Based Test (CBT) centre, where he would be

required to vend an e-PIN to be registered.

In her speech, the JAMB SERVICOM Head admonished candidates to do all necessary corrections with NIMC early enough, and confirm that the changes have been effected to their satisfaction before embarking on the registration exercise, reiterating that any irregularities in names, date of birth, gender, state of origin cannot be changed after registration.

Mrs. Egbuna further charged candidates to ensure that their details with the NIMC tally with the ones given to JAMB and are those, which are reflected in their O' level results, stating that any disparity in the details would affect their mobilization for the compulsory one-year national youth service.

In her concluding remarks, Egbuna enjoined candidates to desist from applying substances such as abrasives and henna on their hands as such might distort the whorls of their fingers resulting in difficulty at biometric verification during registration.

Among the secondary schools visited in Abuja during the exercise were: Government Secondary School, Kuduru; Government Day Secondary School, Dutse; Government Girls Secondary

School, Dutse; Total Child Model School, Dutse; Metro International Secondary School, Kubwa; Federal Government Girls College, Bwari; Excellent Kiddies Academy, Bwari; Valid Crown International College, Bwari; among others.

In another development, JAMB SERVICOM, Ibadan Zonal Office, took its advocacy to selected senior secondary schools and Computer-Based Test (CBT) centres in Oyo State. The schools visited included: Global Academic Trends, Urban Day Grammar School, Old Ife Road, Ibadan; Community High School, Old Ife Road, Ibadan; Bishop Philips Academy, Ibadan; Ikolaba Grammar Schools 1 & 2, Ibadan; Islamic High School, Ibadan; Baptist High School, Igboho; Ifelodun Grammar School; Igboho.

In the same vein, the team also visited various CBT centres across the State to educate their personnel on the demands of professional service delivery and the place of JAMB as a regulator, which frowns at illegal practices, extortion and examination malpractices.

In their various responses, members of staff of PEFTI CBT Centre, Ibadan; Hismay CBT Centre, Ibadan; and Queen's Vee CBT Centre, Ibadan, among others, expressed appreciation for the thoughtfulness

CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS

- All applications of admissions to First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc., must be processed ONLY through the Joint Admissions and Matriculation Board (JAMB).
- No Institution should advertise or sell "application forms" for admissions into the programmes. Institutions should advertise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
- The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

<u>ADVERTORIALS</u>

- Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
- It should be reiterated that no Institution should advertise or sell "application forms" for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
