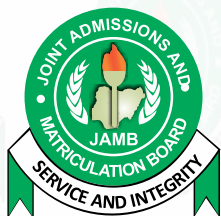

**NATION NEWSPAPER, TUESDAY MARCH 21ST, 2023 - JAMB Resumes Direct Entry Registration:** Joint Admissions and Matriculation Board (JAMB) has announced the resumption of registration for the 2023 Direct Entry (DE) application. It also announced new guidelines for the registration.

The Registrar, Prof. Is-haq Oloyede, who made this known at a news briefing in Abuja, said the DE registration would close on April 20th. 2023.

The Board on February 21 announced the suspension of the registration, to enable it to deploy certain measures, which are designed to better serve prospective candidates.

"To further checkmate the anomaly and also prevent recurrence, the Board has decided that the 2023 DE registration will not only be restricted to JAMB professional Test Centres, but will also be done under strict supervision.

**PUNCH NEWSPAPER, TUESDAY MARCH 21ST, 2023 - Uniosun Secures NUC Accreditation for 26 Courses:** The Management of Osun State University, Osogbo, said it has secured full accreditation of 26 undergraduate and postgraduate courses for the institution.

This was disclosed by the institution's Vice-Chancellor, Prof. Clement Adebooye, while speaking on the recent achievements of the

University.

A statement by the university's Public Relations Officer, Ademola Adesoji, explained that various teams had assessed the institution's teaching and learning facilities, as well as, the available personnel for the respective academic programmes both at undergraduate and postgraduate levels.

The statement read, "I am glad to announce that we received the outcome from the NUC yesterday and that we recorded 100% full accreditation for 26 undergraduate and postgraduate programmes.

"Some of the undergraduate programmes include: Fisheries and Aquaculture, Wildlife Management, Food Science and Technology, Computer Science, Guidance and Counseling, Urban and Regional Planning, Medicine and Surgery, Biochemistry, Industrial Chemistry, Geology, Mathematics.

Others include Microbiology, Physics with Electronics, Statistics, Public Health, Civil Engineering, Electrical and Electronics Engineering, Economics, Geography, Political Science and International Relations, Banking and Finance, among others."

**GUARDIAN NEWSPAPER, THURSDAY MARCH 23RD, 2023 - Stakeholders Divided On Ranking Of Nigeria Universities:** Nigeria has doubled the number of its ranked universities – from six to 12 in the recently released Times Higher Education (THE) World University Rankings.

However, stakeholders are divided on whether the achievement is an accurate reflection of the nation's higher education system, considering incessant strikes by various academic unions.

The rankings for Nigeria showed that the University of Ibadan (UI) and University of Lagos (UNILAG) are tied for first spot, both scaling into the top 500 as they were placed in the 401-500 band.

Covenant University occupies the third spot and is placed in the group band of 601-800. Two federal universities, Bayero University, Kano (BUK) and Federal University of Technology, Akure (FUTA) were placed in the group band of 1001-1200.

Ranked among the group of 1201-1500 are four universities, namely universities of Benin, Ilorin, Nsukka and Obafemi Awolowo University.

The remaining three universities ranked in the last category of 1501+ include Federal University of Agriculture Abeokuta (FUNAAB), Ladoké Akintola University of Technology (LAUTECH) and Nnamdi Azikiwe University (NAU), Awka.

Like their counterparts across the world, the universities were ranked

This was disclosed by the Anambra State Commissioner for Education, Ngozi Chuma-Udeh, in her speech during the 71st WAEC Day celebration, held at Nise, Awka South Council Area.

Commissioner Chuma-Udeh, who stated that the decision was among the major strategies adopted by the Anambra State Ministry of Education to combat examination malpractices in the state, announced that all former WAEC Supervisors in Anambra

State have been relieved of their duties with effect from this year. "...We want to have a new crop of supervisors and if there is a question of examination malpractices, the particular supervisor will pay the price," she warned.

**TRIBUNE NEWSPAPER, TUESDAY MARCH 21ST, 2023 - JAMB Raises Alarm over Candidates Using Fake Results to Secure Admission:** The Joint Admissions and Matriculation Board (JAMB) has decried the high level of forgery of A Level certificates used for the DE registration admission.

The JAMB Registrar, Prof. Is-haq Oloyede recalled that the Board had commenced the 2023 Direct Entry registration on Monday, 20th February, 2023, but had to immediately suspend it following the discovery of the plethora of devices and machinations to circumvent the standard of A' level qualifications required from DE candidates.

He disclosed that out of 148 candidates verified by Bayero

University Kano (BUK), only 6 were found to be genuine. This is from a university that is prepared to expose the infraction.

He said: "It was discovered that in previous years, some candidates used unacceptable and forged A' level certificates/qualifications to register for Direct Entry and eventually got admitted.

"The Board, concerned stakeholders and institutions are working assiduously to detect such and the ones already found, are being dealt with according to the provisions of the law."

# 2023 DE REGISTRATION: JAMB MEETS NIPEDS, WARNS REGISTRATION OFFICERS AGAINST SABOTAGE

Following the resumption of the sale of Direct Entry application documents, the Registrar of the Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede, has warned Registration Officers not to compromise on the new guidelines issued by the Board or involve themselves in any registration infractions that could jeopardise the good intentions of the Board as it strategised to curb the abuses associated with A'Level certificates.

The Registrar further charged the Board's Registration Officers to obey and comply with all the extant advisories and guidelines on Direct Entry registration, stressing that any mistake would not be taken as mistakes rather it would be construed as deliberate attempt to circumvent and sabotage the system.

The warning was contained in an address read by the Registrar during a virtual meeting hosted from the Board's National Headquarters, Abuja, with members of Nigeria Post-secondary Education Data System (NIPEDS) Registration Officers and other critical stakeholders on 20th March, 2023.

The Registrar pointed out that the new measures were aimed at bringing sanity to the admission process and by doing so, "Identify the

plethora of devices and checkmate all machinations targeted at circumventing and compromising the standard of A/L qualifications required from DE candidates."

He disclosed that the recent joint operations conducted by the Federal Ministry of Education and the Independent Corrupt Practices and Other Related Offences Commission (ICPC) on DE qualifications had brought to light the series of unsavoury and nefarious activities being perpetrated by candidates. He commended the authorities of the Bayero University, Kano, which had rusticated 142 students, who had been admitted with fake A'Level results.

Prof. Oloyede informed the Registration Officers that it was in a bid to curb these abuses that the Board decided to restrict the 2023 DE registration to only JAMB PTCs for close monitoring.

According to the Registrar, part of the entry requirements for the 2023 DE registration would include the Registration/Matriculation Number of the previous school attended by the candidate; where the qualification was obtained; subject(s) of qualification; awarding institutions; and institutions actually attended, among others

requirements.

Furthermore, the Registrar also stated that the Board would only recognise and accept 13 categories of qualifications/certificates for the 2023 DE namely: First Degree, University Diploma, Higher National Diploma (HND), NABTEB Advanced National Business Certificate (ANBC), NABTEB Advanced National Technical Certificate (ANTC) and Ordinary National Diploma/National Diploma (OND/ND).

Others are: NABTEB GCE-A Level (2015-2021), Nigeria Certificate in Education (NCE); Interim Joint Matriculation Board (IJMB) A'Level; Joint Universities Preliminary Examination Board (JUPEB); Higher Islamic Studies Certificate (HIS) by NBAIS; International Baccalaureate (IBN) - for foreign certificates only; and the National Registered Nurse/National Registered Midwife (NRN/NRM) certificates, among others.

The Registrar added that a total of 127 candidates, who had earlier registered for DE before the exercise was suspended, have been directed to return to their registration centres and update their applications in line with the fresh advisories.

Earlier, the pioneer Vice Chancellor of the University, Prof. Mahfouz A. Adedimeji, in his speech titled: "PERSIST AND RESIST" to the matriculants said that they should

count themselves lucky as it is not all applicants, who sought admission into the institution that were admitted because the admission was conducted solely on merit.

Prof. Adedimeji also informed the matriculants that for the 2022/2023 Session, a total number of sixty-nine (69) students were admitted through the Unified Tertiary Matriculation

Examinations (UTME) route, while twenty-seven (27) students were admitted through Direct Entry (DE), totaling ninety-six (96) students to study the fifteen (15) programmes being run by the institution.

He stated that the matriculants are not expected to only pass through the Institution, but that the Institution should also pass through them. He also urged them to get to the sun if not, at least they should endeavour to reach the moon so that they can be a pride not just to their parents but also to the institution and Nigeria at large.

Mr. Ndaliman urged the fresh graduands to embrace integrity, diligence and honesty to make a difference in their dealings outside the school system.

Earlier at the event, the Rector of the Polytechnic, Dr. Justina Anjiode Kotso, in her address, disclosed that thirty thousand, seven hundred and

five (30,705) students would be graduating from different programmes.

While congratulating the graduands on successfully completing their programmes, the Rector commended them for making it thus far. She also enjoined the graduating students to be worthy of being

certified in moral, character and learning through their comportment, commitment and perseverance. She also charged them to stay focused and remain worthy Ambassadors of our Polytechnic.

## INCLUSIVITY: A BASELINE FOR EQUAL OPPORTUNITY IN JAMB

**I**n line with the 1994 Salamanca Statement and Framework for Action on Special Needs on the Rights of Persons with Disabilities, the Joint Admissions and Matriculation Board (JAMB), has over time, put appropriate machinery in motion to cater for the needs of its candidates, particularly those with special needs.

This position accords with the Board's viewpoint that all its operations must align with all extant local and international provisions on guaranteeing equal opportunities for all its candidates.

As such, the Board has always ensured that the rights of all its teeming candidates are not jeopardized in any way by giving adequate regards to individual candidate's peculiarities through its inclusivity programme.

Inclusivity involves ensuring that candidates with diverse and different learning and physical abilities enjoyed a level playing field. Consequently, the Board, has over the years, been actively promoting inclusiveness through its JAMB Equal Opportunity Group (JEOG) led by the erudite Prof. Peter Okebukola.

The Group, among others, is primarily saddled with the responsibility of moderating the delivery of the Board's Unified Tertiary Matriculation Examination (UTME) for candidates with special needs, particularly those with visual impairments, hearing impairments, albinos, candidates with cerebral palsy, prison inmates, among others, in its UTME as well as moderating their admission processes to tertiary institutions in Nigeria.

The Board has also invested heavily on special needs logistics, especially in terms of assistive technology, partnership, and special arrangements, to cater for candidates with special needs.

Furthermore, the Board has not left out the prison inmates, who had historically been excluded because of their status, through state-of-the-art technology to enable them access and sit the UTME.

It should be noted that the Board, in its bid to curb examination malpractice, had introduced biometric verification to curb the menace. However, in a scenario where physical disability hinders a candidate from being biometrically captured for the UTME, or where the whorls of the fingers were too faint to be captured on a count of corrosion, JAMB provides special arrangements for such candidates to register and sit its examination, as such, no candidate is disenfranchised.

In the same vein, the partnership between JAMB and tertiary institutions with the focus on the development of inclusive educational practices and exempting Blind, Deaf, Foreign Candidates, and Prison Inmates from all forms of pre-admission screening tests is highly commendable.

Similarly, to ensure fairness in its assessment, the Board allows magnifiers for candidates with low vision and albinos to make test items appear in larger fonts while taking the UTME.

In view of all these noteworthy and innovative steps, it is recommended that the Board should sustain its current approaches to inclusivity as well as update the same in line with global best practices.





## FEW FACTS ABOUT JAMB

- The Joint Admissions and Matriculation Board (JAMB) was established for the general control of the conduct of matriculation examinations for admissions into all universities, polytechnics, monotechnics, colleges of education and ( recently added) Innovation Enterprise Institutes (IEIs).
- Section 5 (2) of the ACT establishing the Board provided as stated: For the avoidance of doubt, the Board shall be responsible for determining matriculation requirements and conducting examinations leading to undergraduate admissions and also for admissions to National Diploma and the Nigerian Certificate in Education courses, but shall not be responsible for examinations or any other selective process for postgraduate courses and any other courses offered by the tertiary institutions. In the implementation of this section, there is always a synergy with the National Universities Commission (NUC), the National Board for Technical Education (NBTE) and the National Commission for Colleges of Education (NCCE) with the endorsement of the National Council on Education (NCE).
- In exercising this power, the Board is always guided by admission guidelines approved by the Policy Meeting under the Chairmanship of the Hon. Minister of Education with all Heads of Tertiary Institutions and other stakeholders in attendance.
- Since the inception of the Interim Joint Matriculation Board Examination (IJMBE), JAMB appoints moderators for all its questions as well as the grading of candidates scores. It has always done this without failing to still accommodate 'HSC' within the current 6-3-3-4 system. The National Council on Education (NCE) guidelines for the Joint Universities Preliminary Examinations Board (JUPEB) also endorsed the practice for JUPEB.
- The Joint Admissions and Matriculation Board shall continue to operate within its laws.



## JAMB DISTRIBUTES SECURITY GADGETS ACROSS NSCDC STATE COMMANDS, SETS FOR 2023 MOCK-UTME

**T**he Joint Admissions and Matriculation Board (JAMB) has begun the nationwide distribution of security gadgets across the State Commands of the Nigeria Security and Civil Defence Corps (NSCDC) in readiness for the 2023 Mock-UTME scheduled for 30th March, 2023.

In a statement made available to JAMB Bulletin, the Board stated that it had sent delegations to all States Commands of the Corps across the country to distribute the security gadgets that would be used during the upcoming 2023 Mock-UTME.

## RESUMPTION OF 2023 DIRECT ENTRY REGISTRATION: JIGAWA STATE COORDINATOR MEETS REGISTRATION OFFICERS

**A**head of the resumption of Direct Entry registration on Monday, 20th April, 2023, the State Coordinator, Jigawa, Mr. Bello H. Aminu, has met with the Registration Officers deployed to the State Office on Tuesday, 21st March, 2023.

It would be recalled that the 2023 Direct Entry registration exercise, which had initially commenced on Monday, 20th February, 2023, was suspended the following day, Tuesday, 21st February, 2023, to facilitate the deployment of more security measures, among others.

According to him, the resumption of DE registration was borne out of the

deployment of necessary measures to forestall the series of issues associated with previous Direct Entry registrations and admissions so as to better serve prospective candidates as well as protect the sanctity of the exercise.

Furthermore, the State Coordinator disclosed that the Board would, in due course, educate all stakeholders on the major modifications introduced by the Board regarding the Direct Entry registration process. He urged Registration Officers to attend to candidates with courtesy and to ensure that all the requirements approved by the Board are met before registering any

candidate.

In addition, Mr. Bello revealed that the decision to restrict the Direct Entry registration exercise to JAMB Professional Test Centres (PTC) and Professional Registration Centres (PRC) only is an indication of the Board's confidence in its staff and enjoined Registration Officers to ensure strict compliance with the new guidelines.

Mr. Shu'aibu Garba, one of the Registration Officers, welcomed the changes introduced by the Board and promised that all the deployed Registration Officers would ensure strict compliance with the new guidelines.

which was coordinated from the Board's National Headquarters, Bwari, Abuja, the Registrar, Prof. Is-haq Oloyede, said that every year, the Board conducts training, examination and certification for every outing and only qualified staff are enlisted in the exercise. According to him, the training and the examination are, in essence, a way of validity test to recertify its entire technical staff to ensure that only the best hands are deployed for the 2023 exercise.

In his words, "All staff and ad-hoc personnel are as good as their current results."

Furthermore, the Registrar informed the Technical Officers, who numbered about 650 personnel, that the training and the concomitant test were meant to update and assess their level of technical capabilities stressing that only those who pass the skills test would be enlisted for the exercise.

He also disclosed that for the 2023 exercise starting with the Mock-UTME, the Board had deployed

some cutting-edge technology to preclude all forms of examination malpractice that could mar the conduct of the examination.

Prof. Oloyede stated that part of the measures to safeguard the sanctity of the examination was that no candidate would be allowed to login to the examination one hour into the stipulated examination start time as the system has been so designed to prevent such.

Also speaking was the Director, Information Technology Services (ITS), Mr. Fabian Okoro, who advised all the participants to work together as a team

"The success or failure of this examination hinges on the ability of all officers to work together as a team with everyone doing their best. Hence, there should be proper synergy between officers from the Headquarters and those in the field and any challenge experienced should be swiftly transmitted and treated."

He also charged all officers to be diligent and take their assignment

seriously as no excuse would be entertained.

On the issue of rescheduling of examination, Mr. Okoro stated that if for any reason a centre experiences any challenge that hinders it from commencing examination one hour into the start time, that session would be cancelled and the candidates who were affected would be rescheduled. He, however, urged participants to adhere strictly to this measure and that it should not be taken for granted.

Over 800 examination officials, Technical Officers, State Technical Advisors, Zonal Directors and State Coordinators, attended the training anchored by the Chief Technical Advisor, Prof. Bashir Galadanci, and the Board's IT Consultant, Mr. Damilola Bamiro.

## RESUMPTION OF DIRECT ENTRY EXERCISE

You will recall that the Board commenced the 2023 Direct Entry registration on Monday, 20<sup>th</sup> February, 2023, but had to immediately suspend it following the discovery of the plethora of devices and machinations to circumvent and compromise the standard of A'level qualifications required from DE candidates. Recall that recent joint operations of the Federal Ministry of Education and the Independent Corrupt Practices and Other Related Offences Commission (ICPC) on DE qualifications brought to light some of these unsavoury and nefarious activities. Bayero University, Kano (BUK) has also consistently brought to the fore the high rate of forgery of A'Level qualifications for DE.

2. For instance, it was discovered that, in previous years, some candidates used unacceptable and forged A' level certificates/qualifications to register for Direct Entry and eventually got admitted. For example out 148 candidates verified by BUK, only 6 were found to be genuine. By implication 142 of the results were forged. The Board, concerned stakeholders and institutions are working assiduously to detect such and the ones already found, are being dealt with according to the provisions of the law.

3. In order to further checkmate the anomaly and to also prevent recurrence of such irregularity, the Board has decided that the 2023 DE registrations will not only be restricted to JAMB PTCs but will also be done under strict supervision.

4. The Board has provided additional guidelines to all DE registration outlets (JAMB-owned centres), Officers of the Board and candidates on the 2023 Direct Entry registration exercise: -

## INNOVATIONS IN THE UTME AND A CALL FOR UNDERSTANDING

It will be recalled that the Board has gradually upgraded its operational processes since 2017, and as is usual with change, it came with some challenges including resistance. Given public support and understanding, the Board since 2018 has reached the cruising level. However, there is always room for improvement and the Board has decided to move to the next stage of its technological transformation.

The next stage requires all hands to be on deck as we take some crucial steps. The Board has instituted some measures which are to be deployed during the 2023 UTME exercise. Despite the fact that the innovations have been tested and certified, yet it is not unlikely that some hiccups might spring up when the new technology is deployed live and nationwide. We therefore solicit your support and understanding as we promptly address any unforeseen circumstances. Hardly can there be growth without audacity and courage.

One major feature of the new dispensation is that no examination would be allowed to take place after one hour of its scheduled start time because the Board has discovered that some of the problems reported at the centres are contrived to delay the commencement of a session in some centres with a view to securing undue advantage for the delayed candidates.

Consequently, any session that, for whatever reason(s), could not take-off within one hour of its schedule is automatically rescheduled. When such occurs, affected candidates are expected to file out of the examination hall into the waiting hall and await the new scheduled time and place which most

likely would be the same or following day. Candidates are expected not to disrupt subsequent sessions but to simply await information on reschedule. Parents have constituted major intrusion into the examination process. While we appeal for parents to keep-off the examination venues, we would not hesitate to sanction the candidates and (parents) whose parents obstruct the smooth running of the centre.

The rescheduling does not permit a candidate who was initially marked absent during the screening to be part of the rescheduled session since the questions meant for such absentees have been withdrawn and not available for the rescheduled session.

In addressing possible rescheduling, an extra session has been created for every centre on every examination day.

## CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS

- 🌐 All applications of admissions to **First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc.**, must be processed **ONLY** through the Joint Admissions and Matriculation Board (JAMB).
- 🌐 No Institution should advertise or sell “application forms” for admissions into the programmes. Institutions should advertise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- 🌐 Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
- 🌐 The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

### **ADVERTORIALS**

- 🌐 Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
- 🌐 It should be reiterated that no Institution should advertise or sell “application forms” for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
