





E INSTITUTIONS NEVER MATRICULATED YEARS - OLOYEDE



he Registrar of the Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede, has disclosed that some tertiary institutions in the country have failed to matriculate any student in the last five years, yet, they have been busy issuing certificates as well as graduating students. This was contained in the remarks of the Board's helmsman during a 2-Day refresher training for all its Admission Desk Officers organised by the Board to sensitise them on the significance of matriculation and matriculation list analysis.

The training, which was held at the Boardroom, National Headquarters, Bwari, Abuja, commenced on Wednesday, 22nd and ended on Thursday, 23rd November, 2023.

Declaring the training open, the JAMB Registrar, Prof. Is-hag Oloyede, stated that the training was important to ensure optimal performance. He expressed displeasure with the flagrant disregard for extant regulations by erring institutions.

"How can a school that never admitted any candidate continue to issue certificates and graduating students? A number of them got approval to operate no doubt, but they never bother following other



requisite regulations thereafter, they just continue running the institutions their own way," he said.

Continuing, he charged the participants to take the training seriously as they would be held responsible for not informing any erring institutions in writing that they did not admit and, as such, could not araduate any students.

In his words, "At the end of the year, you will inform the erring institutions that had not informed you of their matriculation in writing that, they had not admitted any student for the year and, as such, any candidates who attend such schools do it at their own risk, as they will not be mobilised for the one-year compulsory national youths service."

The Registrar stressed that the reports from the Desk Officers must be robust enough to give details of all institutions assigned to them, whether they have written to notify the Board of their matriculations or not, saying that analysis should not only be based on the records of the in stitutions that have communicated to JAMB.

He said, "Immediately you are through with your analysis and your Director approves it, you will send it to the Head of Public Affairs and Protocol, for a weekly publication of what is now to be known as 'Matriculation This Week', which will feature the details of the institutions

that are ready for matriculation within any particular week. Other details to be contained in their reports would include necessary details as: number of candidates pending approval, number of candidates pending approval, number of candidates admitted on CAPS, number of candidates admitted outside CAPS, et cetera."

Explaining further, Oloyede admonished the Desk Officers to constantly ensure free flow of communication between them and the institutions, particularly if there is any reason for which the schools could not be permitted to matriculate.

He said, for example, "If any institution has admitted candidates under the table, even if such school has sent its matriculation list as well as invited the Board for its matriculation within the stipulated period, all you will simply do is to write to them that they cannot matriculate because, most of their admitted students have been admitted outside CAPS against the regulation."

In the same vein, Prof. Oloyede charged the participants to take advantage of the training to acquire necessary skills, noting that the admission process has been 90% automated and, therefore, different from what they used to know. He disclosed that by the 2024/2025

Academic Year, the entire process would be fully automated.

In his remarks, the Director of Admissions Department, Mr. Muhammed Babaji Ahmed, made it known that the training came about as a result of the Registrar's reservations regarding some lapses in the conduct of some Desk Officers and, therefore, expressed the need for all Desk Officers to have requisite knowledge of the entire process.

"The Registrar felt that there was a need for all Desk Officers to have a good grasp of the essence of the matriculation list analysis for their respective institutions. Hitherto, we had to wait for the institutions to bring their matriculation list for analysis to be conducted then we write the institutions, highlighting the observations made but now, our system is automated, it runs the analysis and send the results to the institutions through the Central Admissions Processing System (CAPS)."

In his remarks, the Director of Information and Technology Services (ITS), Mr. Fabian Okoro, said, "ITS Department is ever ready to render necessary technical support to Admissions Department. Whatever support is needed from us will be given at all times. I implore you all to pay rapt attention to this training, if you need any assistance, we will be here to give it," he announced.

He stated that the team was in JAMB for to hold talks with the Board as a critical stakeholder and agency vested with the mandate of conducting m a t r i c u l a t i o n examinations and placing s u i t a b l y - q u a l i f i e d candidates into tertiary institutions.

Prof. Yahava said the university was committed to excellence, community development, research, adherence to due process and laid-down rules in line with global best practices. He pointed out that following the recognition of NSUED by the National Universities Commission (NUC) as a dulyestablished university coupled with the marching order of the Niger State Governor, Hon. Mohammed Umar Bago, to midwife the smooth take-off of the new university, it behoves on them to liaise with critical stakeholders such as JAMB toward the speedy commencement

of academic activities at the new institution.

Prof. Yahaya urged JAMB to, among others, list the university in the Board's brochure for the 2024/2025 Academic Session, put the university on the JAMB mailing platform, include her in Central Admission Processing System (CAPS), meetings, and other instruments and channels that could enhance communication, get intimated of policy directives, advisories and regulations, that could enhance the ease of conducting Admissions into the institution.

In his remarks, the Registrar thanked the delegation and their determination to follow laid-down rules without cutting corners. He said JAMB would do everything possible within the armbit of the law and its mandate to provide the university the needed support for a hitch-free take off.

He pointed out that the university had no Vice Chancellor yet and promised that when one is appointed, other necessary protocols would be deployed for proper interface.

The Registrar directed the Director of Admissions, Mr Muhammed Babaji Ahmed, to expediously put necessary mechanisms in motion to address some of the concerns raised by the University.

JAMB TO ADOPT UI ARCHIVAL MODEL

he Joint Admissions and Matriculation Board(JAMB) has expressed its desire to adopt the archival model of the University of Ibadan, Ibadan, for the preservation of its documents.

The Registrar, Prof. Is-haq Oloyede, dropped this hint during his recent visit to the Admissions Office of the University as part of his efforts to retrieve all Board's records domiciled at various institutions across the country.

or keen watchers and followers of his enthralling trajectory, the recent news that the Reaistrar/Chief Executive Officer of the Joint Admissions and Matriculation Board (JAMB), Prof. Is'haq Olanrewaju Oloyede, has become a hot cake for five African countries that desperately covet his services, is not surprising nor is it unexpected. His sterling performance at JAMB and at the University of Ilorin where he was Vice Chancellor between 2007 and 2012 easily recommends him for anybody or entity that truly desires the best in service delivery and organisational efficiency. He is a veritable goldfish that has no hiding place.

So, even as most Nigerians have almost given up on the country as a result of its deep immersion in the cesspit of corruption, there are still some of our countrymen whose activities in both public offices and their private lives continue to assure us that there is yet hope for Nigeria; hope of a sure dawn of a truly new era; hope of a country that will surely rub shoulders with some of the best nations in the world in terms of every conceivable index of growth and development.

There is, however, an abiding feeling that these "new Nigerians" are either born ahead of their times or have simply found themselves at a wrong place at a wrong time. The iconic Registrar of the Joint

Admissions and Matriculation Board (JAMB), Prof. Oloyede, is unarguably one of these exceptional Nigerians. They are those that have successfully defied the pervasive anomie. In their lonely but dianifying walk, they tow the path of forthrightness by choosing to do things differently from the maddening crowd around them. They often do this to the chagrin of the evil minded, who frenetically seek the sustenance of the rotten status quo and to the admiration of all lovers of good things, who genuinely desire a shift from the ugly trend of corruption, bad governance, graft, and general integrity deficit.

Prof. Falola's revelation was echoed by the ICPC's Director of Public Enlightenment and Education, Mr. Mohammed Ashiru Baba, during a sensitisation lecture on the "Role of Public/Civil Servants in the Implementation of the National Ethics and Integrity Policy", organised by the Anti-Corruption and Transparency Unit (ACTU) of JAMB in collaboration with ICPC on Tuesday, October 24, 2023 in Abuja. The ICPC Director said, "Prof. Oloyede is an icon of integrity and it is evident in the way the public and, indeed, the world views the Board. According to him, it is because of this high level of integrity that he is being sought after by five countries.

The transformational initiatives of Prof. Olovede at JAMB, and the single-minded commitment he invests in the office since he became Registrar in 2016 are legion and well-acknowledged. Top among these are: the Central Admissions Processing System (CAPS) for automation of admission process; the institution of Equal Opportunity Group for the conduct of the Universal Tertiary Matriculation Examination (UTME) for Blind Candidates; the expansion of the capacities of CBT centres for standardization purposes; the introduction of E-Ticketing (for Complaints; the introduction of the Integrated Brochure and Syllabus System (IBASS) for prompt delivery of admissions requirements; the use of Biometric Authentication to confirm validity of registration; the introduction of E-slip printing; the

ADVISORY ON PROCEDURE FOR EMERGENCY TRANSFER OF RETURNEE NIGERIAN STUDENTS INTO NIGERIAN UNIVERSITY SYSTEM IN TIME OF CRISIS

Please find below the procedure for processing transfer of Returnee Nigerian Students into Nigerian University system in time of crisis:

- A prospective student travelling abroad for undergraduate studies normally registers (document his/her travel) with the Federal Ministry of Education (FME) and obtains a Document ID. It is called "Notification to Study Abroad". In case of crises such registration becomes helpful.
- 2. Anyone who did not but has now become a returnee who is desirous of transfer into a Nigerian University must do a retroactive registration with the Federal Ministry of Education as follows:
 - Go to FME website www.education.gov.ng
 - Go to attestation of academic documents or http://.ess.education.gov.ng
 - Tick the certificates you want to evaluate (Tick your highest qualification in Nigeria to enable you pick a date)
 - Pick a date
 - Make payment via remittal RRR code
 - Print Appointment Slip
 - Go to FME Revenue Unit 2nd floor
 - Go to 8th floor Evaluation Accreditation Division with original copies of your credentials base on your Date of Appointment

 - b. NIN
 - c. Telephone Number
 - d. Active e-mail address
 - e. Current University
 - f. Country and City of Study
 - g. Programme
 - h. Year of Entry
 - i. Current Level of Study
- 5. Returnee Student selects intended University of Choice and Programme.
- 6. Returnee Student uploads scanned copy of the following documents:
 - a. Current University Admission letter;
 - b. Transcript/Student Semester Results;
 - c. Data page of International Passport; and
 - d. Sworn Affidavit (confirming the genuineness of information supplied and that insincere or false information shall lead to withdrawal from studies and/or of certificates (in the event of issuance). Prosecution may also follow.
- 7. Returnee Student clicks SUBMIT button, which now sends an email to intended University of Choice for Request for Application to Apply for Inter-University Transfer.

- 8. Notification page for successful request is loaded and presented on the screen by IBASS System.
- 9. Returnee Student gets a notification email and SMS for his/her application request sent to the intended University of Choice.
- 10. Student's University of Choice gets an IBASS mail of the Student's Request for Application to Apply for Inter-University Transfer
- 11. Intended University evaluates Student's credentials for possible consideration.
- 12. If the Intended University of Choice is satisfied/unsatisfied with the credentials presented by the Returnee Student, a notification is sent on <u>JAMB-IBASS-mail for</u> Qualified/Unqualified for consideration.
- 13. Qualified Returnee Student is directed via the email and SMS to approach any JAMB Office (in person) to complete the Inter-University Transfer Application.

Note that the process is tracked by JAMB, NUC and the candidate as follows:

- (a) Submitted
- (b) Being reviewed by the University
- (c) Successful/Unsuccessful
- 14. The intended University of Choice then follows the Advisory on <u>Inter-University</u> <u>Transfer of Students earlier sent to the institutions in 2019</u> (see attached).

ADVISORY ON PROCEDURE FOR APPLICATION FOR FOREIGN INTER-UNIVERSITY TRANSFER FOR STALITES (NOT FRESHERS)

Please find below the procedure for application for foreign inter-University transfer for Stalites:

- 1. The proposed institution sends a list of all candidates (not Freshers) for foreign Inter-University transfer to State JAMB Office with a letter of indemnity.
- 2. The proposed institution directs each candidate to State JAMB Office to create his/her profile on efacility platform (Candidate not on the list earlier sent by the proposed institution would be rejected by the State JAMB Office and cannot process any application on the system).
- 3. At State JAMB Office, the candidate fills the INTER-UNIVERSITY TRANSFER APPLICATION FORM FOR STALITES (NOT FRESHERS) FROM FOREIGN UNIVERSITIES online which would be available only at the State JAMB Office (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- 4. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her Current and Proposed Institutions for the signature of the Heads of the Institutions to indemnify JAMB on the accuracy of the information provided by the candidate. The form is to be endorsed first by the current institution.
- 5. The Proposed Institution sends the endorsed and indemnified form to the Coordinator of the State JAMB Office.
- 6. The form is uploaded from the State JAMB Office to the Headquarters and made available to the efacility platform for processing.
- 1. If the application is approved, the candidate is notified through his/her email.
- 2. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

ADVISORY ON PROCEDURE FOR APPLICATION OF FRESH FOREIGN CANDIDATES (EXTRA ORDINARY)

Please find below the procedure for application for fresh foreign candidates (this **supersedes** the advisory issued in November, 2019):

- The University sends a list of all fresh foreign candidates (for current admission) to State JAMB Office with
 a letter of indemnity signed by Head of the Institution. The letter of indemnity will read in part "I confirm
 that the listed candidate as forwarded to JAMB all met the admission requirements into my institution and
 hereby indemnify JAMB against any inaccuracy of the claims".
- The same list and letter as in (1) above should be sent to the JAMB Director of Admissions through the CAPS mail.
- The institution directs candidates to State JAMB Office to create their profiles individually on efacility platform (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- 4. At State JAMB Office, the candidate fills FRESH FOREIGN Application form online which would be available only at the State JAMB Office (Candidate not on the list earlier sent by the institution would be rejected by the State JAMB Office and cannot process any application on the system).
- Immediately the registration is completed at the JAMB Office, a Registration Number would be generated and assigned to the candidate alongside his/her transaction ID.
- Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her institution for the signature of the Head of the Institution to again indemnify JAMB on the accuracy of the information provided by the candidate.
- The <u>Head of the Institution authorises the candidate's application online</u>. At this point the details
 of the candidate is now made available on CAPS to enable the institution Propose and Recommend the
 candidate to JAMB for approval.
- The Head of the Institution would now send the endorsed indemnified <u>physical</u> form to the Coordinator of the State JAMB Office for immediate upload to CAPS for approval.
- NO UPLOAD OF INDEMNIFIED PHYSICAL FORM, NO APPROVAL ON CAPS BY JAMB
- If the application is approved, the candidate is notified through his/her email. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

introduction of management dashboard to monitor registration and admission exercise real time; the use of CCTV cameras in all CBT centres to monitor the examination and registration process real time; exemplary funds management; an ebullient staff welfare policy; as well as prudent and judicious use of JAMB's financial resources, an initiative that made it possible for the Board to remit more than N70 billion to the Federal Government's coffer despite not being a statutory revenue generating agency!

CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS

- All applications of admissions to First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc., must be processed ONLY through the Joint Admissions and Matriculation Board (JAMB).
- No Institution should advertise or sell "application forms" for admissions into the programmes. Institutions should advertise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
- The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

<u>ADVERTORIALS</u>

- Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
- It should be reiterated that no Institution should advertise or sell "application forms" for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
