

he 2022 Mock-UTME is now to hold on Saturday, 9th April 2022, and not Saturday, 16th April 2022, as earlier scheduled.

This change is owing to the realisation that 16th April 2022, earlier chosen, is Easter Saturday, a day celebrated by the Christian faithful as a Holy Saturday as it ends the Lenten Season and falls on the day before Easter Sunday.

It would be recalled that the Board was to begin its registration for the 2022/23 UTME/DE exercise on Saturday, 12th February 2022, but had to push the exercise to Saturday, 19th of February, 2022. The one-week extension had similarly affected the date for the Mock-UTME which also had to be rescheduled.

The Board, as a responsive organisation, would at all times, continue to act in the best interests of Nigerians. Therefore, all candidates who wish to register early so as to sit the Mock UTME are to kindly note the change of date.

he Management of the Joint Admissions and Matriculation Board (JAMB) has approved the constitution of a Management Committee to monitor the ongoing 2022 UTME registration exercise nationwide.

It should be recalled that the Board had recently given the green light to all its accredited Computer-Based Testing (CBT) centres to conduct registration for the National Open University of Nigeria (NOUN), Part-time, Sandwich and

Distance Learning (DL) candidates in addition to that of the Unified Tertiary Matriculation Examination (UTME) and Direct Entry (DE).

This added responsibility, which was suspended following reported cases of abuses by the centres, is not only to empower the centres but also to bring these services closer to candidates.

However, to ensure that the candidates and the public gets quality services and are not extorted, the Board would be monitoring the 2022 UTME/DE registration exercise, as well as assess how the centres are shouldering the added responsibility.

The exercise is part of the Board's resolve to ensure that its agents play according to the rules as anyone found wanting would be delisted.

Furthermore, the centres were also charged to refrain from charging above the regulated fees.

AF.FEEDNEWS.COM ONLINE NEWS SUNDAY,20TH FEBRUARY, 2022 - POLAC Commandant Assures of Strict Compliance to Regulatory Standards in Admission Process: The Commandant, Nigeria Police Academy, Assistant Inspector General of Police, Ahmad Abdurrahman, psc, min, has assured the Registrar Joint Admissions and Matriculation Board(JAMB), Prof. Is-haq Oloyede that the Nigeria Police Academy Wudil, Kano, would adhere strictly to the regulatory processes in ensuring that only candidates with the prerequisites approved score as approved by JAMB would be admitted into the Academy.

The Commandant made this known when he received the Zonal Director, Kano, Jigawa and Katsina, Mr Usman Sabo Zage, who was on a courtesy visit to his office on 16th February 2022. The Commandant was responding to a query raised by the Registrar, JAMB, through the Zonal Director, especially how some Nigerian Universities often disregard established processes in the admission of students into Nigerian Universities.

VANGUARD NEWSPAPER TUESDAY, 22ND FEBRUARY, 2022 – Conversion of Polytechnics to Varsities a Backward Step-NBTE Boss: The Executive Secretary of the National Board for Technical Education, NBTE, Prof. Idris Bugaje, has condemned the craze of converting polytechnics to universities, saying such a step is usually taken in ignorance of what the real trend in technical and vocational education is. He, therefore, described such an action as taking a step forward and taking many steps backward.

According to him, "While countries like China and Germany are giving priority to technical and vocational education and with China even converting universities to polytechnics because they know that is the future, we are now in the craze of turning our polytechnics to universities here. We are having a dearth of technicians while we are heading for a glut of university graduates. There should be a paradigm shift. What we need to be

able to compete well at the global level is to produce skilled manpower. We may not need a situation where you will be asking for five credits at General Certificate in Education level or somebody who scores 300 in the UTME." TRIBUNE NEWSPAPER THURSDAY, 24TH FEBRUARY, 2022 – <u>UBEC Set to Conduct Nationwide Learning Assessment:</u> The Universal Basic Education Commission (UBEC) says plans have been concluded to conduct internationally acceptable 2022 National Assessment of Learning Achievement in Basic Education (NALABE).

The Executive Secretary Universal Basic Education Commission UBEC, Dr Hamid Bobboyi disclosed this at a 5-day workshop for the development of test items for the 2022 National Assessment of Learning Achievement in Basic Education (NALABE) in Nigeria held in Kaduna State recently.

According to Dr Bobboyi, UBEC and UNICEF had put everything together for the conduct of an internationally acceptable National assessment. He said, "The workshop will also produce a development test blueprint and generate test items that will be trial tested for standardization."

LEADERSHIP NEWSPAPER WEDNESDAY, 23RD FEBRUARY, 2022 — NYSC DG Advocates Teaching of Military History in Conventional Varsities: The Director-General, National Youth Service Corps (NYSC), Major General Shuaibu Ibrahim has advocated the teaching of military history in conventional Universities in Nigeria.

He made the submission in a lecture titled: "Military History and the Relevance of Strategic Leadership: Challenges and Prospects", which was delivered to members of the National Defence College Course 30 in Abuja.

Ibrahim, who explained that military history had only gained wider recognition in the military institutions and Defence Academies, added that its non-availability as a branch of history in the conventional Universities might be partly due to its misconception as to the study of warfare and relics of war alone, and partly because of its newness in history.

-NECO Releases 2021 SSCE External Candidates Results: The National Examinations Councils (NECO) has released the 2021 Senior School Certificate Examination (SSCE) external candidates' results. The result, which was released 64 days after the last paper was written, had a 78 per cent pass rate. NECO's Registrar and Chief Executive Officer, Professor Dantani Ibrahim Wushishi, who announced the results at the council's headquarters in Minna, the Niger State capital, said four supervisors from Niger, Borno and Delta states were blacklisted for aiding and abetting during the examination. According to him, these supervisors would no longer be engaged in the conduct of NECO examinations. The NECO boss reiterated the council's zero tolerance for examination malpractice, saying appropriate standards and excellence were maintained from the planning stage to the release of results.

Wushishi said 49,916 candidates registered for the November – December external examination, adding that 36,116 out of 45,821 candidates made Credit and above in the English language, representing 78.04 per cent.

JAMB PAYS RETURN VISIT TO BWARI GENERAL HOSPITAL

he management of the Joint Admissions and Matriculation Board has paid a return visit to the Managing Director(MD) of Bwari General Hospital (BGH).

The visit was to reciprocate the earlier one the MD paid to the Registrar of the Board, Prof. Is-haq Oloyede, a few weeks ago at the Board's National Headquarters, Bwari, Abuja.

The MD, Dr Abdullahi Anate, during his visit to the Board, had informed the Registrar that he was on a tour of Government Agencies in Bwari to familiarise himself with the Chief Executives and build a solid relationship for the benefit of the people of the Area Council.

Prof. Is-haq Oloyede, while briefing the

MD on his visit to the hospital, said he came to fulfil his promise as well as to consolidate the existing relationship between the two bodies. He said the Board would continue to work with all Agencies in the Area Council to ensure that the residents benefit maximally from their location in the area.

He noted that the hospital is, in most cases, the first port of call for his staff for the provision of their healthcare needs as such it is necessary to build a mutual relationship with the facility.

He said the Board would not hesitate to support the hospital in any area that the law allows it to do. He also dropped the hint that the Board would not hesitate to leverage on its relationship with Project C.U.R.E., one of the world's leading charitable organisations and the largest distributor of life-saving medical equipment and supplies to hospitals and clinics around the world, to provide some needed equipment to the hospital.

He disclosed that the Board, in partnership with Project C.U.R.E., is in the process of securing medical equipment for eleven Teaching Hospitals and Federal Medical Centres across the six geographical zones of the country.

He further stated that the importance of healthcare facilities like the Bwari General Hospital in improving the quality of health of the people can never be overemphasized.

The MD, Dr Abdullahi Anate, commended the JAMB Registrar for the various

interventions in the health facility which were aimed at improving healthcare delivery in the host community.

He disclosed that on assumption of duty he was informed that the Board had, during the Covid-19 pandemic, donated ventilators and other medical equipment to mitigate the spread of the virus.

The MD showered encomiums on the Registrar, whom he described as "a teacher, brother and a highly-disciplined academic and administrator with zero tolerance for corruption."

He said he was elated at the return visit of the Registrar, stating that the existing cordial relationship established with the Board would be sustained.

While taking the Registrar on a guided tour of the hospital, the Medical Director, Dr Abdullahi Anate, stated that JAMB, like a big brother, had done much for the hospital, but added that like the proverbial Oliver Twist, he would still ask for more given his desire to improve on the facilities at the hospital, as the hospital had unlimited needs. He cited the desire of the hospital, under his leadership, to procure Dialysis machines for the management of renal cases and the proposed VIP Hall as two of the most critical needs of the hospital.

The MD conducted the Board's delegation round some of the hospital facilities such as the Eye Clinic, Radiology, NPI and the Sexual Assault Referral Centre, funded by the European Union and implemented by the British Council, among others.

andidates sitting the Unified Tertiary Matriculation ■ Examination (UTME) can now pick Computer Studies or Physical and Health Education as part of their four UTME subjects if they so desire or as dictated by their programme preferences. This is made possible following the

addition, by the Joint Admissions and Matriculation Board (JAMB), of the two subjects to the existing 23 UTME subjects to make them 25 beginning from the 2022 UTME exercise.

This addition is to enhance the career prospects of students transiting to tertiary institutions. At present, the 23 UTME subjects are : Agricultural Science, Arabic, Art, Biology, Chemistry, Christian Religious Studies, Commerce, Economics, French, Geography, Government, Hausa, History, Home Economics, Igbo, Islamic Studies, Literature-in-English, Mathematics, Music, Physics, Principles of Accounts, Use of English and Yoruba.



FEW FACTS ABOUT JAMB

- The Joint Admissions and Matriculation Board (JAMB) was established for the general control of the conduct of matriculation examinations for admissions into all universities, polytechnics, monotechnics, colleges of education and (recently added) Innovation Enterprise Institutes (IEIs).
- Section 5 (2)of the ACT establishing the Board provided as stated: For the avoidance of doubt, the Board shall be responsible for determining matriculation requirements and conducting examinations leading to undergraduate admissions and also for admissions to National Diploma and the Nigerian Certificate in Education courses, but shall not be responsible for examinations or any other selective process for postgraduate courses and any other courses offered by the tertiary institutions. In the implementation of this section, there is always a synergy with the National Universities Commission(NUC), the National Board for Technical Education(NBTE) and the National Commission for Colleges of Education(NCCE) with the endorsement of the National Council on Education(NCE).
- In exercising this power, the Board is always guided by admission guidelines approved by the Policy Meeting under the Chairmanship of the Hon. Minister of Education with all Heads of Tertiary Institutions and other stakeholders in attendance.
- Since the inception of the Interim Joint Matriculation Board Examination (IJMBE), JAMB appoints moderators for all its questions as well as the grading of candidates scores. It has always done this without failing to still accommodate 'HSC' within the current 6-3-3-4 system. The National Council on Education(NCE) guidelines for the Joint Universities Preliminary Examinations Board (JUPEB) also endorsed the practice for JUPEB.
- The Joint Admissions and Matriculation Board shall continue to operate within its laws.

.1 The general entry requirements for admission into the First Degree, National Diploma (ND), National Innovation Diploma (NID) and Nigeria Certificate in Education (NCE) programmes are five (5) O'level credit passes including English Language. In addition, credit in mathematics is required for science-based and social science programmes. Details are available in the e-Brochure which would be given to each eligible candidate at every JAMB-accredited-CBT -registration centre. .2 <u>DIRECT ENTRY (Note: DE registration closes on the same date with UTME Application)</u> Candidates with any of the following qualifications may be considered for admission through

- (a) A minimum of O'level credit pass in five (5) SSSC subjects at not more than two sittings with at least two prescribed subjects for each programme (course of study) at Principal or Advanced level.
- (b) Two passes [in prescribed subjects for each (programme) course of study] at the A'Level Examination awarded by IJMB, Cambridge, JUPEB or Institute of Baccalaureate wi 3 credit passes in the SSSC.

Following persistent requests from CBT centres, the Board has approved that some services hitherto, restricted to JAMB Offices, be extended to other approved CBT centres.

- 2. These services being extended to the CBT centres are registrations for:
 - (i) Part-time
 - (ii) NOUN
 - (iii) Sandwich
 - (iv) Distance Learning
- 3. The following steps are to be followed by each centre while attending to these category of candidates:
 - a. First create a Profile for the candidate (note that profile creation is free);
 - b. Login to the Candidate's Profile on e-Facility;
 - c. Expand the "Other Registrations" Tab and select the appropriate registration for the candidate;
 - d. Follow the prompts to make the payment of N3,500 application fees online using the candidate's ATM card (do not collect any candidate's card details, let the candidate be the one to enter his/her card details);
 - e. After payment, the centre will proceed to register the candidate on the Registration App platform and print out the Registration Slip.
 - f. For DE candidates of 2017 onwards, after registration, only the Registration Slip is to be given to them as the candidate's registration information goes straight to CAPS;
 - g. For candidates of year 2016 and before, after registration, the centre is expected to give them both the Registration Slip and an Indemnity Form;
 - h. The service charge for this type of registration is N700 only and payable directly to the centre.

ADVISORY TO INSTITUTIONS ON HOW TO HANDLE THE CONDONEMENT OF UNDISCLOSED ILLEGAL INSTITUTIONAL ADMISSIONS (CUIIA)

(ADMISSIONS CONDUCTED OUTSIDE CAPS 2017-2020)

The Board introduced the **Central Admissions Processing System (CAPS)** in 2017 as the transparent platform for all admissions. Regrettably, some of the institutions continued to admit some, indeed large number of candidates (undisclosed to JAMB), thereby jeopardizing the interest of such candidates admitted through under-the table deals.

Recent events made the candidates protest the disadvantages of such non-disclosure and lack of formal recognition of their degrees. Such Institutions are now being compelled by necessity to confess their past deeds of undisclosed admission.

This Advisory is to guide the affected institutions on how the candidates can be rescued:

- I. The institutions should first and foremost declare the number of candidates admitted outside CAPS by sending a formal letter of confession and disclosure (LCD) to the Registrar of JAMB.
- ii. The letter of confession and disclosure shou<mark>ld have</mark> the list of candidates attached. A copy of the letter and the list of candidates should be sent to JAMB state office where the institution is located. The list and total number of affected candidates for each year of admission should be clearly specified with the Programme (i.e Course of Study).
- iii. If the Board upon receiving the letter (and after due scrutiny and investigations) grants approval, the institution shall be contacted within 2 weeks of acknowledged receipt of the LCD.
- iv. The portal is then opened for the Institution to upload the list of candidates already submitted.
- v. The letter of approval from JAMB to the institution and the uploaded list shall contain the following:
 - the academic year for which the retroactive approval is granted;
 - total number of candidates, and
 - the period of grace (not exceeding 60 days) within which the affected candidates must complete the process of Condonement of Undisclosed Illegal Institutional Admission (CUIIA). Only the candidates declared by the institutions are to visit JAMB office and complete the appropriate form online after paying the prescribed fee (i.e) the application fee of N4,000 only is paid by those without JAMB Registration number for the year and N5,000 penalty paid by every candidate involved.
- vi. The records of the candidates shall then be made available on CAPS after they have completed the online process.
- vii. The Admission Officer of the Institution shall retroactively propose formally the candidates to the Head of Institution who in turn shall recommend the candidates within the specified time.
- viii. The JAMB Desk officer too, shall retroactively approve the candidates on CAPS within the original list submitted by the institution. After approval, the previously illegal students will be able to print their JAMB admission letters from e-facility on JAMB Portal.
- ix. It should be noted that the admission letter would henceforth carry the date of the retroactive approval and not backdated to protect the Board's integrity of the data it might have provided before the condonement. The admission letter would also be named "Retroactive Letter of Admission" to reflect the correct history of the admission.
- x. Please **NOTE** that only candidates on the list declared by the institutions shall be attended to at the JAMB office. The Board shall not extend the period of grace granted to each institution. Any candidate that does not complete the process within the allotted (maximum two months) grace period loses the remedial opportunity.
