he Joint Admissions and Matriculation Board(JAMB) has been urged to come up with stringent regulations to stop the proliferation of computer-Based Test centres nationwide.

This was the submission of the General Manager, Gateway ICT Limited, South-West Resource Centre, owned by Ogun State, Mrs Irene Ayorinde. The GM, who disclosed this in a telephone chat with JAMBulletin on Tuesday in Abuja, also scored the Board high in its service delivery. She described the Board as a pacesetter

In Service Delivery, Says It is a Pacesetter in the area of assessment and in the provision of

> quality service to the public with integrity. In addition, Mrs Ayorinde charged JAMB to stop further registration of new CBT centres so as to prevent their proliferation and making the business of delivering quality assessment an allcomers affair. According to her, such a measure would curb most of the infractions perpetrated by some operators who view the venture as a money-spinning one rather than service to the nation while making legitimate earnings.

> In her words, "I want to make a passionate appeal to the Board to stop registration of the new CBT centres, although there might be some merits in having an abundance of CBT centres to the extent that there might be CBT centres at every street corner. However, it should be noted that the quality of services rendered may be compromised while serious infractions might have fertile ground to thrive."

> Continuing, she said, "Businessmen and women are setting up CBT centres everywhere to make money and if they are not getting their projected profits, they may indulge in acts inimical to the conduct of the examination. Similarly, the Board has little control over what happens at these CBT centres. So, I would say that if the Board were to continue to partner with private CBT centres, then more stringent regulations would have to be put in place to regulate the operations of both new and existing CBT centres."

> Mrs Ayorinde, who had a blissful career as a banker that spanned over 23 years before taking up the headship of the state-owned ICT Resource Centre, pointed out that the operation of a CBT centre requires integrity, character and strict

She said the Gateway Centre had collaborated with JAMB for over a period of four years with an unblemished record in the conduct of the Board's Unified Tertiary Matriculation Examination (UTME).

According to her, the successes recorded by the centre may not be unconnected with quality service the centre has been rendering to the public, particularly UTME candidates in Ogun State during UTME Registration as well as the conduct of the examination proper and other ancillary services.

She noted that Gateway ICT Centre was committed to the mission and vision of the guiding the operations of the Institute making it always ahead of other centres in terms of service delivery.

"It's interesting partnering with JAMB. We are always on our toes because the Board, at times, pays us unscheduled visits, especially during the build-up to the UTME, so as to test our facilities such as the systems, Local Area Network, among others. As a responsive outfit, we are committed to excellence. We are always on our feet and it's so heartwarming to note that the Board has never found us wanting."

Continuing, she said, "We rejig our networking every year to comply with the Board's operational guidelines and, as such, we have never had any problems."

She disclosed that without doing anything untoward, a CBT centre could make enough profit to sustain its operations. This, according to her, was because the Board had created numerous business opportunities besides the registration and conduct of examination through which a centre could thrive. She stated that it was unfortunate to note that some centres wanted to make millions in one examination session at the detriment of the integrity of their centres. The good news, however, is that the Board has developed multiple layers of checks to nab such dubious centres.

Commenting further, she decried some centre owners' propensity to connive with professional examination syndicates to perpetrate examination malpractice.

She said, "Examination malpractice is a problem that could stultify the nation's developmental aspirations if not nipped in the bud. I've worked for 23 years before I retired meritoriously. As such, I would not involve myself in acts that would tarnish my image and integrity."

She urged the nation's tertiary institutions to set up their own CBT centres, adding that such a gesture would not only help in the realization of clamour for virtual learning but also provide a training platform for staff and students while providing a creditable platform for the UTME.

The General Manager told JAMBbulletin that the South-West Resource Centre is a training centre which runs a computer training programme, engages in networking, trains and retrains members of the public on computer appreciation, among others. The centre is also in collaboration with the Nigerian Association for the Blind to train its members on the latest assistive technology at no cost to members.

Mrs Ayorinde also declared that no amount of money would satisfy greedy centre owners whose sole motive is profit. She noted that the opportunities provided by JAMB if judiciously utilised would enable centre owners to make legitimate money that is reliable and consistent.

On another note, she disclosed the state government's commitment to pursue a robust ICT policy capable of making Ogun State a technology hub. She restated the determination of the present administration in the State to change the familiar narrative of underdevelopment by positioning the state for emerging opportunities in national and global technology spheres.

In the same vein, the GM rated the Board high in its efforts at repositioning the educational sector for more achievements. She added that the Board has cultivated an image that is far above what one would expect from a public institution in Nigeria as it has institutionalised a culture of transparency, accountability and integrity.

She equally commended the Board for the wonderful job by turning around the negative narratives about public institutions in the country and urged others to follow suit, especially with respect to ICT. She expressed her happiness for being a part of the Board's march to e-testing or CBT. She said etesting had been made to work in the country in spite of all the negativity for it had restored public confidence and hope in our public examinations.

## WHAT YOU NEED TO KNOW ABOUT COVID-19

the infectious disease caused by the most recently discovered CORONAVIRUS. This new virus and disease were unknown before the outbreak began in Wuhan, China, in December 2019.

SYMPTOMS: The most common symptoms of COVID-19 are fever. tiredness, and dry cough. Some people may have aches and pains, nasal congestion, runny nose, sore throat or diarrhoea. These symptoms are usually mild and begin gradually. Some people become infected but don't develop any symptoms and don't feel unwell. Most people (about 80%) recover from the disease without needing special treatment. Around 1 out of every 6 people who gets COVID-19 becomes seriously ill and develops difficulty breathing. Older people, and those with underlying medical problems like high blood pressure, heart problems or diabetes, are more likely to develop serious illness. People with fever, cough and difficulty breathing should seek medical attention.

Illness due to COVID-19 infection is generally mild, especially for children and young adults.

HOW IS IT SPREAD? The virus that causes COVID-19 is mainly transmitted through droplets generated when an infected person coughs, sneezes, or speaks. These droplets are too heavy to hang in the air. They quickly fall on floors or surfaces.

The disease can spread from person to person through small droplets from the nose or mouth which are spread when a person with COVID-19 coughs or exhales. These droplets land on objects and surfaces around the person. Other people then catch COVID-19 by touching these objects or surfaces, then touching their

HAT IS COVID-19? COVID-19 is eyes, nose or mouth. This is why it is important to stay more than 1 meter (3 feet) away from a person who is sick.

> You can be infected by breathing in the virus if you are within 1 metre of a person who has COVID-19, or by touching a contaminated surface and then touching your eyes, nose or mouth before washing vour hands.

#### **PROTECTION MEASURES FOR EVERYONE**

You can reduce your chances of being infected or spreading COVID-19 by taking some simple precautions:

- Regularly and thoroughly clean your hands with an alcoholbased hand rub or wash them with soap and water.
- Maintain at least 1 metre (3 feet) distance between yourself and anyone who is coughing or sneezing. If you are too close, you can breathe in the droplets, including the COVID-19 virus if the person coughing has the disease.
- Avoid touching eyes, nose and mouth. As your hands touch many surfaces and can pick up viruses. Once contaminated, hands can transfer the virus to your eyes, nose or mouth.
- Make sure you, and the people around you, follow good respiratory hygiene. This means covering your mouth and nose with your bent elbow or tissue when you cough or sneeze. Then dispose of the used tissue

immediately.

- Stay home if you feel unwell. If you have a fever, cough and difficulty breathing, seek medical attention and call in advance.
- Self-isolate by staying at home if you begin to feel unwell, even with mild symptoms such as headache, low grade fever (37.3 C or above) and slight runny nose, until you recover. Avoiding contact with others and visits to medical facilities will allow these facilities to operate more effectively and help protect you and others from possible COVID-19 and other viruses.
- Only wear a mask if you are ill • with COVID-19 symptoms (especially coughing) or looking after someone who may have COVID-19. Disposable face mask can only be used once. If you are not ill or looking after someone who is ill, then you are wasting a mask.

COVID-19 outbreaks can be contained and transmission stopped, as has been shown in China and some other countries. Unfortunately, new outbreaks can emerge rapidly.

If you think a surface may be infected, clean it with simple disinfectant to kill the virus and protect yourself and others. Clean your hands with an alcohol-based hand rub or wash them with soap and water. Avoid touching your eyes, mouth, or nose.
