

IARY OF GUIDELINES FOR REOPE

he guidelines cover four thematic areas:

i. Staying home and learning safely

ii. Before schools and learning facilities reopen

iii. Re-opening process

iv. Conditions for safety when learning facilities are reopened.

In each of these areas, actions and responsibilities are identified for various stakeholders such as policy, financing, safe operations, learning, training, reaching the most marginalised, building back better safety and hygiene, Infection Prevention and Control, (IPC).

1. STAYING HOME AND LEARNING SAFELY

Ensuring continuity of learning is vital.

Staying home and learning in a safe environment does not only address learners and educators' basic physical safety needs but also ensures that all learners and their families/ household members are safe.

This means that all education environments must be inclusive irrespective of location, access to the internet, and socio-economic background.

The following actions are recommended to safeguard the health, safety and security of learners accessing remote learning while ensuring that quality outcomes are obtainable:

Conduct online training that not only prepares teachers to teach in a way that safeguards the health, safety, and security of the learners but also enables them to facilitate

COVID-19:JAMB APPEALS TO CBT CENT -Urges them to take advantage of facility provided by JAMB

he Joint Admissions and Matriculation Board (JAMB) has appealed to Computer-Based Test centres to take the issue of COVID-19 seriously and obey all official protocols on the deadly virus.

The Registrar, Prof. Is-haq Oloyede, who spoke at a web-hosted meeting with CBT centre owners nationwide and some of the Board's stakeholders on Thursday. 16th July, 2020 pointed out that the meeting was called to "deliberate on new operational processes under the extant

COVID-19 dispensation."

He said, "It is to be noted that rendering quality service during this challenging period should be with an expression of our collective resolve as service providers to ensure that Nigerians seeking our services are adequately protected from the ravages of the COVID-19 contagion." Continuing, he said, "It is for this reason, Ladies and Gentlemen, that we have invited you to this special meeting today being held to acquaint you with our preparations for full reopening in

compliance with all COVID-19 protocols issued by relevant agencies of government."

Prof. Oloyede said, "Obey all rules to mitigate the spread of COVID-19.We don't want your centres to be a ground or platform for the spread of the virus. We urge you not to expose your own life, the life of your workers, candidates and clients coming to your centres."

The Registrar told the meeting attended by service providers like Sidmach, Airtel, MTN, Technical Advisors of the Board and other critical stakeholders that CBT centres

based on Information and Communications Technology (ICT).

- Revise to strengthen current remote learning programmes initially launched for stronger curriculum backing towards improving relevance and quality on a grade level to level basis.
- Provide learners access to online resources materials online learning platforms, radio or television programmes. Children and young people should stay at home and wash their hands regularly, maintain personal hygiene and adhere to the Nigerian Centre for Disease Control (NCDC), and World Health Organisation (WHO) COVID-19 guidelines.

2. BEFORE SCHOOLS AND LEARNING **FACILITIES REOPEN**

Federal and State Ministries of Education (SMoE) should decide when to reopen schools after due consultations with the Presidential Task Force on COVID-19 (PTF) and other critical stakeholders taking into consideration key requirements listed in the guidelines. In each state, a functional School Health Programme chaired by a state school health focus officer should be put in place while a school focal officer should be assigned in every school.

Schools must also put in place systems that meet the following:

- Safe distancing procedures;
- Alternative learning models for safe distancing. The guideline proffers diverse alternative learning models tailored to the specific learning context that assures equity in learning;
- Review existing policies, practices,

learning using 21st century pedagogy and risk mitigation strategies in the use of schools for other purposes, such as distance learning centres, temporary shelters, isolation, quarantine and treatment centres, markets, voting centres, and others;

- Develop and display at schools simple context-specific reference protocols on day-to-day actions to be operated in each school;
- Conduct risk assessment with a view to understanding the gaps in the system that can increase the risk of transmission and make recommendations for addressing the gaps; and
- Safety and hygiene in all stages and phases of the school reopening process which promote behaviours that reduce spread, such as school commutes (to and from school travelling), safe distancing, frequent hand washing, and the use of facemasks.

Other guiding frameworks include sensitisation, financing, learning, and monitoring procedures.

3. THE RE-OPENING PROCESS

Adjusting to the new school process requires much planning. A phased and gradual reopening of schools is advocated to minimise the risk of infections in schools and the resurgence of COVID-19 infections in the community. This involves measures including:

- Training of teachers and other personnel on safety and hygiene measures;
- Establishing a COVID-19 referral system;

Ensure availability of an ambulance and access to a testing/isolation/treatment centre including NCDC helpline and state government facilities.

- Ensuring the provision of adequate Water, Sanitation and Hygiene (WASH) facilities across the school premises;
- De-congesting classrooms, hostels, worship centres and other spaces;
- Encouraging use of open spaces for gathering and promoting outdoor activities; and
- 6. Establishing a staff/student committee for regular surveillance, monitoring and enforcement of COVID-19 guidelines.

4. ENSURING SAFETY WHEN SCHOOLS AND LEARNING FACILITIES REOPEN

Preventive actions are sustained through regular monitoring of compliance in schools after reopening to ensure the safety and health of all learners, teachers, administrators, and other education personnel.

Each school will comply with periodic Joint Risk Assessment for Safe Reopening of Schools and Learning Facilities Checklist under Annex A of the guidelines.

Implementing these guidelines will require the collaborative support of all stakeholders to reopen schools and learning facilities.

With the guidance offered in this document, schools should be able to put systems in place that allow them reopen in a way that protects learners, teachers, administrators, parents, and all stakeholders while providing high-quality education.

Others to be joined in the suit include Nigeria Institute of Architects (NIA), National Board for Technical Education (NBTE) and other relevant authorities in Nigeria. The aggrieved representatives of the HND graduates of architecture from polytechnics in Nigeria, namely, Sikirulai Adebayo Ibiyeye, Mr Okeagu Uche Kelechukwu, Mr Abdulrasaq Akanni Usman, Mr, Iwunze Paschal Ezechi, Mr Rabiu Adamu Abubakar Manga, Mr Omotoso Olubunmi David, in the letter claimed that ARCON has not addressed their alleged discrimination and nonregistration of their members despite withdrawing their previous suit.

PUNCH, MONDAY, JULY 13, 2020 — Ekiti Shuts School over Breach of COVID-19 Protocols: The Ekiti State Government has sealed off the premises of Victory College, llawe Ekiti, in the Ekiti South West Local Government Area for allegedly violating its directives on the closure of schools as a result of the COVID-19 pandemic. The government also said the proprietor of the private school, who is reportedly on the run, "will face the wrath of the law for the violation of COVID-19 protocols in the state whenever he is apprehended." It was revealed that the proprietor of the school was discovered to be organising extramural classes for pupils in total violation of the subsisting government directive on the closure of schools in the state.

DAILY INDEPENDENT, TUESDAY, JULY 14, 2020 -COVID-19: FG Unveils Resumption Guidelines For Schools: The Federal Government has released 52-page guidelines for the reopening of schools in the country as it continues to manage the COVID-19 pandemic. While it listed several conditions that must be met, the government, however, did not give a specific date as to when schools would reopen. Chairman of the Presidential Task Force, PTF, on COVID-19 and Secretary to the Government of the Federation, SGF, Mr. Boss Mustapha, said the Federal Government would not do anything to compromise the safety of students and pupils. According to him, Decisions on safe reopening should be contingent on meeting the requirements set out in these guidelines and on a case-by-case basis for each school and learning facility. To this end, a multi-sectoral approach comprising of education, health, environment and Emergency Operation Centres (EOCs) should use the Joint Assessment for Safe Reopening of Schools and Learning Facilities to determine when each school

THISDAY, THURSDAY, JULY 16, 2020 -WAEC May Postpone 2020 Senior Secondary Examinations: Minister of State for Education, Mr Chukwuemeka Nwajiuba, has disclosed that the West African Examinations Council (WAEC) may postpone the Senior Secondary School Certificate Examinations (SSCE) scheduled for August 4 to September 5, 2020. He, however, said schools would remain closed because the ministry believes that it is still not safe to reopen schools in view of the threat posed by COVID-19 pandemic. According to him, WAEC is currently negotiating with West African countries on the possibilities of shifting the hitherto scheduled West Africa School Certificate Examinations (WASCE) from August.

THISDAY, THURSDAY, JULY 16, 2020 -College of Education Workers Issue 21day Strike: The Colleges of Education Academic Staff Union (COEASU) has threatened to declare a nation-wide industrial action if nothing concrete is done by the federal government to address their grievances within 21 days. According to the Union, its grievances ranged from the nonimplementation of Needs Assessment, check-off dues, infractions and deprivations as a result of the implementation of the Integrated Personnel and. must implement safe distancing measures that would minimise the risk of contagion. The Registrar added, "You are enjoined to adhere strictly to all the National Centre for Disease Control (NCDC) and Presidential TaskForce on COVID-19 Protocols when relating with candidates and the public."

"Ensure that your premises are fumigated and disinfected before anybody could gain access to your centres. Your staff and candidates must wash their hands and sanitise them as well as wear face masks.

"The implication is that you must provide facilities for hand washing and sanitisers at the designated locations within your premises preferably at the entrance."

The Registrar urged the CBT centres to avail themselves of the various measures and facilities adopted which are in furtherance with the containment efforts various Protocols on COVID-19.

Some of these, according to the indefatigable Registrar, include Ticketing, the appointment booking platform which allows a candidate to secure an online appointment before visiting the centre. This is to reduce the number of candidates to be attended to and prevent

overcrowding as directed by Presidential Task Force (PTF), NCDC, etc.

To book an appointment, the candidate is expected to use the same SIM (phone numbers) he or she had used to register for the UTME/DE, dialling a USSD code *55019#. The candidate selects from the drop down MENU the state where he or she intends to access the required service and complete the process for a scheduled appointment.

He said timing would be strictly adhered to and candidate who is a minute late would be disqualified until a crest appointment is secured.

Another facility is the One-Time Password (OTP). The OTP temporarily replaced biometric verification by way of fingerprints all cleverly designed to curb the spread of the virus while enforcing social distancing.

The Registrar, while decrying group registration in spite of the consistent sensitisation on the negative implications, told the participants that the Board had devised SMART phone numbers for added value and to ease communication and entrenched COVID-19 protocols.

Earlier, the Director of Information

Technology Services Department (ITS), Mr. Fabian Okoro, dwelled on three critical issues arising from the 2020 UTME, such as the state of the centres, centres with high number of unverifiable candidates by Biometrics Verification Machine (BVM) and account details that are inconsistent with the centre name.

The Director ITS pointed out that failure and technical deficiencies were highly reduced but there were some centres totalling eight spread across the country that were delisted due to some hitches and infractions.

On the centre with high unverifiable candidates by BVM, the trend of which he described as worrisome, he said the Board is critically analysing it with a view to unraveling the mystery behind it.

He said the trend is more pronounced in the Northern CBT centres.

Mr Okoro lamented the incoherent filling of forms bordering on accounts details stating the inconsistencies were responsible for the delay in the payment of some centres.
